Dear President Kouchi, Speaker Saiki, and Members of the Legislature:

In accordance with HRS 37-52.5 which requires a report to the Legislature within thirty days of establishment of administratively established accounts, please find that an account was established for the deposit and expenditure of VW Trust funds for non-administrative expenses.

In November 2017, Governor David Ige designated the Department of Business, Economic Development, and Tourism (DBEDT) to serve as the State's Lead Agency for purposes of overseeing and administering the State's Trust allocation of \$8,125,000. Hawaii State Energy Office, an attached agency of DBEDT, is the primary agency charged with determining the expenditure of Hawaii's Trust fund allocation. Revenue will include monies from the VW Trust and interest from participating in the State's investment pool.
