1/ Data are based on the U.S. poverty thresholds and for population for whom poverty status is determined. Poverty status was determined for all people except institutionalized people, people in military group quarters and in college dormitories, and unrelated individuals under 15 years old. These groups also were excluded from the numerator and denominator when calculating poverty rates. They were considered neither "poor" nor "nonpoor". Poverty thresholds in Hawaii are about 15 percent higher; these statistics accordingly understate the prevalence of poverty in Hawaii.

2/ Census tract figures do not sum to the island and state totals.

3/ Maui County excluding Kalawao County contained 100% of this area's population, although Kalawao County did have 1 out of the 2,103 Korean race alone or in combination population in this area according to the 100-percent data (SF1). For Maui County excluding Kalawao County, the median household income was \$48,594; the median family income was \$58,661; the per capita income was \$16,936; the percent below poverty for families was 2.5; and the percent below poverty for persons was 11.2.
