
NOTE. **HOUSEHOLDS AND FAMILIES:** In 2005-2009 there were 820 households in Honokaa CDP. The average household size was 3.2 people.

Families made up 80 percent of the households in Honokaa CDP. This figure includes both married-couple families (55 percent) and other families (25 percent). Nonfamily households made up 20 percent of all households in Honokaa CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

**The Types of Households in Honokaa CDP, Hawaii in 2005-2009**






**NATIVITY AND LANGUAGE:** Twenty-five percent of the people living in Honokaa CDP in 2005-2009 were foreign born. Seventy-five percent was native, including 59 percent who were born in Hawaii.

Among people at least five years old living in Honokaa CDP in 2005-2009, 36 percent spoke a language other than English at home. Of those speaking a language other than English at home, 3 percent spoke Spanish and 97 percent spoke some other language; 49 percent reported that they did not speak English "very well."

**GEOGRAPHIC MOBILITY:** In 2005-2009, 95 percent of the people at least one year old living in Honokaa CDP were living in the same residence one year earlier; 1 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, less than 0.5 percent from another state, and 4 percent from abroad.

**Geographic Mobility of Residents of Honokaa CDP, Hawaii in 2005-2009**





**EDUCATION:** In 2005-2009, 87 percent of people 25 years and over had at least graduated from high school and 18 percent had a bachelor's degree or higher. Thirteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Honokaa CDP was 690 in 2005-2009. Nursery school and kindergarten enrollment was 62 and elementary or high school enrollment was 570 children. College or graduate school enrollment was 55.

**The Educational Attainment of People in Honokaa CDP, Hawaii in 2005-2009**






**DISABILITY:** In Honokaa CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

**INDUSTRIES:** In 2005-2009, for the employed population 16 years and older, the leading industries in Honokaa CDP were Arts, entertainment, and recreation, and accommodation and food services, 40 percent, and Educational services, and health care, and social assistance, 15 percent.


**OCCUPATIONS AND TYPE OF EMPLOYER:** Among the most common occupations were: Service occupations, 48 percent; Management, professional, and related occupations, 15 percent; Construction, extraction, maintenance, and repair occupations, 12 percent; Sales and office occupations, 12 percent; and Production, transportation, and material moving occupations, 9 percent. Seventy-five percent of the people employed were Private wage and salary workers; 14 percent was Federal, state, or local government workers; and 10 percent was Self-employed in own not incorporated business workers.

**TRAVEL TO WORK:** Sixty-six percent of Honokaa CDP workers drove to work alone in 2005-2009, 13 percent carpooled, 13 percent took public transportation, and 5 percent used other means. The remaining 3 percent worked at home. Among those who commuted to work, it took them on average 35.2 minutes to get to work.

**INCOME:** The median income of households in Honokaa CDP was \$58,036. Seventy-six percent of the households received earnings and 29 percent received retirement income other than Social Security. Forty percent of the households received Social Security. The average income from Social Security was \$14,699. These income sources are not mutually exclusive; that is, some households received income from more than one source.

**POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS:** In 2005-2009, 7 percent of people were in poverty. Nine percent of related children under 18 were below the poverty level, compared with 10 percent of people 65 years old and over. Five percent of all families and 16 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Honokaa CDP, Hawaii in 2005-2009




**Percent below poverty level**

POPULATION OF Honokaa CDP: In 2005-2009, Honokaa CDP had a total population of 2,600 - 1,300 (51 percent) females and 1,300 (49 percent) males. The median age was 39.5 years. Twenty-eight percent of the population was under 18 years and 15 percent was 65 years and older.

**The Age Distribution of People in Honokaa CDP, Hawaii in 2005-2009**



For people reporting one race alone, 23 percent was White; less than 0.5 percent was Black or African American; 1 percent was American Indian and Alaska Native; 47 percent was Asian; 5 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Twenty-four percent reported Two or more races. Ten percent of the people in Honokaa CDP was Hispanic. Nineteen percent of the people in Honokaa CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Honokaa CDP had a total of 920 housing units, 11 percent of which were vacant. Of the total housing units, 89 percent was in single-unit structures, 11 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Eleven percent of the housing units were built since 1990.

**The Types of Housing Units in Honokaa CDP, Hawaii in 2005-2009**






OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Honokaa CDP had 820 occupied housing units - 570 (70 percent) owner occupied and 250 (30 percent) renter occupied. Two percent of the households did not have telephone service and 7 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-four percent had two vehicles and another 29 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,024, nonmortgaged owners \$292, and renters \$796. Fifty-one percent of owners with mortgages, 3 percent of owners without mortgages, and 33 percent of renters in Honokaa CDP spent 30 percent or more of household income on housing.
