



NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 3,300 households in Kapaa CDP. The average household size was 2.9 people.

Families made up 73 percent of the households in Kapaa CDP. This figure includes both married-couple families (53 percent) and other families (20 percent). Nonfamily households made up 27 percent of all households in Kapaa CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


The Types of Households in Kapaa CDP, Hawaii in 2005-2009



NATIVITY AND LANGUAGE: Fourteen percent of the people living in Kapaa CDP in 2005-2009 were foreign born. Eighty-six percent was native, including 53 percent who were born in Hawaii.

Among people at least five years old living in Kapaa CDP in 2005-2009, 20 percent spoke a language other than English at home. Of those speaking a language other than English at home, 6 percent spoke Spanish and 94 percent spoke some other language; 53 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 83 percent of the people at least one year old living in Kapaa CDP were living in the same residence one year earlier; 13 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, 3 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Kapaa CDP, Hawaii in 2005-2009



EDUCATION: In 2005-2009, 87 percent of people 25 years and over had at least graduated from high school and 21 percent had a bachelor's degree or higher. Thirteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Kapaa CDP was 2,300 in 2005-2009. Nursery school and kindergarten enrollment was 190 and elementary or high school enrollment was 1,700 children. College or graduate school enrollment was 430.

The Educational Attainment of People in Kapaa CDP, Hawaii in 2005-2009






DISABILITY: In Kapaa CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Kapaa CDP were Arts, entertainment, and recreation, and accommodation and food services, 19 percent, and Construction, 14 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 28 percent; Sales and office occupations, 26 percent; Service occupations, 22 percent; Construction, extraction, maintenance, and repair occupations, 16 percent; and Production, transportation, and material moving occupations, 8 percent. Seventy-three percent of the people employed were Private wage and salary workers; 14 percent was Federal, state, or local government workers; and 13 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-five percent of Kapaa CDP workers drove to work alone in 2005-2009, 13 percent carpooled, less than 0.5 percent took public transportation, and 4 percent used other means. The remaining 8 percent worked at home. Among those who commuted to work, it took them on average 20.7 minutes to get to work.

INCOME: The median income of households in Kapaa CDP was \$59,399. Eighty percent of the households received earnings and 19 percent received retirement income other than Social Security. Thirty-two percent of the households received Social Security. The average income from Social Security was \$12,406. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 18 percent of people were in poverty. Twenty-eight percent of related children under 18 were below the poverty level, compared with 14 percent of people 65 years old and over. Thirteen percent of all families and 30 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Kapaa CDP, Hawaii in 2005-2009




Percent below poverty level

POPULATION OF Kapaa CDP: In 2005-2009, Kapaa CDP had a total population of 9,800 - 4,800 (49 percent) females and 5,000 (51 percent) males. The median age was 39.8 years. Twenty-three percent of the population was under 18 years and 14 percent was 65 years and older.

The Age Distribution of People in Kapaa CDP, Hawaii in 2005-2009



For people reporting one race alone, 35 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 28 percent was Asian; 8 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Twenty-eight percent reported Two or more races. Thirteen percent of the people in Kapaa CDP was Hispanic. Thirty-one percent of the people in Kapaa CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Kapaa CDP had a total of 4,000 housing units, 17 percent of which were vacant. Of the total housing units, 80 percent was in single-unit structures, 20 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Eighteen percent of the housing units were built since 1990.

The Types of Housing Units in Kapaa CDP, Hawaii in 2005-2009






OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Kapaa CDP had 3,300 occupied housing units - 2,100 (64 percent) owner occupied and 1,200 (36 percent) renter occupied. Seven percent of the households did not have telephone service and 6 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-five percent had two vehicles and another 37 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,892, nonmortgaged owners \$370, and renters \$1,336. Fifty percent of owners with mortgages, 11 percent of owners without mortgages, and 63 percent of renters in Kapaa CDP spent 30 percent or more of household income on housing.
