
NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 500 households in Nanawale Estates CDP. The average household size was 2.5 people.

Families made up 60 percent of the households in Nanawale Estates CDP. This figure includes both married-couple families (51 percent) and other families (8 percent). Nonfamily households made up 40 percent of all households in Nanawale Estates CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

The Types of Households in Nanawale Estates CDP, Hawaii in 2005-2009





NATIVITY AND LANGUAGE: Fourteen percent of the people living in Nanawale Estates CDP in 2005-2009 were foreign born. Eighty-six percent was native, including 45 percent who were born in Hawaii.

Among people at least five years old living in Nanawale Estates CDP in 2005-2009, 25 percent spoke a language other than English at home. Of those speaking a language other than English at home, 1 percent spoke Spanish and 99 percent spoke some other language; 40 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 78 percent of the people at least one year old living in Nanawale Estates CDP were living in the same residence one year earlier; 21 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, 1 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Nanawale Estates CDP, Hawaii in 2005-2009



EDUCATION: In 2005-2009, 90 percent of people 25 years and over had at least graduated from high school and 27 percent had a bachelor's degree or higher. Ten percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Nanawale Estates CDP was 310 in 2005-2009. Nursery school and kindergarten enrollment was 29 and elementary or high school enrollment was 240 children. College or graduate school enrollment was 38.

The Educational Attainment of People in Nanawale Estates CDP, Hawaii in 2005-2009






DISABILITY: In Nanawale Estates CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Nanawale Estates CDP were Arts, entertainment, and recreation, and accommodation and food services, 21 percent, and Educational services, and health care, and social assistance, 16 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 30 percent; Service occupations, 22 percent; Sales and office occupations, 20 percent; Construction, extraction, maintenance, and repair occupations, 13 percent; and Production, transportation, and material moving occupations, 9 percent. Fifty-three percent of the people employed were Private wage and salary workers; 15 percent was Federal, state, or local government workers; and 31 percent was Self-employed in own not incorporated business workers.


TRAVEL TO WORK: Fifty-three percent of Nanawale Estates CDP workers drove to work alone in 2005-2009, 22 percent carpoolled, 2 percent took public transportation, and 5 percent used other means. The remaining 19 percent worked at home. Among those who commuted to work, it took them on average 43 minutes to get to work.

INCOME: The median income of households in Nanawale Estates CDP was \$32,303. Seventy-five percent of the households received earnings and 18 percent received retirement income other than Social Security. Thirty-one percent of the households received Social Security. The average income from Social Security was \$11,377. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 22 percent of people were in poverty. Eleven percent of related children under 18 were below the poverty level, compared with 22 percent of people 65 years old and over. Twenty-two percent of all families and 35 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Nanawale Estates CDP, Hawaii in 2005-2009



POPULATION OF Nanawale Estates CDP: In 2005-2009, Nanawale Estates CDP had a total population of 1,200 - 570 (46 percent) females and 660 (54 percent) males. The median age was 38.6 years. Twenty-one percent of the population was under 18 years and 14 percent was 65 years and older.

The Age Distribution of People in Nanawale Estates CDP, Hawaii in 2005-2009



For people reporting one race alone, 34 percent was White; 1 percent was Black or African American; 1 percent was American Indian and Alaska Native; 17 percent was Asian; 20 percent was Native Hawaiian and Other Pacific Islander, and less than 0.5 percent was Some other race. Twenty-seven percent reported Two or more races. Eight percent of the people in Nanawale Estates CDP was Hispanic. Thirty-two percent of the people in Nanawale Estates CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Nanawale Estates CDP had a total of 550 housing units, 9 percent of which were vacant. Of the total housing units, 99 percent was in single-unit structures, 1 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Thirty-four percent of the housing units were built since 1990.

The Types of Housing Units in Nanawale Estates CDP, Hawaii in 2005-2009





OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Nanawale Estates CDP had 500 occupied housing units - 380 (76 percent) owner occupied and 120 (24 percent) renter occupied. Eight percent of the households did not have telephone service and 7 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-eight percent had two vehicles and another 14 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$938, nonmortgaged owners \$186, and renters \$967. Thirty-six percent of owners with mortgages, 9

percent of owners without mortgages, and 87 percent of renters in Nanawale Estates CDP spent 30 percent or more of household income on housing.
