
NOTE. HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 3,000 households in Napili-Honokowai CDP. The average household size was 2.4 people.

Families made up 55 percent of the households in Napili-Honokowai CDP. This figure includes both married-couple families (42 percent) and other families (13 percent). Nonfamily households made up 45 percent of all households in Napili-Honokowai CDP. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Nineteen percent of the people living in Napili-Honokowai CDP in 2005-2009 were foreign born. Eighty-one percent was native, including 29 percent who were born in Hawaii.

Among people at least five years old living in Napili-Honokowai CDP in 2005-2009, 25 percent spoke a language other than English at home. Of those speaking a language other than English at home, 37 percent spoke Spanish and 63 percent spoke some other language; 51 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 81 percent of the people at least one year old living in Napili-Honokowai CDP were living in the same residence one year earlier; 10 percent had moved during the past year from another residence in the same county, 2 percent from another county in the same state, 6 percent from another state, and 2 percent from abroad.

Geographic Mobility of Residents of Napili-Honokowai CDP, Hawaii in 2005-2009





EDUCATION: In 2005-2009, 90 percent of people 25 years and over had at least graduated from high school and 30 percent had a bachelor's degree or higher. Ten percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Napili-Honokowai CDP was 1,300 in 2005-2009. Nursery school and kindergarten enrollment was 87 and elementary or high school enrollment was 1000 children. College or graduate school enrollment was 240.

The Educational Attainment of People in Napili-Honokowai CDP, Hawaii in 2005-2009






DISABILITY: In Napili-Honokowai CDP, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Napili-Honokowai CDP were Arts, entertainment, and recreation, and accommodation and food services, 41 percent, and Professional, scientific, and management, and administrative and waste management services, 12 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 35 percent; Sales and office occupations, 24 percent; Management, professional, and related occupations, 21 percent; Construction, extraction, maintenance, and repair occupations, 13 percent; and Production, transportation, and material moving occupations, 7 percent. Eighty-four percent of the people employed were Private wage and salary workers; 5 percent was Federal, state, or local government workers; and 9 percent was Self-employed in own not incorporated business workers.


TRAVEL TO WORK: Seventy percent of Napili-Honokowai CDP workers drove to work alone in 2005-2009, 14 percent carpooled, 4 percent took public transportation, and 5 percent used other means. The remaining 7 percent worked at home. Among those who commuted to work, it took them on average 13.8 minutes to get to work.

INCOME: The median income of households in Napili-Honokowai CDP was \$64,666. Ninety-three percent of the households received earnings and 5 percent received retirement income other than Social Security. Thirteen percent of the households received Social Security. The average income from Social Security was \$13,639. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 4 percent of people were in poverty. One percent of related children under 18 were below the poverty level, compared with 4 percent of people 65 years old and over. One percent of all families and 5 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Napili-Honokowai CDP, Hawaii in 2005-2009






Percent below poverty level

POPULATION OF Napili-Honokowai CDP: In 2005-2009, Napili-Honokowai CDP had a total population of 7,400 - 3,300 (45 percent) females and 4,000 (55 percent) males. The median age was 38 years. Twenty-two percent of the population was under 18 years and 5 percent was 65 years and older.

The Age Distribution of People in Napili-Honokowai CDP, Hawaii in 2005-2009



For people reporting one race alone, 66 percent was White; 1 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 16 percent was Asian; 4 percent was Native Hawaiian and Other Pacific Islander, and 2 percent was Some other race. Eleven percent reported Two or more races. Fourteen percent of the people in Napili-Honokowai CDP was Hispanic. Fifty-seven percent of the people in Napili-Honokowai CDP was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Napili-Honokowai CDP had a total of 5,600 housing units, 46 percent of which were vacant. Of the total housing units, 24 percent was in single-unit structures, 76 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Twenty percent of the housing units were built since 1990.

The Types of Housing Units in Napili-Honokowai CDP, Hawaii in 2005-2009



OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Napili-Honokowai CDP had 3,000 occupied housing units - 1,400 (48 percent) owner occupied and 1,600 (52 percent) renter occupied. Five percent of the households did not have telephone service and 8 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-one percent had two vehicles and another 14 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$2,566, nonmortgaged owners \$596, and renters \$1,284. Forty-eight percent of owners with mortgages, 27 percent of owners without mortgages, and 49 percent of renters in Napili-Honokowai CDP spent 30 percent or more of household income on housing.
