
NOTE. Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties.

HOUSEHOLDS AND FAMILIES: In 2005-2009 there were 250 households in Puukapu Hawaiian Home Land, HI. The average household size was 3.2 people.

Families made up 84 percent of the households in Puukapu Hawaiian Home Land, HI. This figure includes both married-couple families (40 percent) and other families (44 percent). Nonfamily households made up 16 percent of all households in Puukapu Hawaiian Home Land, HI. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: One percent of the people living in Puukapu Hawaiian Home Land, HI in 2005-2009 were foreign born. Ninety-nine percent was native, including 85 percent who were born in their state of residence.

Among people at least five years old living in Puukapu Hawaiian Home Land, HI in 2005-2009, 21 percent spoke a language other than English at home. Of those speaking a language other than English at home, less than 0.5 percent spoke Spanish and 100 percent spoke some other language; 5 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2005-2009, 96 percent of the people at least one year old living in Puukapu Hawaiian Home Land, HI were living in the same residence one year earlier; 2 percent had moved during the past year from another residence in the same county, 2 percent from another county in the same state, less than 0.5 percent from another state, and 1 percent from abroad.



EDUCATION: In 2005-2009, 92 percent of people 25 years and over had at least graduated from high school and 17 percent had a bachelor's degree or higher. Eight percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Puukapu Hawaiian Home Land, HI was 160 in 2005-2009. Nursery school and kindergarten enrollment was 13 and elementary or high school enrollment was 150 children. College or graduate school enrollment was 4.

The Educational Attainment of People in Puukapu Hawaiian Home Land, HI in 2005-2009





DISABILITY: In Puukapu Hawaiian Home Land, HI, among people at least five years old in 2005-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2005-2009, for the employed population 16 years and older, the leading industries in Puukapu Hawaiian Home Land, HI were Arts, entertainment, and recreation, and accommodation and food services, 26 percent, and Professional, scientific, and management, and administrative and waste management services, 17 percent.


OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Service occupations, 33 percent; Management, professional, and related occupations, 25 percent; Sales and office occupations, 19 percent; Construction, extraction, maintenance, and repair occupations, 13 percent; and Production, transportation, and material moving occupations, 9 percent. Seventy-three percent of the people employed were Private wage and salary workers; 19 percent was Federal, state, or local government workers; and 8 percent was Self-employed in own not incorporated business workers.


TRAVEL TO WORK: Seventy-one percent of Puukapu Hawaiian Home Land, HI workers drove to work alone in 2005-2009, 19 percent carpooled, less than 0.5 percent took public transportation, and 2 percent used other means. The remaining 7 percent worked at home. Among those who commuted to work, it took them on average 24.8 minutes to get to work.

INCOME: The median income of households in Puukapu Hawaiian Home Land, HI was \$83,403. Eighty-seven percent of the households received earnings and 43 percent received retirement income other than Social Security. Forty-eight percent of the households received Social Security. The average income from Social Security was \$16,263. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2005-2009, 1 percent of people were in poverty. Less than 0.5 percent of related children under 18 were below the poverty level, compared with 5 percent of people 65 years old and over. One percent of all families and less than 0.5 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Puukapu Hawaiian Home Land, HI in 2005-2009






Percent below poverty level

POPULATION OF Puukapu Hawaiian Home Land, HI: In 2005-2009, Puukapu Hawaiian Home Land, HI had a total population of 790 - 380 (48 percent) females and 410 (52 percent) males. The median age was 40.9 years. Twenty-five percent of the population was under 18 years and 17 percent was 65 years and older.

The Age Distribution of People in Puukapu Hawaiian Home Land, HI in 2005-2009



For people reporting one race alone, 16 percent was White; less than 0.5 percent was Black or African American; less than 0.5 percent was American Indian and Alaska Native; 4 percent was Asian; 41 percent was Native Hawaiian and Other Pacific Islander, and 1 percent was Some other race. Thirty-nine percent reported Two or more races. Five percent of the people in Puukapu Hawaiian Home Land, HI was Hispanic. Sixteen percent of the people in Puukapu Hawaiian Home Land, HI was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2005-2009, Puukapu Hawaiian Home Land, HI had a total of 250 housing units, 1 percent of which were vacant. Of the total housing units, 93 percent was in single-unit structures, 7 percent was in multi-unit structures, and less than 0.5 percent was mobile homes. Sixteen percent of the housing units were built since 1990.

The Types of Housing Units in Puukapu Hawaiian Home Land, HI in 2005-2009





OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2005-2009, Puukapu Hawaiian Home Land, HI had 250 occupied housing units - 180 (73 percent) owner occupied and 67 (27 percent) renter occupied. Less than 0.5 percent of the households did not have telephone service and 1 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty percent had two vehicles and another 40 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,484,

nonmortgaged owners \$409, and renters \$628. Twenty percent of owners with mortgages, less than 0.5 percent of owners without mortgages, and 7 percent of renters in Puukapu Hawaiian Home Land, HI spent 30 percent or more of household income on housing.
