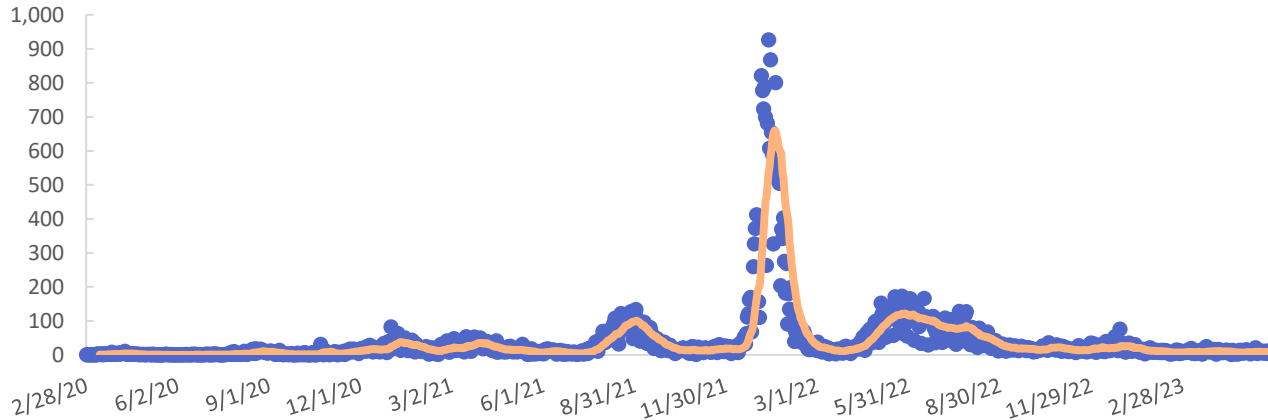

New known cases and 14-day moving average



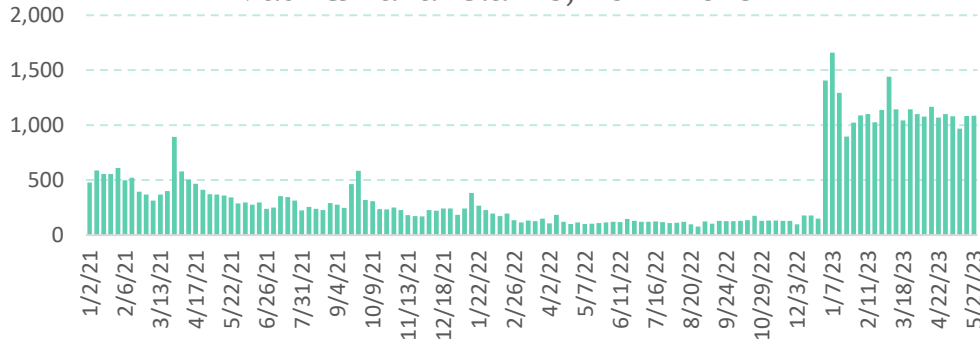

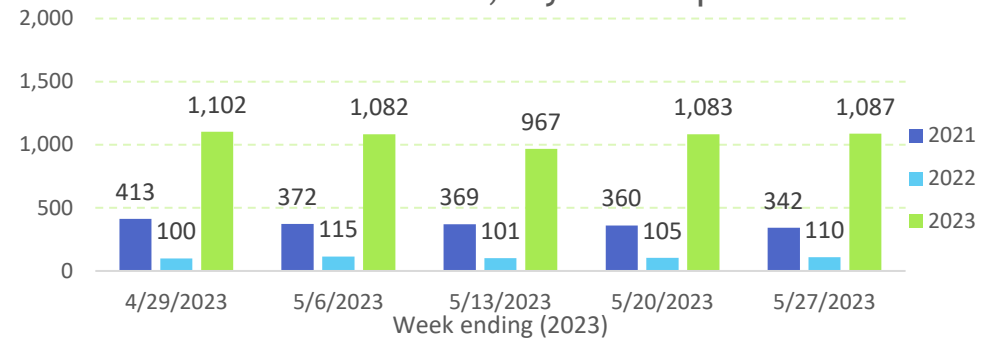

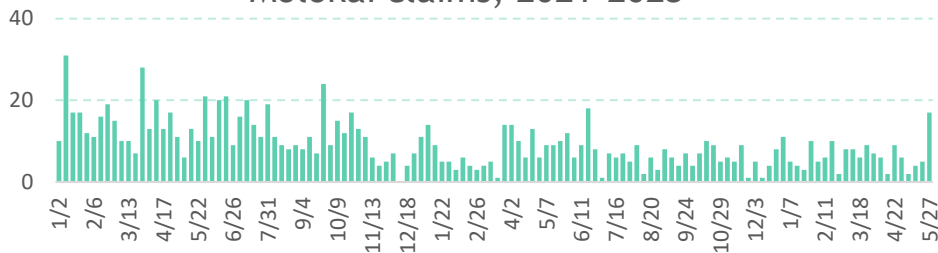
Maui & Lanai claims, 2021-2023



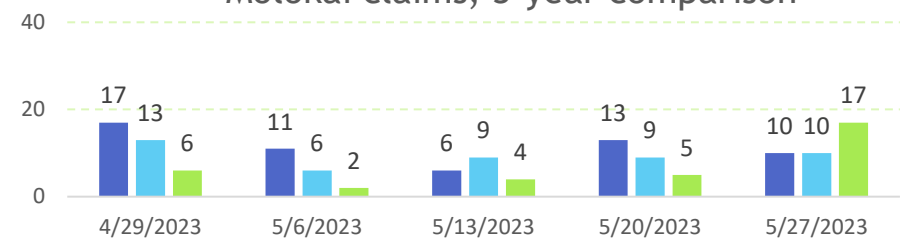
Maui & Lanai claims, 3-year comparison



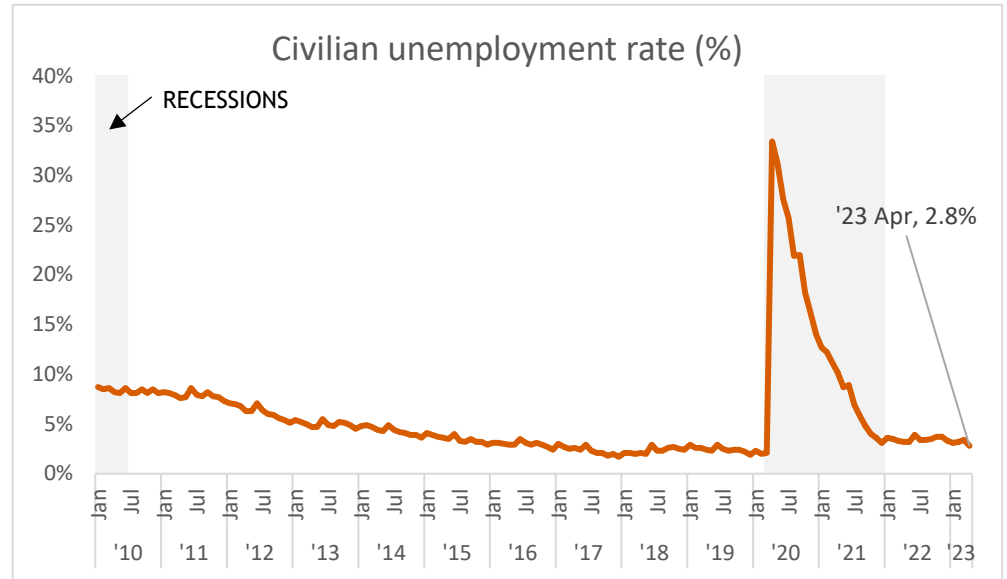
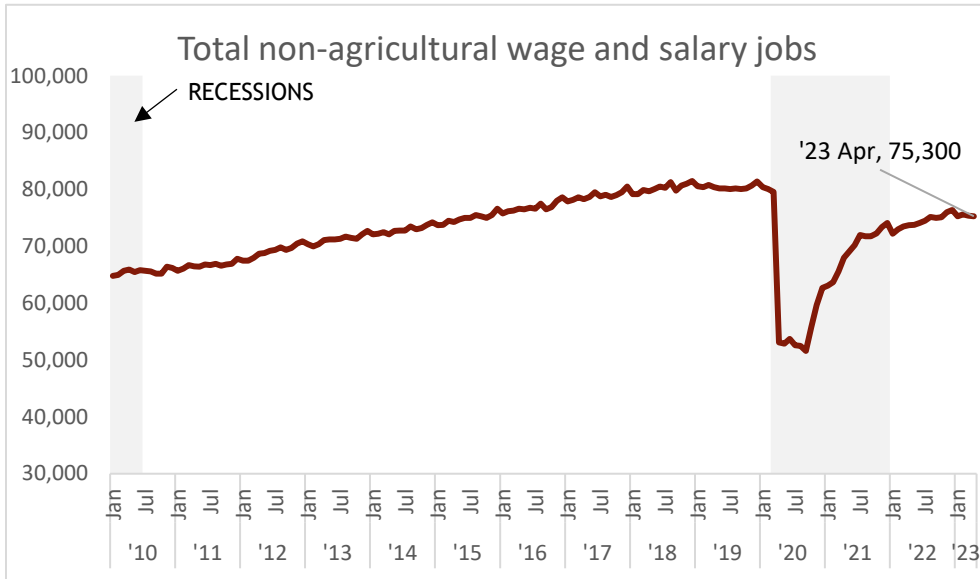
Molokai claims, 2021-2023

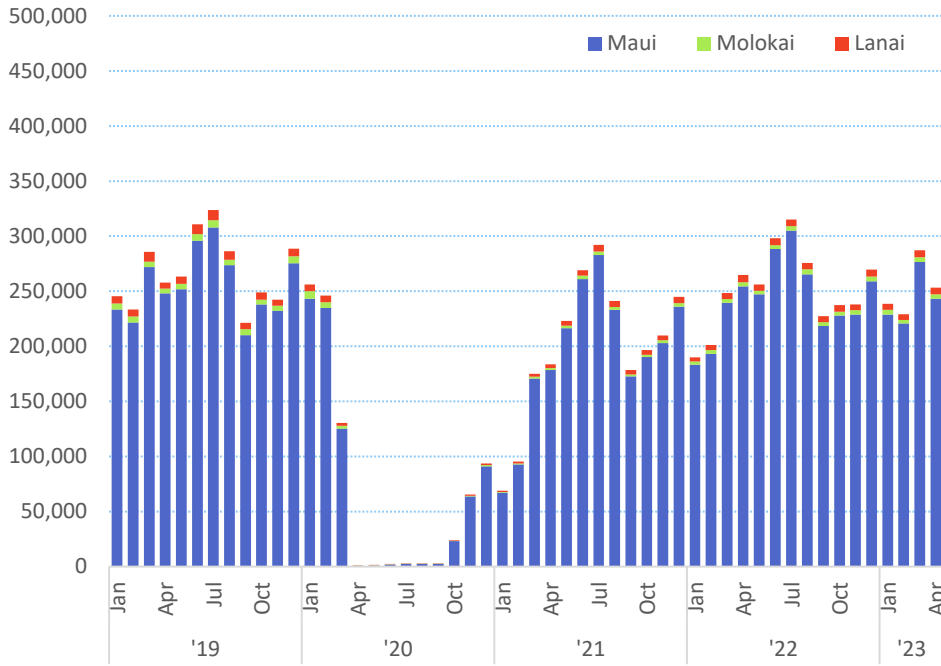

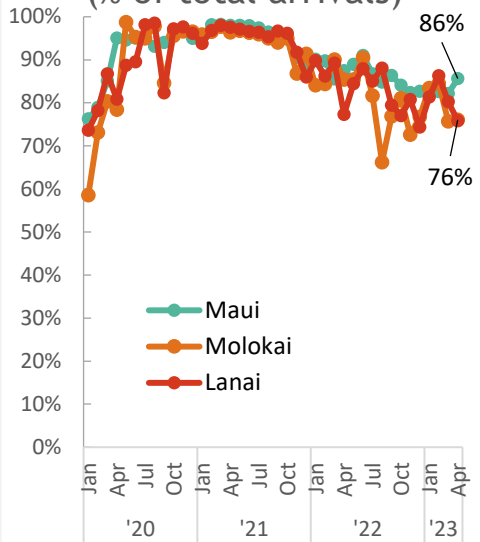

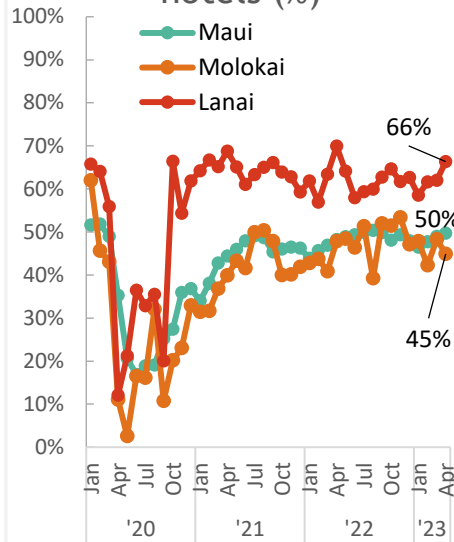

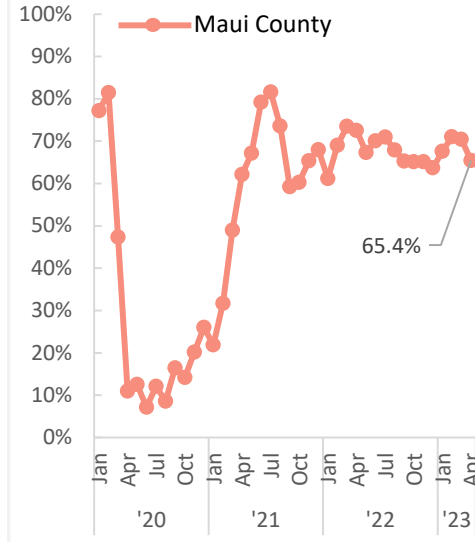
## US mainland visitors (% of total arrivals)



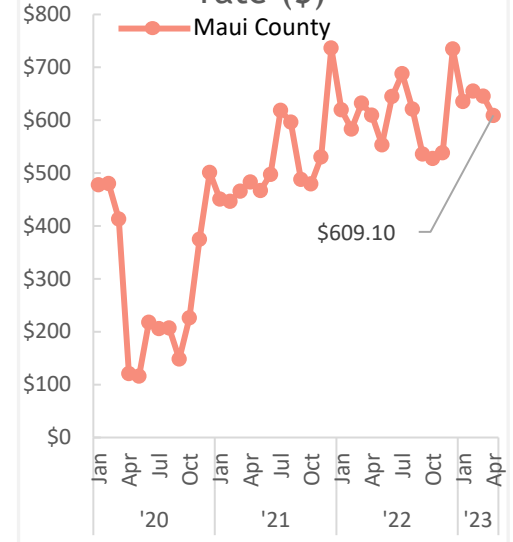
## Visitors staying in hotels (%)

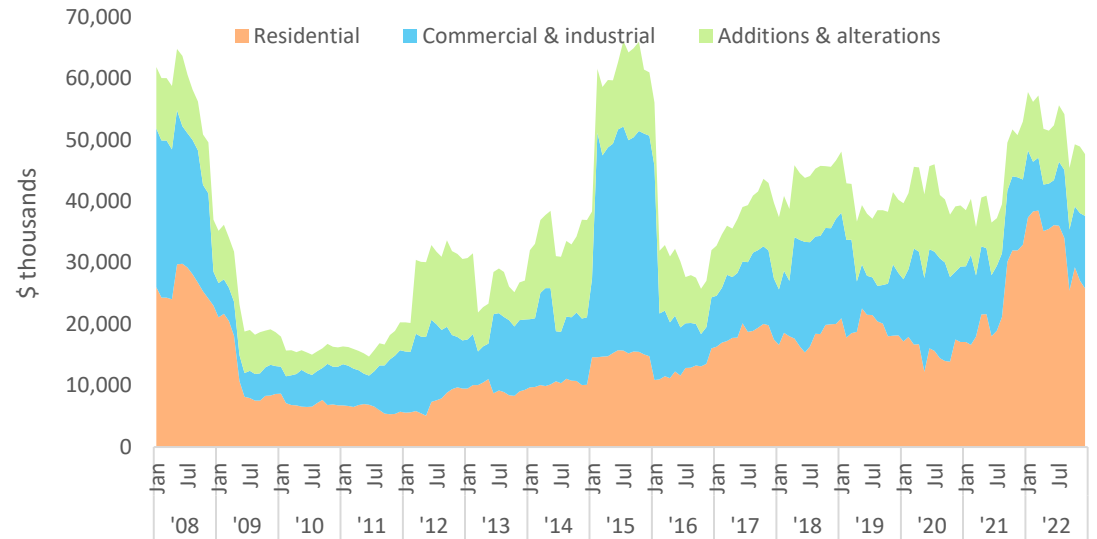

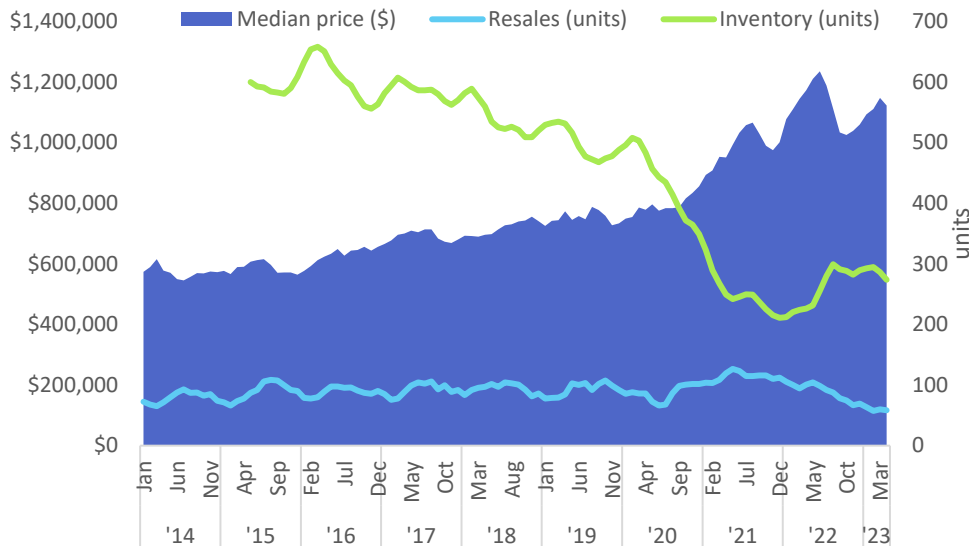
Private building permits (values in \$ thousands)\*

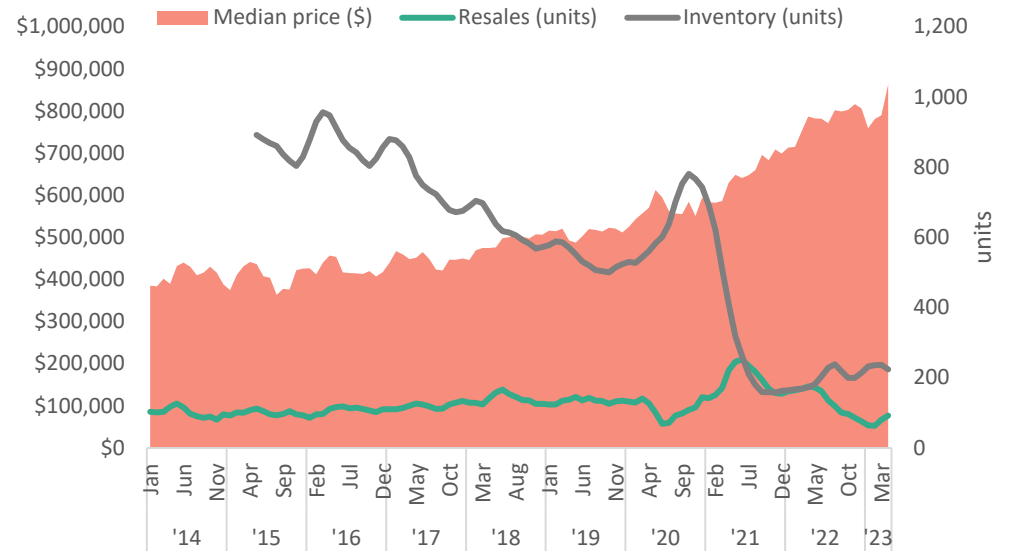
## Housing Market for Maui County

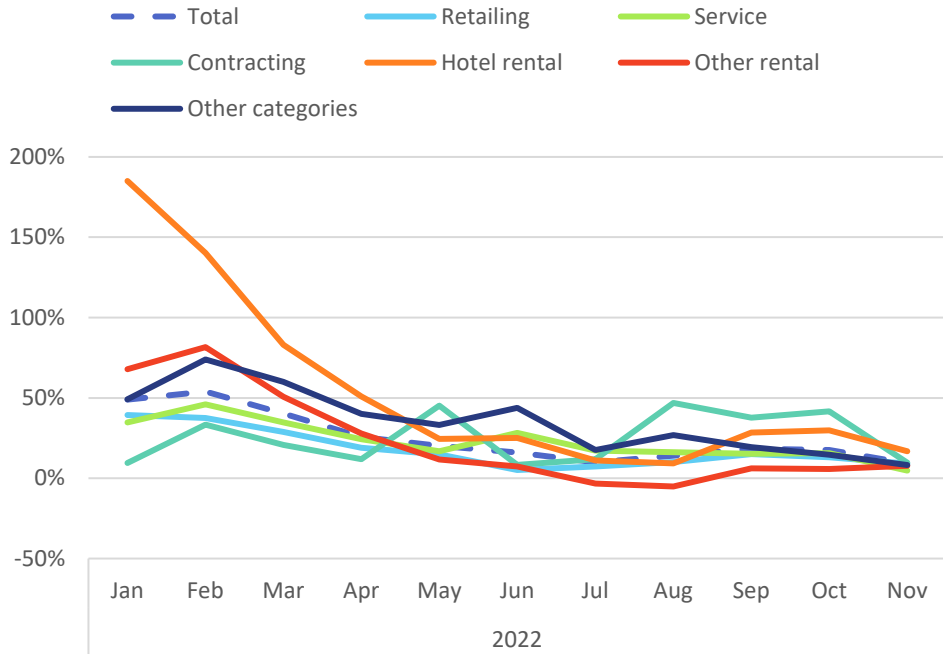
Condo/Apartment/Townhouse market\*
