Introduction

This report presents income and spending patterns by average household consumers in Honolulu. It also compares the household spending of Hawaii to five major U.S. cities and the national average using annual historical data averaged over a two-year period from 1986-1987 to 2004-2005. The U.S. cities are selected from the west coast (San Francisco and Seattle), east coast (New York), Southern area (Houston), and Central area (Chicago). In addition, the report presents income and expenditure comparisons of the major metropolitan areas in the United States. Data cited in this report are from the Consumer Expenditure Survey (Annual) conducted by the U.S. Bureau of Labor Statistics (BLS). Data can be found at BLS website at http://www.bls.gov/cex/.


The Consumer Expenditure Survey (CES) is comprised of a Diary Survey and an Interview. The first, conducted for two consecutive one-week periods, is designed to collect data on items frequently purchased but difficult to recall exact purchases such as food, through an expenditure diary. The personal interview, on the other hand, is conducted once per quarter, for five consecutive quarters, and is designed to collect data on major expenses such as property and vehicles.

Data were not produced for the period of 1995-96. Therefore, this particular period is not covered in this report. It should be noted that BLS revised its methodology for estimating consumer income in 2004. Income for consumer units that did not provide complete income sources is now imputed rather than excluded from the income calculation. Due to this change, income data and personal insurance and pensions, which are derived from income data, are not strictly comparable before and after 2004.

Summary of Findings


After adjusting for inflation, the report shows that expenditures for Honolulu consumers was

remarkably stable over the 20 year period. The average nominal expenditures for Honolulu consumers increased from \$28,239 in 1986-1987 to \$54,937 in 2004-2005, an increase of 94.5 percent between the periods, or 3.8 percent a year (Table 1&3). After adjusting for inflation, real average spending increased 12.3 percent between 1986-1987 and 2004-2005 periods, or 0.6 percent a year during the 20 year period (Table 6).



BLS reports fourteen major spending categories for Honolulu consumers (Table 1). In terms of growth, healthcare grew the fastest at an annual rate of 5.3 percent, followed by transportation at 4.8 percent a year, and housing at 4.0 percent a year (Table 3). In addition, Honolulu consumers have been allocating more money to spend on entertainment and healthcare, but reducing spending on apparel, reading, and miscellaneous items. Spending on education, personal care products, and tobacco products have been level for many years.

In terms of share of spending categories, Honolulu consumers spend the most on housing. Spending on housing has increased as a share of consumers' budgets over time and accounts for about one third of their total expenditures. Between 1986 and 1990, spending on housing accounted for 30.4 percent of total spending. That share increased to 34.6 percent in 1998-1999. Since 2000, spending on housing was averaged 32.7 percent of total spending. The lower percentage in housing spending during the first half of 2000s was mainly due to lower mortgage rates and refinancing that occurred during this period (Table 2).



Food and beverage consumption was the second largest category until 2001-2002, when spending on transportation exceed spending on food. The share of food in total expenditures declined from 18.2 percent of total expenditure in 1986-1987 to 15.6 percent in 2004-2005, while spending share on transportation increased from 15.0 percent in 1986-1987 to 18.1 percent in 2004-2005. Food and beverage consumption slipped to third place. Ranked the fourth is spending on personal insurance and pensions which accounted for 12.3 percent of total expenditures in 2004-2005. The top four categories accounted for approximately 75 percent of total expenditures every year (Table 2).

While Honolulu consumers allocate a smaller proportion of their budget to food, there has been a change in the share of expenditures on food at home (56 percent) and food away from home (44 percent) (Table 7). For food consumed at home, the proportion spent on meat, poultry, fish, and eggs has declined, and the proportion spent on other food at home has increased. Other food items include baby food, pet food, frozen foods, non-alcoholic beverages, etc. Proportions of food spending on cereals and bakery products, dairy products, and fruit and vegetables have varied little during the 20 year period.

Transportation spending was led by vehicle purchases, which accounted for 48.1 percent of the total transportation spending in 2004-2005, up from 29.8 percent in 1986-1987 (Table 8). The share of spending on gasoline and motor oil, other vehicle expenses, and public transportation all increased during the 1990-2000 period but declined during the 2000-2005 period.

In 2004-2005, annual income before tax for average Honolulu households was \$70,104. The bulk of this income, 78.4 percent, or \$54,937 was spent on consumer goods (Table 18). Based on data from the U.S. Bureau of Economic Analysis, Hawaii residents used 11.1 percent of their income to pay for income taxes and fees in 2004-2005. It can be estimated that saving rate in Honolulu was 10.5 percent in that year.

To compare Hawaii expenditures to other U.S. cities, per capita expenditures, or spending per person, is a better measure. As shown in Table 11, U.S. per capita expenditures were 8.5 percent lower than those of Honolulu in 2004-05. However, for most of the 20 year period in the study, per capita expenditures in the other selected cities (San Francisco, Seattle, New York, Chicago, and Houston) were higher than that of Honolulu. For example, per capita spending in Seattle and San Francisco was nearly 20 percent higher than in Honolulu in 2004-05; Chicago and New York were 7.7 percent and 6.1 percent higher than Honolulu, respectively.





Figure 4. Per Capita Income and Expenditures for Selected Cities and the United States (in Nominal Dollars): 2004-2005 40,000 90.0 78.4 80.0 ▲ 79.4 35,000 33,437 70.2 Income before Taxes 70.0 30,000 28.789 Average Annual Expenditures 27,777 26.048 Expenditures as % of Income 60.0 23.985 25,000 23,458 23,490 Nominal dollars 25,037 22,633 21 129 20.816 50.0 9,620 20,000 18,275 7,961 40.0 15,000 30.0 10.000 20.0 5.000 10.0 0 U.S. Houston San Seattle Chicago New York Honolulu Francisco Average

Overall, average per capita annual expenditures were the highest in Seattle and San Francisco among the selected cities, both at nearly \$23,500 per year. Honolulu per capita spending reached \$19,620 in 2004-05, more than doubled the amount spent in 1986-87.

One of the reasons that per capita expenditures in San Francisco, Seattle, Chicago, and New York were higher than that of Honolulu was that the per capita income in these cities was higher than that of Honolulu. In 2004-05, per capita income in San Francisco was 33.5 percent higher than Honolulu. New York's per capita income exceed that of Hawaii by 15 percent, Seattle by 10.9 percent, and Chicago by 4.0 percent. In terms of percentage of gross income spent, Seattle had the largest proportion at 84.6 percent, followed by Chicago at 81.1 percent. Honolulu's 78.4 percent ranked the 3rd among the cities selected for 2004-05. The U.S. average was 79.4 percent, higher than Honolulu (Table 10–12).

There were differences among the cities in expenditure patterns. The U.S. average per capita spending on housing was 6 percent below Honolulu in 2004-05. However, spending on housing

was lower in Hawaii than most of the selected cities. Among the six cities, spending on housing was the highest in San Francisco (42% higher than Honolulu), followed by New York (24% higher than Honolulu), Seattle (22% higher than Honolulu), and Chicago (17% higher than Honolulu), while residents in Houston spent the least (8% lower than Honolulu) on housing in 2004-05 (Table 13).




Transportation spending was the highest in Seattle (16% higher than Honolulu), followed by San Francisco (3% higher than Honolulu) (Table 14). Transportation spending in Chicago and New York were lower than Honolulu due to the widely used mass transportation systems in both cities.

Per capita spending on food and beverages were generally higher in San Francisco, Seattle, and New York than Honolulu. San Francisco and Seattle also had higher spending on personal insurance and pension than Honolulu (Table 15 and 16).

The percentage share of expenditures on food and beverages by Honolulu households was higher than any of the selected six cities and the U.S. average for most of the reported period (Table 17). The share of expenditures on housing in Houston was the smallest, ranging from 27.8% in


1994-1995 to 33% in 1986-1987. The share of expenditures on housing was generally above 35 percent in both San Francisco and New York. higher than other areas and Honolulu. On the other hand, the share of expenditures on transportation in Houston was much higher than other areas while New York has the lowest share. Percentage share of housing in Chicago and New York increased more sharply over the period.



Consumer expenditures in other metropolitan areas (MSA) grew in a similar manner as the expenditures in Honolulu over the past 20 years, except for expenditures for transportation. The share of spending on housing, personal insurance, health care, entertainment, and education all increased (Table 19&20) and the proportion spent on food and beverages, apparel & services, and on other items

decreased. The share spent on transportation in the other MSA's decreased, however, Honolulu consumers spent more of their total budget on transportation.

Average household income for the U.S. was \$56,583 (Table 18) in 2004-2005. Amongst the 24 metropolitan areas, San Francisco had the highest household income at \$86,935,



Washington D.C. was the second highest at \$86,526, and Honolulu ranked the sixth (\$70,104) in 2004-2005.

The higher ratio of expenditures to income indicates more income is allocated for spending. Portland households had the highest expenditures to income ratio among the selected metropolitan areas in 2004-2005 (Table 20) at 88.7 percent, which means 88.7 percent of their gross income was used for payment for goods and services. Residents in Baltimore spent the least out of their gross income at 61.9 percent during the same time period.
