# STATE OF THE ECONOMY

Hawaii's major economic indicators were mixed in the second quarter of 2024. Non-agricultural wage and salary jobs, State general fund tax revenues, and private building authorizations increased in the quarter compared to the second quarter of 2023. However, the labor force, employment, and visitor arrivals by air decreased.

In the second quarter of 2024, the total number of visitors arriving by air to Hawaii decreased 131,452 or 5.3 percent and the daily visitor census decreased 17,188 or 7.1 percent from the same quarter of 2023.

In the second quarter of 2024, the construction sector added 3,500 jobs or 9.2 percent compared with the same quarter of 2023, while the permit value for private construction increased \$301.6 million or 31.9 percent. Government contracts awarded in the second quarter of 2024, however, decreased \$346.5 million or 43.3 percent compared to the same quarter of 2023. According to the most recent data available, the contracting tax base increased 19.1 percent or \$510.2 million in the first quarter of 2024, compared to the same quarter of the previous year.

In the second quarter of 2024, State general fund tax revenues increased \$38.6 million or 1.4 percent over the same period of 2023. The state general excise tax revenue decreased \$19.9 million or 1.7 percent, the transient accommodations tax (TAT) decreased \$13.3 million or 6.2 percent, the net corporate income tax revenues increased \$116.4 million or 86.5 percent, and the net individual income tax revenues decreased \$75.0 million or 6.4 percent. In the first half of 2024, State general fund tax revenues increased \$64.3 million or 1.3 percent compared to same period of the previous year.

Labor market conditions were mixed. In the second quarter of 2024, the civilian labor force decreased 8,650 or 1.3 percent from the same quarter of 2023. Civilian employment decreased 8,000 or 1.2 percent. The unemployment rate (not seasonally adjusted) was 2.8 percent in the second quarter of 2024, a decrease of 0.1 percentage point from the second quarter of 2023. Nonagricultural wage and salary jobs increased by 2,200 jobs or 0.3 percent from the second quarter of 2023.

The job increase in the second quarter of 2024 was due to job increases in the government sector. The number of non-agricultural jobs in the private sector remained the same compared to the second quarter of 2023. The number of jobs decreased the most in Transportation, Warehousing and Utilities, which lost 1,600 jobs or 4.6 percent; Information, which lost 1,500 jobs or 18.5 percent; Retail Trade, which lost

1,000 jobs or 1.5 percent; and Financial Activities, which lost 1,000 jobs or 3.6 percent. The number of jobs increased the most in Construction, which gained 3,500 jobs or 9.2 percent; followed by Health Care and Social Assistance, which gained 2,300 jobs or 3.1 percent. The Government sector added 2,200 jobs or 1.8 percent in the second quarter of 2024 compared to the same quarter of 2023. The Federal Government added 700 jobs or 2.0 percent, the State Government added 1,300 jobs or 1.8 percent, and the Local Government added 200 jobs or 1.1 percent, compared to the second quarter of 2023.

In the first quarter of 2024, total annualized nominal GDP increased \$5,210 million or 4.9 percent, from the same quarter of 2023. In 2023, total annualized nominal GDP increased \$6,940 million or 6.9 percent from the previous year. In the first quarter of 2024, total annualized real GDP (in chained 2017 dollars) increased \$1,546 million or 1.8 percent from the same quarter of 2023. In 2023, total annualized real GDP increased \$1,676 million or 2.0 percent from the previous year.

In the first quarter of 2024, total non-farm private sector annualized earnings increased \$2,734.5 million or 6.0 percent from the same quarter of 2023. In dollar terms, the largest increase occurred in Health Care and Social Assistance; followed by Transportation and Warehousing, and Construction. During the first quarter of 2024, total government earnings increased \$1,694.5 million or 9.7 percent from the same quarter of 2023. Earnings from the federal government increased \$933.9 million. Earnings from the state and local governments increased \$760.6 million in the quarter.

In the first half of 2024, Honolulu's Consumer Price Index for Urban Consumers (CPI-U) increased 4.7 percent from the same period in 2023. This is 1.5 percentage points above the 3.2 percent increase for the U.S. average CPI-U. It is also higher than the 3.4 percent increase in the Honolulu CPI-U for the first half of 2023 compared to the same period of the previous year. In the first half of 2024, the Honolulu CPI-U increased the most in Housing (8.0 percent), followed by Food and Beverages (4.1 percent), Other Goods and Services (3.9 percent), and Recreation (3.4 percent). The Honolulu CPI-U decreased in Apparel (2.6 percent), Education and Communication (1.1 percent), and Transportation (0.3 percent) compared to the first half of 2023.

# **OUTLOOK FOR THE ECONOMY**

Hawaii's economy continues to recover from the impacts of the COVID-19 pandemic and the August 2023 Maui wildfires. As of the first quarter of 2024, the latest quarter Federal economic data are available, Hawaii's economy recovered 98 percent from the prepandemic fourth quarter of 2019. While the non-tourism sector has fully recovered, the tourism sector (retail trade, transportation, recreation, food services and accommodation) has recovered to only 90 percent.

Total visitor arrivals to the state during the first seven months of 2024 fell by 3.3 percent compared to the same period in 2023. Visitor expenditures, measured in current dollars, decreased 3.9 percent year-to-date through July 2024.

The construction industry is booming. Average construction payroll job count reached 41,200 during the first seven months of 2024, a record level for the industry. The value of private building permits increased 19.1 percent during the first seven months of 2024. The value of permits for additions and alterations increased by 29.4 percent and the value of residential permits increased by 24.2 percent, while the permit value for industrial and commercial projects decreased by 31 percent. However, the value of industrial and commercial permits accounted for only 7.9 percent of the total private permit value.

Based on the most recent data from the U.S. Bureau of Economic Analysis, Hawaii's real gross domestic product (GDP) grew 1.8 percent in the first quarter of 2024 compared to the first quarter of 2023. Hawaii's personal income grew by 5.5 percent in the first quarter of 2024 compared to the first quarter of 2023.

Hawaii's labor force (not seasonally adjusted) for the first seven months of 2024 increased 0.4 percent compared to the same period in 2023. Hawaii's unemployment rate (not seasonally adjusted) averaged 2.9 percent during the first seven months of 2024, ranking seventh lowest among the states in the nation.

State general excise tax collections decreased by 0.1 percent during the first seven months of calendar year 2024 compared to the same period a year ago.

Hawaii's consumer inflation, measured by the Honolulu Consumer Price Index for All Urban Consumers, was at 4.5 percent in July 2024, 2.4 percentage points higher than Hawaii's inflation rate of in July 2023 and 1.6 percentage points higher than the national average.

At the national level, the most recent (August 2024) Blue Chip Economic Indicators report, the consensus of 50 economic forecasting organizations, projected the U.S. economy to grow at 2.5 percent in 2024, and 1.8 percent in 2025. DBEDT estimates that the Hawaii's real GDP will increase by 1.3 percent in 2024, 2.0 percent in 2025, 2.1 percent in 2026, and 2.2 percent in 2027.

Visitor arrivals are projected to decrease by 1.0 percent in 2024 and will improve starting in 2025 as the Japanese visitor market recovery accelerates. Full recovery in arrivals will not happen until 2027 when 10.3 million visitors will come to the state. Visitor spending is projected to be \$20.7 billion in 2024 and is expected to increase to \$23.9 billion by 2027.

Non-agriculture payroll job growth is expected to increase by 0.8 percent in 2024 and then to 1.3 percent in 2025, 1.2 percent in 2026, and 1.0 percent in 2027. A full recovery of non-agriculture payroll jobs is expected to occur in 2027 when the total will reach 659,700 jobs.

The state unemployment rate is expected to be 2.8 percent in 2024 and will improve to 2.7 percent in 2025 and 2.5 percent in both 2026 and 2027.

Personal income is expected to grow at rates of about 4 percent in the next few years, similar to projections in the previous quarter.

As measured by the Honolulu Consumer Price Index for Urban Consumers, inflation is expected to be at 4.2 percent in 2024, which is higher than the projected U.S. consumer inflation rate of 3.0 percent for the same year. Hawaii consumer inflation is expected to decrease to 2.4 percent by 2027.

Hawaii's population is expected to decrease by 0.1 percent in 2024, remain flat in 2025, and then increase by 0.2 percent in 2026 and by 0.2 percent in 2027.

# COUNTY ECONOMIC CONDITIONS

Maui County continued to experience the impacts of the August 8, 2023 wildfires through the second quarter of 2024. Maui County visitor arrivals and jobs decreased in the quarter and Maui County's unemployment rate remained higher in the second quarter of 2024 compared to the same quarter in 2023. Honolulu saw an increase in visitor arrivals, gained jobs, and saw a lower unemployment rate. Hawaii County gained jobs and saw a lower unemployment rate but also saw a decrease in visitor arrivals. Kauai saw lower unemployment, no change in jobs, and a decrease in visitor arrivals.

In the second quarter of 2024, the unemployment rate decreased 0.3 of a percentage point from 2.8 percent to 2.5 percent in Honolulu; decreased 0.2 of a percentage point from 2.7 percent to 2.5 percent in Kauai; and decreased 0.3 of a percentage point from 3.2 percent to 2.9 percent in Hawaii County. Maui County's unemployment rate increased 1.4 percentage points from 2.7 percent to 4.1 percent.

In the second quarter of 2024, Honolulu added 7,500 or 1.6 percent non-agricultural wage and salary jobs compared to the same quarter of 2023. The number of jobs increased the most in Construction, which added 3,600 jobs or 13.2 percent, followed by Health Care and Social Assistance, which added 2,100 jobs or 3.8 percent; Food Services & Drinking Places, which added 1,100 jobs or 2.4 percent; and Accommodation, which added 1,000 jobs or 5.8 percent. Information lost 1,300 jobs or 19.7 percent and Transportation, Warehousing and Utilities lost 900 jobs or 3.5 percent in the quarter. The Government sector added 1,500 jobs or 1.6 percent.

In the second quarter of 2024, Hawaii County added 800 or 1.1 percent of non-agricultural wage and salary jobs over the same quarter of 2023. The number of jobs increased the most in Accommodation, which added 400 jobs or 6.6 percent; followed by Health Care and Social Assistance, which added 200 jobs or 2.7 percent; and Transportation, Warehousing, and Utilities, which added 200 jobs or 6.3 percent in the quarter.

The Government sector added 100 jobs or 0.7 percent.

Maui County lost 5,600 or 7.3 percent of non-agricultural wage and salary jobs in the second quarter of 2024 over the same quarter of 2023. The decrease in the number of jobs was largest in Food Services and Drinking Places, which lost 1,900 jobs or 19.2 percent; followed by Professional and Business Services, which lost 1,100 jobs or 15.7 percent; Accommodation, which lost 800 jobs or 6.9 percent; and Retail Trade, which lost 800 jobs or 8.7 percent. Construction added 300 jobs or 6.3 percent in the quarter. The Government sector added 600 jobs or 6.8 percent.

Kauai saw no change in non-agricultural wage and salary jobs in the second quarter of 2024 compared to the same quarter of 2023. Professional and Business Services, Accommodation, Food Services and Drinking Places, and Other Services each added 100 jobs while Construction, Manufacturing, Retail Trade, Financial Activities, and Arts, Entertainment, and Recreation each lost 100 jobs. The number of jobs in the Government sector was unchanged in the quarter.

In the second quarter of 2024, visitor arrivals by air increased in Honolulu but decreased in Maui County, Kauai, and Hawaii County. Visitor arrivals by air increased 3.0 percent in Honolulu and decreased 25.0 percent in Maui County, decreased 3.7 percent in Kauai, and decreased 3.0 percent in Hawaii County compared to the same quarter of 2023.

In the second quarter of 2024, the value of private building permits increased in Honolulu, and Hawaii County but decreased in Maui County and Kauai. In the second quarter of 2024, private building permits increased \$346.5 million or 79.2 percent in Honolulu and increased \$46.4 million or 18.2 percent in Hawaii County. Private building permits decreased \$74.2 million or 34.4 percent in Maui County and decreased \$17.2 million or 43.7 percent in Kauai (only residential available) from the same quarter of the previous year.

### A. LABOR FORCE AND JOBS

Hawaii's labor market conditions were mixed in the second quarter of 2024. The civilian labor force and civilian employment decreased, however, civilian unemployment and the unemployment rate decreased as well. Civilian non-agricultural wage and salary jobs increased slightly due to an increase in government sector jobs.

In the second quarter of 2024, the civilian labor force averaged 668,050 people, a decrease of 8,650 people or 1.3 percent from the same quarter of 2023 (Table A-1). In the first half of 2024, the civilian labor force decreased 6,900 people or 1.0 percent from the same period of the previous year.

Civilian employment averaged 649,350 people in the second quarter of 2024, a decrease of 8,000 people or 1.2 percent compared to the same quarter of 2023 (Table A-2). In the first half of 2024, average civilian employment decreased 6,700 people or 1.0 percent from the same period of the previous year.

In the second quarter of 2024, the number of civilian unemployed averaged 18,700, a decrease of 650 people or 3.4 percent from the same quarter of 2023 (Table A-3). In the first half of 2024, the number of unemployed decreased 200 people or 1.0 percent from the same period of the previous year.

The unemployment rate (not seasonally adjusted) was 2.8 percent in the second quarter of 2024, a decrease of 0.1 percentage point from the second quarter of 2023 (Table A-4). In the first half of 2024, the unemployment rate remained the same at 2.9 percent compared to the same period of the previous year.

In the second quarter of 2024, Hawaii's non-agricultural wage and salary jobs averaged 636,900 jobs, an increase of 2,200 jobs or 0.3 percent from the same quarter of 2023 (Table A-6). In the first half of 2024, average non-agricultural wage and salary jobs increased 0.4 percent or 2,700 jobs from the same period of the previous year.

The increase in jobs in the second quarter of 2024 was due to job increases in the government sector. The number of non-agricultural jobs in the private sector remained the same in this quarter compared to the second quarter of 2023. The number of jobs decreased the most in Transportation, Warehousing and Utilities, which lost 1,600 jobs or 4.6 percent (Table A-11); Information, which lost 1,500 jobs or 18.5 percent (Table A-12); Retail Trade, which lost 1,000 jobs or 1.5 percent (Table A-10) and Financial Activities, which lost 1,000 jobs or 3.6 percent (Table A-13) in the quarter. The number of jobs increased the most in Construction, which gained 3,500 jobs or 9.2 percent (Table A-7), followed by Health Care and Social Assistance, which gained 2,300 jobs or 3.1 percent (Table A-16) in the quarter.

The Government sector gained 2,200 jobs or 1.8 percent (Table A-21) in the second quarter of 2024 compared to the same quarter of 2023. The Federal Government added 700 jobs or 2.0 percent (Table A-22), the State Government added 1,300 jobs or 1.8 percent (Table A-23), and the Local Government added 200 jobs or 1.1 percent (Table A-24), compared to the second quarter of 2023.

# **B. INCOME AND PRICES**

In the first quarter of 2024, total annualized nominal GDP increased \$5,210 million or 4.9 percent, from the same quarter of 2023. In 2023, total annualized nominal GDP increased \$6,940 million or 6.9 percent from the previous year. In the first quarter of 2024, total annualized real GDP (in chained 2017 dollars) increased \$1,546 million or 1.8 percent from the same quarter of 2023. In 2023, total annualized real GDP increased \$1,676 million or 2.0 percent from the previous year (Tables B-1 to B-3).

Hawaii's total personal income increased during the first quarter of 2024, over the same quarter of 2023; all components of personal income increased over the same quarter of the previous year.

In the first quarter of 2024, total nominal annualized personal income (i.e. not adjusted for inflation) increased \$5,037.9 million or 5.5 percent over that of 2023 (Table B-5). In 2023, average personal income was \$93,654.7 million, an increase of \$4,681.4 million or 5.3 percent from the previous year. In the first quarter of 2024, personal income per capita was \$67,657, a 5.8 percent increase over the same quarter of the previous year (Table B-6).

In the first quarter of 2024, wages and salaries increased \$3,169.1 million or 7.1 percent over the same quarter of 2023. In 2023, wages and salaries increased \$2,964.2 million or 6.9 percent from the previous year (Table B-8).

Supplements to wages and salaries, consisting of employer payments to retirement plans, private group health insurance plans, private workers compensation plans, and other such benefits, increased \$854.9 million or 6.8 percent in the first quarter of 2024 from the same quarter of 2023 (Table B-9). In 2023, supplements to wages and salaries increased \$704.1 million or 5.8 percent from the previous year.

Proprietors' income increased \$415.0 million or 6.3 percent in the first quarter of 2024 over that of 2023 (Table B-10). In 2023, proprietors' income was up \$218.1 million or 3.3 percent from the previous year.

Dividends, interest, and rent increased \$789.4 million or 4.2 percent in the first quarter of 2024 from the same quarter of 2023. In 2023, income in this category was up \$1,154.6 million or 6.5 percent from the previous year (Table B-11).

The annualized personal current transfer receipts increased \$352.3 million or 2.1 percent in the first quarter of 2024 from the same quarter of 2023 (Table B-12). In 2023, personal current transfer receipts increased \$111.5 million or 0.7 percent from the previous year.

Contributions to government social insurance (which is subtracted from total personal income) increased \$542.8 million or 7.3 percent in the first quarter of 2024 compared to the same quarter of 2023. In 2023, these contributions increased \$471.2 million or 6.5 percent from the previous year (Table B-13).

In the first quarter of 2024, total non-farm private sector annualized earnings increased \$2,734.5 million or 6.0 percent from the same quarter of 2023 (Table B-4). In dollar terms, the largest increase occurred in health care and social assistance; followed by transportation and warehousing, and construction. During the first quarter of 2024, total government earnings increased \$1,694.5 million or 9.7 percent from the same quarter of 2023. Earnings from the federal government increased \$933.9 million. Earnings from the state and local governments increased \$760.6 million in the quarter.

In the first half of 2024, Honolulu's Consumer Price Index for Urban Consumers (CPI-U) increased 4.7 percent from the same period in 2023 (Table B-14). This is 1.5 percentage points above the 3.2 percent increase for the U.S. average CPI-U in the first half of 2024. It is also higher than the 3.4 percent increase in the Honolulu CPI-U for the first half of 2023 compared to the same period of the previous year. In the first half of 2024, the Honolulu CPI-U increased the most in Housing (8.0 percent), followed by Food and Beverages (4.1 percent), Other Goods and Services (3.9 percent), and Recreation (3.4 percent). The Honolulu CPI-U decreased in Apparel (2.6 percent), Education and Communication (1.1 percent), and Transportation (0.3 percent) compared to the first half of 2023.

#### C. TAX REVENUES

The State general fund tax revenues increased in the second quarter of 2024 compared to the same quarter of 2023. Among the components shown, the Net Corporate Income Tax revenues increased while the Net Individual Income Tax, General Excise and Use Tax (GET), and Transient Accommodations Tax (TAT) collections decreased.

In the second quarter of 2024, total tax collections distributed to the State general fund totaled \$2,812.6 million, an increase of \$38.6 million or 1.4 percent over the same quarter of 2023 (Tables C-1 and C-2). In the first half of 2024, State general fund tax revenues increased \$64.3 million or 1.3 percent over the same period in the previous year.

During the second quarter of 2024, GET revenues (excluding the Counties' Surcharges) totaled \$1,115.6 million, a decrease of \$19.9 million or 1.7 percent over the same quarter of 2023 (Table C-3). In the first half of 2024, GET revenues increased \$6.9 million or 0.3 percent from the first half of the previous year.

Compared to the second quarter of 2023, Net Individual Income Tax revenues decreased \$75.0 million or 6.4 percent to \$1,100.8 million in the second quarter of 2024 (Table C-4). In the second quarter of 2024, Declaration of Estimated Taxes decreased \$80.2 million or 13.9 percent (Table C-5), Payments with Returns decreased \$6.3 million or 2.9 percent (Table C-6), Revenues from Withholding Tax on Wages increased \$59.2 million or 9.3 percent (Table C-7), and Refunds increased \$47.7 million or 18.6 percent (Table C-8). In the first half of 2024, Net Individual Income Tax collections decreased 103.8 million or 5.6 percent from the same period in 2023.

Net Corporate Income Tax revenues, which tend to be volatile by nature, increased from \$134.6 million in the second quarter of 2023 to \$251.0 million in the second quarter of 2024, an increase of \$116.4 million (Table C-9). In the second quarter of 2024, the Declaration of Estimated Taxes increased \$109.9 million or 79.8 percent (Table C-10), the Payment with Returns increased \$18.2 million or 105.6 percent (Table C-11), and the Refunds decreased \$11.7 million or 57.2 percent (Table C-12), compared with the same quarter of 2023. In the first half of 2024, Net Corporate Income Tax revenues increased \$157.0 million or 92.5 percent from the same period in the previous year.

In the second quarter of 2024, TAT revenues decreased \$13.3 million, or 6.2 percent compared to the same quarter of 2023 (Table C-13). In the first half of 2024, TAT revenues decreased \$17.9 million or 4.0 percent from the same period in the previous year.

According to the most recent data available, in the first quarter of 2024, the Retailing tax base increased 1.5 percent or \$176.0 million (Table C-14), the Services tax base increased 5.5 percent or \$284.6 million (Table C-15), the Contracting tax base increased 19.1 percent or \$510.2 million (Table C-16), and the Hotel Rentals tax base decreased 1.0 percent or \$21.6 million (Table C-17), compared to the same quarter of the previous year. For 2023, the Retailing tax base increased 3.9 percent, the Services tax base increased 6.8 percent, the Contracting tax base increased 9.8 percent, and the Hotel Rentals tax base increased 2.7 percent.

# D. TOURISM

International visitor arrivals increased while domestic visitor arrivals decreased in the second quarter of 2024.

The total number of visitor arrivals by air decreased 131,452 or 5.3 percent in the second quarter of 2024, compared to the second quarter of 2023 (Table D-2). The total average daily census decreased by 17,188 or 7.1 percent in the quarter. In the first half of 2024, total visitor arrivals by air decreased 191,903 or 3.9 percent, while the average daily census decreased 16,434 or 6.7 percent from the previous year.

In the second quarter of 2024, total visitor arrivals on domestic flights decreased 155,228 or 7.2 percent compared to the same quarter of 2023 (Table D-3). In the first half of 2024, domestic arrivals were down 287,823 or 6.9 percent from the previous year.

Arrivals on international flights increased 23,776 or 7.3 percent in the second quarter of 2024 compared to the second quarter of 2023 (Table D-4). In the first half of 2024, international arrivals increased 95,920 or 13.3 percent from the previous year.

In terms of major market areas, from the second quarter of 2024 to the same period of 2023, arrivals from the U.S. West decreased 111,577 or 8.1 percent (Table D-5), arrivals from the U.S. East decreased 39,054 or 6.0 percent (Table D-6), and arrivals from Japan increased 41,001 or 36.0 percent (Table D-7). In the first half of 2024, arrivals from the U.S. West were down 186,560 or 7.1 percent; arrivals from the U.S. East were down 94,708 or 7.2 percent; and Japanese arrivals were up 121,738 or 59.4 percent from the previous year.

The total average daily visitor census was down 7.1 percent or 17,188 visitors per day in the second quarter of 2024, over the same quarter of 2023 (Table D-8). The domestic average daily census decreased 7.3 percent or 15,337 visitors per day (Table D-9) and the

international average daily census decreased 5.7 percent or 1,850 visitors per day (Table D-10). In the first half of 2024, the domestic average daily census decreased 16,309 or 7.9 percent; and the international average daily census decreased by 125 or 0.3 percent from the previous year.

Nominal visitor expenditures by air totaled \$5,019.8 million in the second quarter of 2024, a decrease of \$395.8 million or 7.3 percent from the second quarter of 2023 (Table D-11). In the first half of 2024, visitor expenditures totaled \$10,219.8 million, a decrease of \$565.7 million or 5.2 percent from the same period of the previous year.

Total airline capacity, as measured by the number of available seats flown to Hawaii, increased 2.4 percent or by 78,684 seats (Table D-12) in the second quarter of 2024, domestic seats decreased 0.3 percent or 8,326 seats (Table D-13), and international seats increased 16.1 percent or 87,010 seats (Table D-14), compared to the same quarter of 2023. In the first half of 2024, the number of total available seats increased 0.3 percent or 19,971 seats, domestic seats decreased 3.6 percent or 194,559 seats, and international seats increased 18.2 percent or 214,530 seats from the same period of the previous year.

In the second quarter of 2024, the statewide hotel occupancy rate averaged 73.0 percent, 1.2 percentage points lower than that of the same quarter of 2023 (Table D-15). In the first half of 2024, the statewide hotel occupancy rate averaged 74.7 percent, 0.1 percentage point higher than the occupancy rate for the same period of the previous year.



# E. CONSTRUCTION

The indicators of Hawaii's construction industry were largely positive in the second quarter of 2024. Construction jobs and state government CIP expenditures increased in the quarter, though government contracts awarded decreased. Private building authorizations increased for the state overall. Authorizations increased in Honolulu County and Hawaii County but decreased in Maui County and Kauai County compared to the second quarter of 2023.

In the second quarter of 2024, the number of jobs in the construction sector increased by 9.2 percent or by 3,500 jobs compared with the same quarter of 2023. In the first half of 2024, the construction sector added 3,000 jobs or 7.9 percent (Table A-7) compared to the same period of the previous year.

In the second quarter of 2024, private building authorizations in the state increased \$301.6 million or 31.9 percent, compared with the second quarter of 2023 (Table E-8). In the first half of 2024, private building authorizations in the state increased \$518.1 million or 29.8 percent compared with same period of 2023.

In the second quarter of 2024, private building authorizations in Honolulu County increased \$346.5 million or 79.2 percent, compared with the second quarter of 2023 (Table E-8). In the first half of 2024, private building authorizations in Honolulu County increased \$577.7 million or 71.3 percent, compared with the same period in the previous year.

In the second quarter of 2024, private building authorizations in Hawaii County increased \$46.4 million or 18.2 percent, compared with the second quarter of 2023 (Table E-8). In the first half of 2024, private building authorizations in Hawaii County increased \$31.4 million or 6.6 percent, compared with the same period of the previous year.

In the second quarter of 2024, private building authorizations in Maui County decreased \$74.2 million or 34.4 percent, compared with the second quarter of 2023 (Table E-8). In the first half of 2024, private building authorizations in Maui County decreased \$83.7 million or 22.1 percent compared with the same period of the previous year.

In the second quarter of 2024, private building authorizations (residential only) in Kauai County decreased \$17.2 million or 43.7 percent, compared with the second quarter of 2023 (Table E-8). In the first half of 2024, private building authorizations in Kauai

County decreased \$7.3 million or 9.9 percent compared with the same period of the previous year.

In the second quarter of 2024, government contracts awarded decreased \$346.5 million or 43.3 percent, compared with the second quarter of 2023 (Table E-1). In the first half of 2024, government contracts awarded decreased \$3,149.9 million or 79.1 percent compared with the same period of the previous year. State government CIP expenditures increased \$137.4 million or 43.2 percent in the second quarter of 2024 compared with the same quarter of 2023. In the first half of 2024, state government CIP expenditures increased \$191.5 million or 30.8 percent from the same period of the previous year (Table E-2).

The Honolulu Construction Cost Index for Single Family Residence (Table E-6) increased 3.9 percent in the first quarter of 2024 compared to the same quarter of 2023 and similarly the High-Rise Building Index increased 3.4 percent for (Table E-7). In the first half of 2024, the index for Single Family Residence increased 3.9 percent and 3.6 percent for High-Rise Building as compared to the first half of 2023.

Average home prices increased by 0.5 percent in the second quarter of 2024, with single family home prices up by 5.8 percent and condo prices down by 2.3 percent over the same quarter of the previous year (Table E-9). The purchase of homes increased by 11.7 percent for local buyers, by 20.6 percent for mainland buyers, and by 17.3 percent for foreign buyers over the same quarter of the previous year (Table E-10).

In the second quarter of 2024, Honolulu's median price for single family resales was \$1,100,000, up \$50,000 or 4.8 percent over the same quarter of 2023 (Table E-11). The median price for condominium unit resales was \$510,000, up \$10,000 or 2.0 percent over the same quarter of 2023 (Table E-12). In the second quarter of 2024, the number of single-family unit resales increased 7.1 percent, while the number of condominium unit resales decreased 4.8 percent, compared with the second quarter of 2023 (Tables E-13 and E-14). In the first half of 2024, the number of single-family unit resales increased 6.7 percent, while condominium unit resales decreased 5.8 percent compared with the same period of the previous year.

# F. OTHER INDICATORS

The total number of bankruptcy filings in Hawaii increased by 5.2 percent or by 14 cases for the second quarter of 2024, from the same quarter of 2023. In the first half of 2024, total filings increased 17.5 percent or 88 cases from the same period of the previous year.

The number of Chapter 7 filings, the largest category, increased by 17.3 percent or by 28 cases in the second quarter of 2024. Chapter 7 filings are intended to liquidate assets and discharge debt. In the first half of 2024, Chapter 7 filings increased 18.8 percent or 60 cases from the same period of the previous year.

Chapter 11 filings decreased from 3 cases in the second quarter of 2023 to 1 case in the second quarter of 2024. In the first half of 2024, Chapter 11 filings decreased to 1 case from 3 cases in the

same period of the previous year. Chapter 11 filings involve the structuring of repayment plans for companies.

Chapter 13 filings decreased by 11.4 percent or 12 cases in the second quarter of 2024, from the same quarter of 2023. In the first half of 2024, Chapter 13 filings increased 16.0 percent or 29 cases from the same period of the previous year. Chapter 13 bankruptcy allows debtors to work out repayment arrangements with creditors.
