August 2025 Hawai'i Hotel Performance Report

Hawai'i hotels statewide reported slightly higher occupancy and revenue per available room (RevPAR) while average daily rate (ADR) remained unchanged in August 2025 compared to August 2024. When compared to pre-pandemic August 2019, statewide ADR and RevPAR were higher in August 2025, but occupancy was lower.

Statewide RevPAR in August 2025 was \$268 (+0.7%), with ADR at \$361 (0.0%) and occupancy of 74.1 percent (+0.5 percentage points) compared to August 2024 (Figure 1). Compared with August 2019, RevPAR was 9.7 percent higher, driven by higher ADR (+24.5%) which offset lower occupancy (-10.0 percentage points) (Figure 3).

The report's findings utilized data compiled by STR, Inc., which conducts the largest and most comprehensive survey of hotel properties in the Hawaiian Islands. For August 2025, the survey included 166 properties representing 47,944 rooms, or 84.3 percent of all lodging properties with 20 rooms or more in the Hawaiian Islands, including those offering full service, limited service, and condominium hotels. Vacation rental and timeshare properties were not included in this survey.

Statewide Hawai'i hotel room revenues totaled \$471.6 million (+1.4% vs. 2024, +15.5% vs. 2019) in August 2025. Room demand was 1.3 million room nights (+1.4% vs. 2024, -7.2% vs. 2019) and room supply was 1.8 million room nights (+0.7% vs. 2024, +5.3% vs. 2019) (Figure 2).

Luxury Class properties earned RevPAR of \$575 (+12.8% vs. 2024, +22.2% vs. 2019), with ADR at \$857 (+1.3% vs. 2024, +48.4% vs. 2019) and occupancy of 67.1 percent (+6.8 percentage points vs. 2024, -14.3 percentage points vs. 2019). Midscale & Economy Class properties earned RevPAR of \$170 (-2.2% vs. 2024, +20.1% vs. 2019) with ADR at \$219 (-2.5% vs. 2024, +28.1% vs. 2019) and occupancy of 77.8 percent (+0.2 percentage points vs. 2024, -5.2 percentage points vs. 2019).

Kaua'i hotels led the counties in August 2025 RevPAR of \$324 (+4.0% vs. 2024, +54.7% vs. 2019), with ADR at \$430 (+2.1% vs. 2024, +51.5% vs. 2019) and occupancy of 75.3 percent (+1.4 percentage points vs. 2024, +1.6 percentage points vs. 2019).

Maui County hotels continued to be impacted by the August 8, 2023, wildfires. Maui County hotels achieved RevPAR of \$310 (+8.7% vs. 2024, +1.6% vs. 2019), with ADR at \$501 (-3.2% vs. 2024, +27.7% vs. 2019) and occupancy of 62.0 percent (+6.7 percentage points vs. 2024, -15.9 percentage points vs. 2019). Maui's luxury resort region of Wailea had RevPAR of \$491 (+6.7% vs. 2024, -13.7% vs. 2019), with ADR at \$702 (-3.4% vs. 2024, +12.2% vs. 2019) and occupancy of 69.9 percent (+6.6 percentage points vs. 2024, -21.0 percentage points vs. 2019). The Lahaina/Kā'anapali/Kapalua region had RevPAR of \$241 (+17.7% vs. 2024, -2.8% vs. 2019), ADR at \$395 (-2.3% vs. 2024, +21.1% vs. 2019) and occupancy of 61.2 percent (+10.4 percentage points vs. 2024, -15.1 percentage points vs. 2019).

Hotels on the island of Hawai'i reported RevPAR of \$297 (+3.2% vs. 2024, +31.0% vs. 2019), with ADR at \$444 (+3.1% vs. 2024, +58.7% vs. 2019), and occupancy of 66.8 percent (+0.1 percentage points vs. 2024, -14.1 percentage points vs. 2019). Kohala Coast hotels earned

RevPAR of \$398 (-0.7% vs. 2024, +16.3% vs. 2019), with ADR at \$603 (+6.3% vs. 2024, +48.6% vs. 2019), and occupancy of 66.0 percent (-4.7 percentage points vs. 2024, -18.3 percentage points vs. 2019).

O'ahu hotels reported RevPAR of \$234 (-4.7% vs. 2024, +2.9% vs. 2019) in August, ADR at \$289 (-2.0% vs. 2024, +13.3% vs. 2019) and occupancy of 80.8 percent (-2.3 percentage points vs. 2024, -8.2 percentage points vs. 2019). Waikīkī hotels earned RevPAR of \$224 (-5.2% vs. 2024, +0.9% vs. 2019), with ADR at \$272 (-3.4% vs. 2024, +9.2% vs. 2019) and occupancy of 82.4 percent (-1.5 percentage points vs. 2024, -6.8 percentage points vs. 2019).

About the Hawai'i Hotel Performance Report

The Hawai'i Hotel Performance Report is produced using hotel survey data compiled by STR, Inc., the largest survey of its kind in Hawai'i. The survey generally excludes properties with under 20 lodging units, such as small bed and breakfasts, youth hostels, single-family vacation rentals, cottages, individually rented vacation condominiums and sold timeshare units no longer available for hotel use. The data has been weighted both geographically and by class of property to compensate for any over and/or under representation of hotel survey participants by location and type.

For August 2025, the survey included 166 properties representing 47,944 rooms, or 84.3 percent of all lodging properties with 20 rooms or more in the Hawaiian Islands, including full service, limited service, and condominium hotels. The August survey included 85 properties on O'ahu, representing 29,977 rooms (95.5%); 38 properties in the County of Maui, representing 9,390 rooms (69.2%); 23 properties on the island of Hawai'i, representing 5,223 rooms (77.3%); and 20 properties on Kaua'i, representing 3,354 rooms (65.3%).

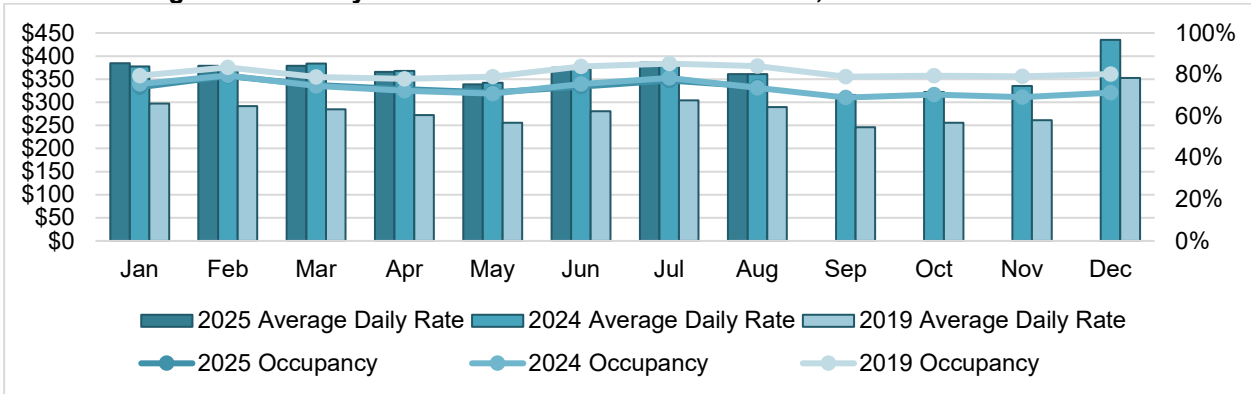

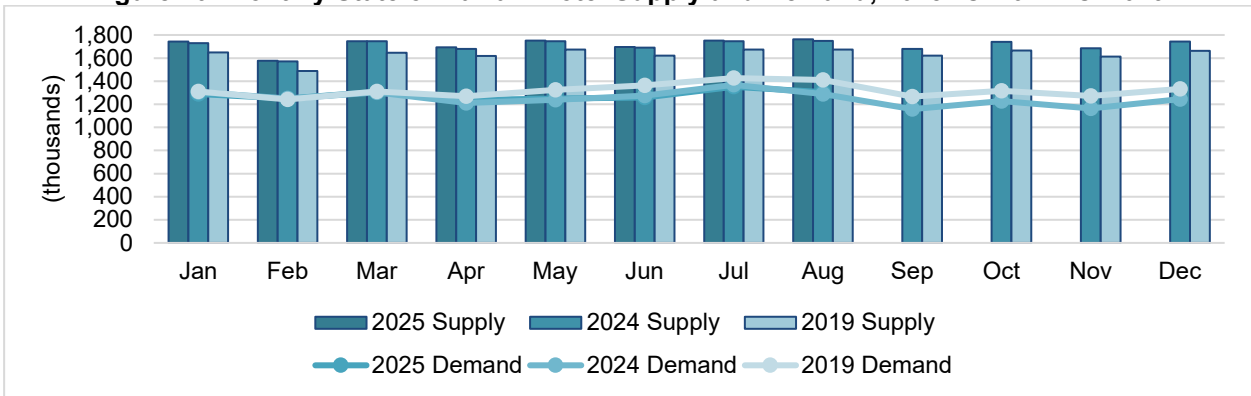

Figure 9: Monthly State of Hawai'i Hotel Performance, 2025 vs. 2024 vs. 2019



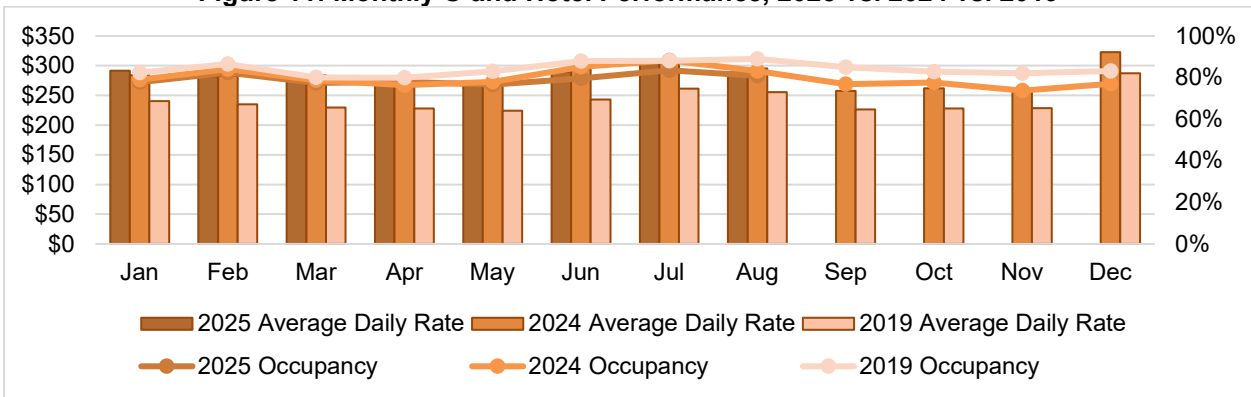

Figure 10: Monthly State of Hawai'i Hotel Supply and Demand, 2025 vs. 2024 vs. 2019



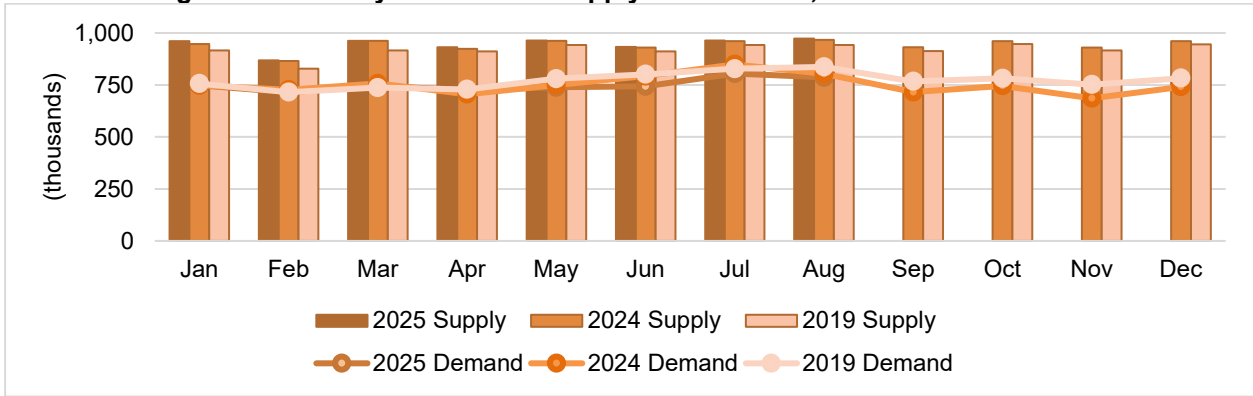

Figure 11: Monthly O'ahu Hotel Performance, 2025 vs. 2024 vs. 2019



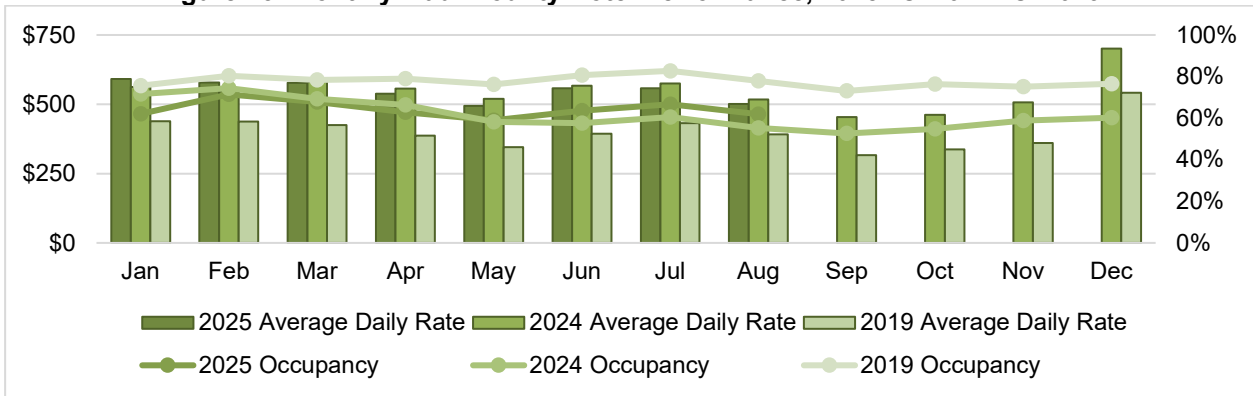

Figure 12: Monthly O'ahu Hotel Supply and Demand, 2025 vs. 2024 vs. 2019



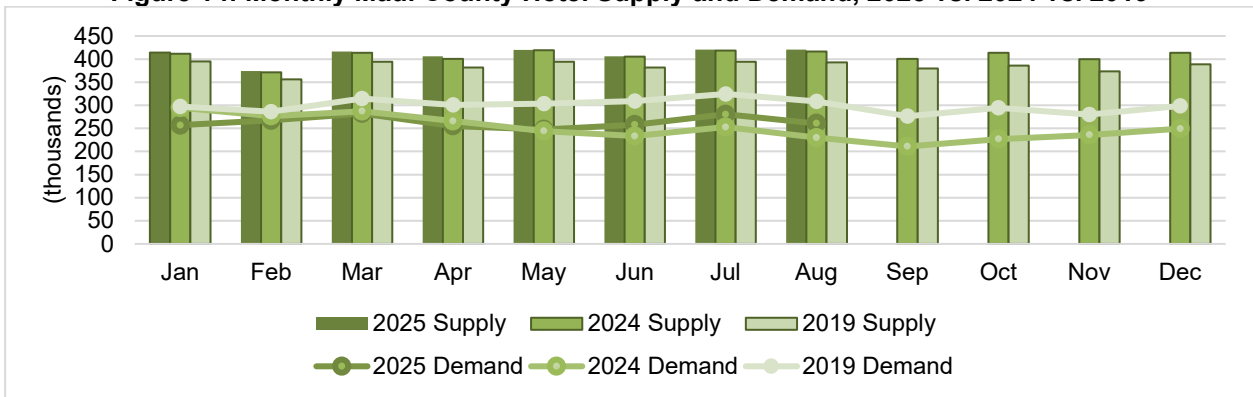

Figure 13: Monthly Maui County Hotel Performance, 2025 vs. 2024 vs. 2019



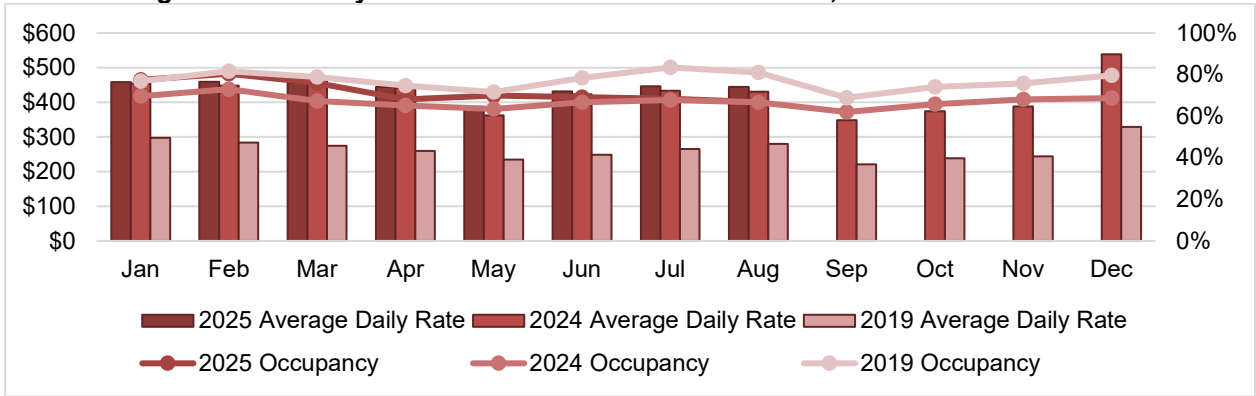

Figure 14: Monthly Maui County Hotel Supply and Demand, 2025 vs. 2024 vs. 2019



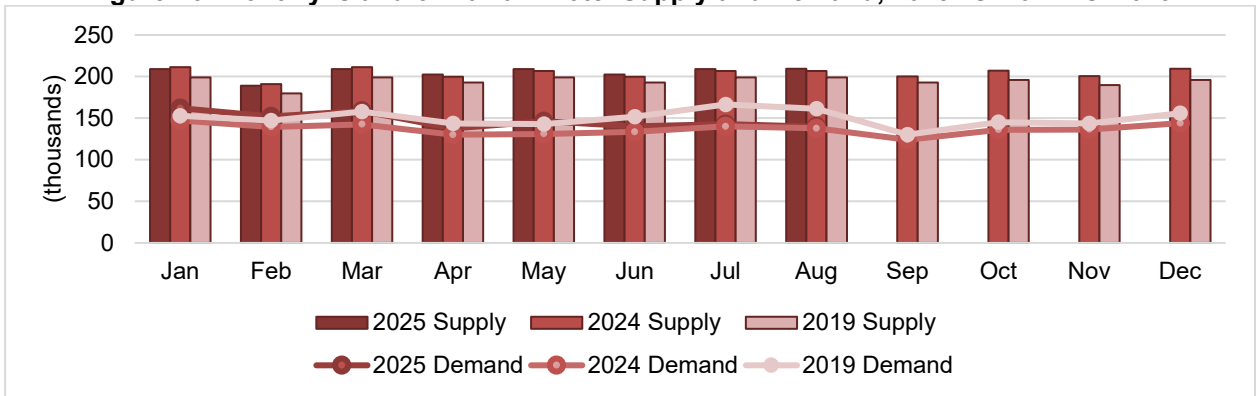

Figure 15: Monthly Island of Hawai'i Hotel Performance, 2025 vs. 2024 vs. 2019



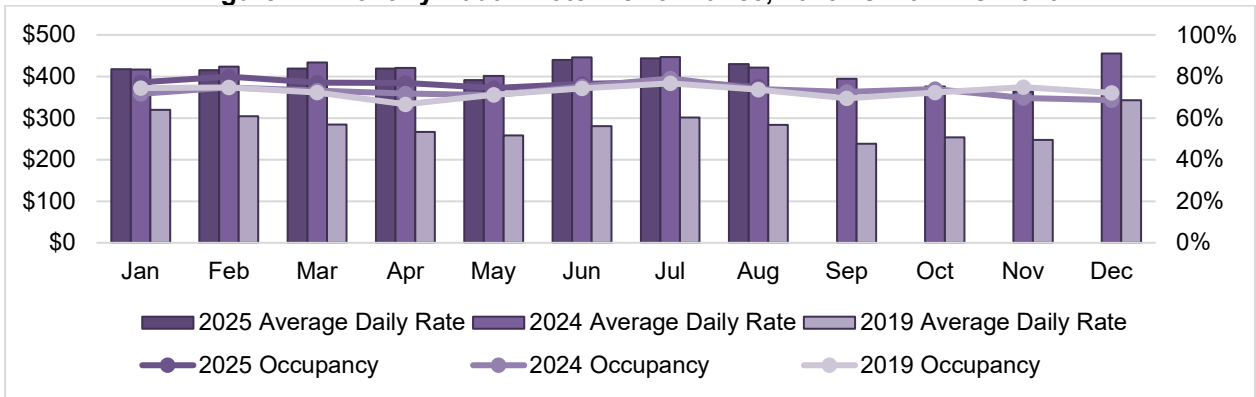

Figure 16: Monthly Island of Hawai'i Hotel Supply and Demand, 2025 vs. 2024 vs. 2019



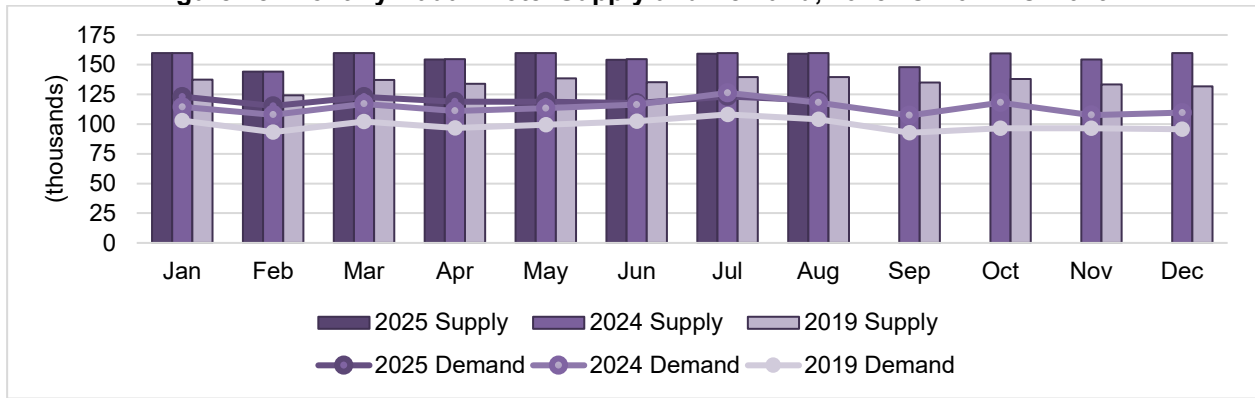
