The State of Hawai'i (State), Hawaii Housing Finance and Development Corporation is requesting to withdraw the "Wailuku State Office Building (SOB) 3" Draft Environmental Assessment-Anticipated Finding of No Significant Impact (DEA-AFNSI) that was published in the June 8, 2021 edition of The Environmental Notice.

A new Draft Environmental Assessment (DEA) will be prepared under the State, Department of Accounting and General Services (the new Proposing and Determining Agency) to supersede the withdrawn "Wailuku SOB 3" DEA-AFNSI.
