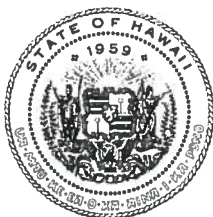

With this letter, the Department of Land and Natural Resources hereby withdraws the final environmental assessment and finding of no significant impact (FEA-FONSI) for the Kekaha Kai State Parks Phase II Improvements at TMK (3) 7-2-05: 02, 03 & 07; 7-3-43: por. 01; 7-2-04: 03, 09, 17 & 19. The FEA-FONSI was published in *The Environmental Notice* on February 23, 2015.

The DLNR is withdrawing the FEA-FONSI because it was inadvertently published prior to approval by the Board of Land and Natural Resources (BLNR). If approved by the BLNR, the FEA-FONSI will be re-published in a subsequent issue of *The Environmental Notice*.
