At its meeting of September 25, 2014, the Exemption Committee reviewed the status of the exemption lists of State and City and County of Honolulu agencies based upon the list prepared in its previous review dated January, 2012. The last column shows the action taken by the committee based upon the absence of a list or a list more than five years old. Final recommendations will be made following receipt of responses from all agencies to a letter sent to them by OEQC asking them to verify the status of their exemption list. The deadline for responses to the letter is December 31, 2014.
