1. Call to Order, Roll Call, Quorum

- a. Chair Shacat called the meeting to order at 1:05 PM with a quorum of 9 members.
- b. Director Glenn introduced the Office of Environmental Quality Control's (OEQC) new Planner III, Zachary Stoddard.
- c. Chair Shacat announced that he would like to step down as Chair of the Environmental Council due to family commitments. He requested Councilmembers to consider serving as Chair. Time commitments of the Chair generally include 2-3 hours per week on average, working with the OEQC Director regularly to prepare the agenda, track activities of the Council, and review incoming correspondence. The Chair does not have to be someone who lives on O'ahu. Past Chairs have lived on other islands. Director Glenn committed to working with a Chair from another island if elected. Consensus is to add this item to the agenda for the next meeting.

2. Review and Approval of Prior Meeting Minutes

- a. April 12, 2016
 - i. MOTION: Member Prentiss motioned and Member Richards seconded to approve the minutes. The motion passed unanimously.

3. Director's Report

- a. OEQC is still recruiting to fill its Secretary II position.
- b. The OEQC Director is a member of the Department of Agriculture Plant and Animal Advisory Committee. At their last meeting, the Committee recommended to the Board of Agriculture to implement rules regarding Rapid 'Ōhi'a Death to reduce the risk of it spreading to other islands from Hawai'i Island.

- c. The OEQC Director and staff have been participating in the Interagency Climate Adaptation Committee (ICAC), co-led by the Department of Land and natural Resources and the State Office of Planning as well as the Climate Change and Health Working Group sponsored by the Department of Health and the HPHA.
 - At recent meetings, Dr. Charles Fletcher presented preliminary groundwater inundation and wave overtopping maps at the parcel level. Director Glenn sees this as a helpful step in making climate change adaptation more applicable to development and environmental protection discussion.
 - ii. Once these maps are finalized, Dr. Fletcher will make the maps available to the public as GIS layers.
 - iii. These maps could be useful for community resource management as well.
- d. The OEQC is working on technology upgrades for the Office and to support the Council, including getting internet streaming-capable camera and a hotspot for Council meetings. This might be ready by the July meeting, unlikely for the June meeting.
 - i. This would allow for the streaming of Council meetings for the public to observe and participate in
 - ii. It is unclear if and how Councilmembers could participate in the Council meeting remotely if the Council does have this set up.
 - iii. ACTION: The Council asked Director Glenn to ask the Office of Information Practices on how to integrate this technology appropriately to comply with sunshine law requirements.
