- 1. Call to order, roll call and quorum, introductions
 - i. Meeting called to order at 1:01 pm
 - ii. Quorum met with 12 members present
- 2. Review and approval of prior meeting minutes
 - a. Meeting held on May 9, 2017
 - i. Minutes not available, defer until July 27, 2017.
 - b. Meeting held on June 13, 2017
 - i. Minutes not available, defer until July 27, 2017.
- 3. National Oceanic and Atmospheric Administration (NOAA) Review of National Marine Sanctuaries and Marine National Monuments Designated or Expanded Since April 28, 2007; Notice of Opportunity for Public Comment (see Attachment A)
 - a. Consideration as to whether the Environmental Council will submit comments regarding Papahānaumokuākea Marine National Monument
 - i. Motion by Member Glenn that the Council submit letter to NOAA in response to DOI consistent with previous letter in support of Papahānaumokuākea National Marine Monument. Chair Shacat to draft letter with Member Ka'aumoana to assist. Member Tulang seconded the motion. Motion unanimously approved.
- 4. Information and Outreach Committee Report
 - a. State Department of Health's monitoring and warning sign posting issues for high bacteria levels, and potential for partnering with community group.

- i. Member Ka'aumoana attended a meeting with DOH on Kauai. To comply with the BEACH Act, DOH has been posting temporary beach warning signs when test results show high bacteria levels. The beaches are not closed. DOH currently does not have plans to utilize community groups to assist with posting and removing signs. One concern was that the temporary signs are paper signs with a plastic covering that do not appear to have as much authority as permanent metal signs. Laura McIntyre of DOH, who attended as a guest, indicated that polluted waters need to be listed on the 303D list for permanent metal signs to be posted. She noted that permanent signage ends monitoring of the site.
- b. Potential initiatives on stormwater pollution control including:
 - i. Public-private partnerships with the visitor industry
 - 1) Member Begier contacted Wayne Hedani of the Ka'anapali Operations Association regarding their storm inlet trash baskets program, but was not at today's committee meeting to provide a report.
 - ii. State water quality standards and current point and non-point source discharge permitting and compliance challenges
 - 1) Based on discussions with L. McIntyre after the last Environmental Council meeting, a meeting is being planned with DOH to discuss current challenges with industrial stormwater permitting. Chair Shacat and other industry representatives will be involved in the meeting.
 - 2) Chair Shacat and Member Abe attended a C&C Honolulu workshop on new City water quality rules, which involve new requirements and procedures to reduce stormwater pollution from construction and constructed projects. The new provisions, which apply to projects involving ground disturbance, include new plan review and certification requirements, permitting procedures, and use of additional best management practices (BMPs). The new permitting system will start August 2017 and will include additional permit fees to review plans for stormwater BMPs.
- 4. Exemption Committee report on exemption list reviews
 - a. Chair Shacat updated the council awaiting on disclaimers pending from NELHA and BWS. HI PHA disclaimer received needs to be posted on website. The City & County of Honolulu, Department of Facilities Maintenance exemption list is 20 years old and needs to be updated. No action by the Council is needed at this time.
- 5. Decision making on 2017 Annual Report topics, preparation, and timeline
 - a. Committee Chair Parsons reported quorum not met for committee meeting today. Decision making on topics tabled to August 8 meeting. Present timeline to Council for review, discussion and approval in August. The GPI indicator is being considered for inclusion for continuity. Member Parsons will meet with the Environmental Funders Group Annual Report to alleviate duplication of information.

- 7. Status of revisions to Hawai'i Administrative Rules (HAR) Chapter 11-200
 - a. Proposed schedule for rulemaking process, including special meetings of the Environmental Council, public outreach meetings, and administrative milestones
 - i. Proposed timeline for completion of rules revision including potential public hearings and Governor approval is approximately April or May 2018.
 - ii. Refer to item 8.i below for agreed upon meeting dates and times.
 - iii. Member Glenn reviewed the history of the rules update building from the last effort in 2012:
 - 1. 2012 EC rules released a draft version 1 and comment matrix to receive public input on the proposed language
 - 2. 2012-2014 Rules Committee reviewed the input and made revisions to version 1
 - 3. 2016 EC created a Permitted Interaction Group (PIG) to address the outstanding comments
 - 4. 2016 PIG created a new draft version that compiled the edits from the Rules Committee to version 1 and called it version 1.1
 - 5. 2017 PIG will submit a report to the EC with previous Rules Committee edits and new issues addressed with footnotes providing descriptions of the edits; this version may be called version 2
 - 6. The EC will do a training on at the next EC meeting on the existing rules to assist council members in understanding proposed changes to the process.
 - Report from the Permitted Interaction Group established on February 23, 2016 relating to revisions to HAR Chapter 11-200 – Suggested revisions to HAR Chapter 11-200 addressing comments received on the previous 2012 working draft language
 - i. Member Thoene reported no PIG report available at this time.
- 8. Environmental Council meeting schedule for 2017 and 2018
 - a. Members agreed to change the council meeting days from the second Tuesday of the month to the first Tuesday effective September and attend additional meetings within the month to review and update HAR 11-200 rules.
