4. Committee review of ongoing agency lists of exemption notices published in the Environmental Notice

Les said about 10 agencies were supplying lists. He discussed various issues that agencies with a lot of Divisions had in trying to get the lists together. We discussed how to get more agencies involved in both publishing their list of Exemption Notices and also reformatting their Exemption Lists. Decided that we should send another letter within a few months. Ron will draft for committee. All agreed that Council Chair should sign to give it more weight, so we will want to take to Council for action
