1. Call to order, roll call and quorum, introductions

With a quorum of ten (misquoted as nine) members present, Chairperson Thoene called the meeting to order at 1:34 PM.

2. Review and approval of prior meeting minutes

3. OEQC Director's Report

Deferred as Acting Director Kawaoka is in legislative meetings.

4. Exemption Committee Update

a. Review of and action to concur with the City & County of Honolulu Department of **Environmental Services exemption list**

Committee Chair Terry commented that the Exemption Committee was ready to concur but noticed that the Department of Environmental Services failed to add standard disclaimer language in the beginning.

MOTION: Committee Chair Terry moved from the Committee (no second needed) to concur with the City & County of Honolulu Department of Environmental exemption list with the addition of disclaimer language in the beginning of the list. The Environmental Council unanimously approved the motion (10-0-0).

b. Review of and action to approve publication of State of Hawai'i, Department of Hawaiian Homelands exemption list for public comment

MOTION: Committee Chair Terry moved from the Committee (no second needed) that the State of Hawai'i Department of Hawaiian Homelands exemption list be approved for publication for public comment. The Environmental Council unanimously approved the motion (10-0-0).

c. Discussion of agency feedback on exemption notices

Committee Chair Terry commented that questionnaire was sent to every agency that is expected to send an exemption notice once a month to OEQC which is published for the public. A lot of agencies are not doing this. The feedback from the agencies that replied was that this is a good process, and they believe that it makes their agencies more diligent on considering environmental impacts. One person provided oral feedback to Committee Chair Terry and asked for better training on creating the exemption notices.

5. Annual Report Committee Update

Chairperson Thoene updated the Council that the Annual Report was sent out in early February.

6. Legislative Committee Update

a. Update on pending legislation that may impact the Council

Committee Chair Kaye commented that the HB1318 hearing was today and passed with one reservation. HB901 hearing is tomorrow. The rest of the bills that the Committee is tracking have not moved forward.

7. Rules Committee Update

a. Discussion of potential amendments to Hawai'i Administrative Rules Title 11, Chapter 201
Committee Chair Tuteur commented that the rulemaking changes depend on if the appeals
process stays within the EC. If the process stays, the Committee is looking to update the rules to
reflect the ability to file electronically, increase the fee of filing, send one draft for public
comment, and take out any Council appeal references in Chapter 91. Members commented to
have a rationale document and if increasing the 30-day comment period, to look at the intent of
what the Council needs to do.

8. Information & Outreach Committee Update

Committee Chair Begier commented that the forums will now begin in June so as not to disrupt the legislative calendar.

Member Tulang left the meeting.
