- 1. Call to order, roll call and quorum, introductions.

- 3. Based on the discussion at the April 5, 2022 Strat Planning meeting and data contained therein I&O decided to revamp our forum direction from the previously agreed up forum topics. We will make our next forum specific to the EA & EIS processes. The discussion level will be geared to the lay person understanding. Our goal is to present this forum on zoom or other acceptable digital format as deemed appropriate prior to the end of calendar 2022. The time frame is broad due to the desired scope of presenters. Several names were considered/discussed. Various members of I&O volunteered to reach out to persons to check availability and interest to participate.

Each member of I&O will draft an elevator speech for presentation/discussion at the August I&O meeting. We invited the entire EAC to submit anything they might want to in this vein as well.
 - C. Discussed EAC support of creation of a Dept. Of the Environment.
 - D. Discussed the lack of a budget for I&O to bring up at the full EAC.
 - E. Discussed "representation" of each island or county on EAC.
