1. Call to order, Roll Call, Introductions, Quorum

With a quorum of 5 members present, Chairperson Thoene called the meeting to order at 1:03 PM.

2. Office of Planning and Sustainable Development (OPSD) Director's Update

Director Evans reported the emergency proclamation relating to wildfires continues to exempt Chapter 343. Maui County and Federal ordinances and rules that were adopted prior to the Governor's emergency proclamation issuance remain in force.

Discussion followed relating to the Director's update regarding the Governor's proclamation.

Director Evans also reported that there has been an increase in use in exemptions for affordable housing projects from producing an EA in the state urban district in a county zone that allows for housing. The increase implies that the addition to the 2019 rules can be used to reduce the cost of affordable housing projects in the urban district.

Member Mary Begier and Member Michele Lefebvre joined the meeting at 1:16 PM. Quorum is 7 members.
