### **1. Call to order, Roll Call, Introductions, Quorum**

With a quorum of four members present, Chairperson Hegger-Nordblom called the meeting to order at 1:00 PM.

### **2. Review and adoption of minutes of the March 3, 2026, meeting**

MOTION: Member Gordon moved to approve the March 2026 meeting minutes. Member Sprague seconded the motion. There was no further discussion or public testimony. The EAC voted to approve the motion (4-0-1).

### **3. Adoption of Time Limits on Oral Testimony**

The Council discussed the adoption of a formal policy for a time limit on oral testimony. Chair Hegger-Nordblom suggested that the limit be set to three (3) minutes.

MOTION: Member Lefebvre moved to accept the policy to allow for a reasonable time limit of three (3) minutes on oral testimony by members of the public on each discussion or action. Member Gordon seconded the motion. There was no further discussion or public testimony. The EAC voted to approve the motion (4-0-1).

The comment period on DLNR's Exemption List ran from February 23, 2026 to March 10, 2026. Three comments were received during the period. The Council requested that DLNR inform the Council of when they have drafted responses to the public comments. DLNR has not drafted responses at the time of the EAC meeting, therefore the Exemption Committee cannot move forward with an action on the Exemption List.

Kylie Cruz spoke on behalf of Earth Justice. Earth Justice also submitted written comments. The following comments were made by Earth Justice.

Type 4, Part 1, Number 21: Earth Justice requests that the exemption be amended to apply to only non-extractive ongoing activities, due to the cumulative impact of ongoing extractions.

Type 8, Part 1, Numbers 6-8: Earth Justice believes that the exemptions do not qualify for this category of exemptions, as the category is reserved for administrative activities.

Type 8, Part 1, Numbers 6-9: Earth Justice believes that the proposed exemption is overbreadth. The proposed exemptions seek to exempt a wide variety of land use transactions that fall within HRS 343-5A, the triggering category. Earth Justice suggests that there should be a limiting principle when assessing these types of transactions to ensure that exemptions apply to only minor activities, and not large-scale land use transactions that may be highly controversial.

Member Lefebvre clarified the role of the Council and the Exemptions Committee in the exemption list process. The EAC reviews submitted Exemption Lists and may concur with lists, but does not have the authority to approve lists.

Ashley Obrey stands on the written testimony provided by the Native Hawaiian Legal Corporation.

Rene Umberger spoke on behalf of For the Fishes with the following comment.

Type 4, Part 1, Number 21: For the Fishes explains that the exemption creates a loophole for commercial aquarium collection that would have large negative impacts on coral reefs. They request that the exemption excludes extractive activities.

Bills will then go to floor votes in the House and Senate, and if passed, will be sent to the Governor for consideration.

Director Evans presented on the review of the August 2019 adopted rules. ERP staff is continuing to discuss ways to align the rules with the updates in HRS, and clarify definitions and processes in the rules.
