Subject: Summary of January 2020, DHHL Actions Declared Exempt from the Preparation of an EA per Hawai'i Administrative Rules Section 11-200.1-15

Dear Sir or Madam:

The Department of Hawaiian Home Lands evaluated two actions, briefly described below, and determined both to be exempt from the preparation of an EA.

Action One:

Right of Entry land management disposition(s) that replace surrendered or relinquished general lease(s) when there is no change in use (reference-file # PO-20-002) was determined to be exempt based on the general types enumerated in Section 11-200.1-15(c), Hawai'i Administrative Rules (HAR), Exemption Type 8.

Action Two:

The acquisition of private land and structures using State funds of TMKs (1)2-7-011:008, 009, and 053, Coolidge Street and Isenberg Street, Mō'ili'ili, Kona Moku, O'ahu (reference-file # PO-20-005) was determined to be exempt based on the general types enumerated in Section 11-200.1-15(c), Hawai'i Administrative Rules (HAR), Exemption Type 9.
