Project includes but is not limited to: cold planing; resurfacing of asphalt concrete pavement; adjustment of utility manhole and handhole frames and covers; installation of pavement markings and vehicle loop detectors; reconstruction of existing concrete and vehicle loop detectors; reconstruction of existing concrete curb and/or gutters; and reconstruction of concrete curb ramps.

The project will mitigate rockfall hazards at five sites (S1-S5) along Pacific Heights Road, between Kaola Way and Ahekol Street that have been identified as having imminent to short term potential for rockfall due to opened fractures. The project area is 0.19 acres and entirely within CCH roadway ROW. The project includes the removal of 4 rock outcrops, rock scaling, the installation of shotcrete with grouted shotcrete anchors, geocomposite drain mats, and the removal of trees within the shotcrete limits.
