		151 Kapahulu Avenue	Honolulu	96815	3-1-043:001		2	Honolulu Zoo-Savanna Sidewalk, Walkway, and Guardrail Improvements Phase 1A: Project Description: The City and County of Honolulu, Department of Design and Construction is proposing to replace a portion of the existing pedestrian walkway in the Savanna area located at the Honolulu Zoo; limits of walkway to be replaced extends from the Giraffe Habitat to just east of the Cheetah and Bongo Habitats (See Figure 1: Project Location Map). The length of walkway to be replaced extends approximately 500 linear feet and varies in width from 5-feet to 15-feet. Excavation is anticipated to range from 4-inches to 10-inches below existing grade. In addition to replacing the walkway, this project proposes to replace/improve select existing site elements located along this section, including replacement of existing fencing, installation of new flagstone pavers in an area damaged by tree roots, and installation of bench seating. According to available records, the walkway in the Savanna area was constructed around 1992 and no active drainage structures within the project limits of disturbance were observed. Additionally, based on previous archaeological studies, the walkway is believed to be constructed on approximately 4-feet of modern fill and therefore unlikely to encounter archaeological finds. The appropriate best management practices and monitoring will be implemented as needed. Work is anticipated to occur in the Spring 2026 and take approximately 6 months to complete.	
		819 SOUTH BERETANIA STREET	Honolulu	96813	2-1-042: 015		1	819 SOUTH BERETANIA STREET – HPD SECURITY FENCE: Proposing to install approximately 311 linear feet of a new 8-foot high security fence within the 5-foot front yard setback fronting South Beretania Street and Hale Māka'i Street. The new fence will replace an existing construction chain-link fence which was installed during the demolition of the old structure at the property. The fence will be setback 6-inches from the property line as indicated on the enclosed plan sheet C-1. Two vehicle gates, 18-feet wide and 24-feet wide, will be installed at the existing driveway aprons along South Beretania Street. No other improvements are anticipated at this time. The purpose of the fence installation is to provide security for the vacant lot and to prevent unauthorized access. Work to install the security fence is anticipated to begin before summer of 2026 and should take about 2 weeks to complete.
