Project Summary:

The Department of Health (DOH) initiates Section 106, NHPA consultation with the State Historic Preservation Division (SHPD) pursuant to 36 CFR Part 800. The U.S. Environmental Protection Agency (EPA) delegated DOH to act on EPA's behalf, pursuant to 36 CFR §800.2(c)(4) when initiating a Section 106, NHPA process for projects funded under the Hawaii Drinking Water State Revolving Fund (DWSRF). Under the DWSRF, the DOH may provide funding to the County of Hawaii, Department of Water Supply (DWS) for the Waiaha Well B Project. The use of federal funds is considered an undertaking, as defined by Section 106 of the NHPA, 54 U.S.C. §306101 et seq., and 36 CFR Part 800. The proposed project includes plans to construct: (*i*) a second production well, (*ii*) a 700-gallon per minute pump, (*iii*) a new pump control and chlorination building; and (*iv*) a chain link security fence around these new facilities. These additions would be built within DWS' existing Waiaha Well and Reservoir facility (State Well No. 3857-004) and are intended to improve reliability in the North Kona Water System. The DOH anticipates requesting SHPD's concurrence with its project determination of *no historic properties affected*.
