Comfort Station at One'ula Beach Park

Pursuant to Hawai'i Revised Statutes (HRS) Chapter 343, the City and County of Honolulu, Department of Design and Construction (DDC), has determined that additional environmental review is not required for the proposed construction of a new comfort station with outdoor shower, located at One'ula Beach Park. The proposed new comfort station would be located outside of the certified shoreline setback area, south of Pāpipi Road and east of the existing paved parking lot. See Figure 1 – Proposed Site Plan.

A Final Environmental Assessment and Finding of No Significant Impact (FEA-FONSI) for the One'ula Beach Park Master Plan was published in The Environmental Notice on May 8, 2001. The FEA-FONSI assessed potential impacts associated with the development of the entire park parcel to support anticipated future recreational demands. Construction of this new comfort station with outdoor shower is a small portion of the development that was assessed in the FEA-FONSI and is to be located in a location similar to that which was assessed in the Master Plan.

Utility and infrastructure improvements anticipated to be required to support the new comfort station are consistent with the overall intent of impacts analyzed on the FEA-FONSI. Anticipated infrastructure improvements include new on-site water, sewer, and electrical systems.

The Hawai'i Administrative Rules (HAR) Section 11-200.1-11 provides the following as it relates to use of prior FONSI to satisfy HRS Chapter 343 Requirements:

- "(a) When an agency is considering whether a prior exemption, FONSI, or an accepted EIS satisfies chapter 343, HRS, for a proposed action, the agency may determine that additional environmental review is not required because:
 - (1) The proposed action was a component of, or is substantially similar to, an action that received an exemption, FONSI, or an accepted EIS (for example, a project that was analyzed in a program EIS);
 - (2) The proposed action is anticipated to have direct, indirect, and cumulative effects similar to those analyzed in a prior exemption, final EA, or accepted EIS: and
 - (3) In the case of a final EA or an accepted EIS, the proposed action was analyzed within the range of alternatives."

Based on the foregoing, the DDC has determined:

- 1. The scope of the proposed project is a component of and substantially similar to the actions described in the FEA-FONSI for the One'ula Beach Park Master Plan;
- 2. The proposed project is anticipated to have effects similar to those analyzed in the 2001 FEA; and
- 3. The environmental setting and probable impacts described in the 2001 FEA have not substantially changed.



This project proposes to construct a new comfort station with outdoor shower at One'ula Beach Park, south of Papipi Road and adjacent (east) of the existing paved parking lot, in a location similar to what was presented in the 2001 One'ula Beach Park Master Plan. The new comfort station is anticipated to be approximately 30'L x 12'W x 12'H with a surrounding ADA

compliant walkway. On-site utility and infrastructure upgrades to support the new comfort station with outdoor shower would also be implemented as required, including on-site water, sewer, and electrical improvements. Minimal to no changes to the existing roadway and paved parking areas are anticipated.

This new comfort station is needed to support park users and anticipated recreational activities.
