EIS for 'Ewa Oil Pipeline

Anticipating significant impacts to the environment, the State Department of Transportation is requiring Hawaiian Electric Company (HECO) to prepare an environmental impact statement (EIS) for its Waiau Fuel Pipeline Project to move fuel oil from the Barber's Point Tank Farm to HECO's Waiau Power Plant and ancillary facilities. The action involves the long-term committment of state-owned land through a lease in the State Energy Corridor and through granting of an easement in the former O'ahu Railway and Land Company Right-of-Way (a designated historic site)

Enrichment Camp at Former Hawai'i Kai Nike Missile Site

The Department of Land and Natural Resources is currently processing a conservation district use application from a private 501(c)(3) non-profit foundation to renovate four existing buildings on 3.5 acres at the former Nike Camp and Missile Site above Hawai'i Kai to house and produce enrichment programs for island teens, their parents and teachers. The private nonprofit plans to use monies raised from the community as well as volunteer labor. OEQC is recommending that the Office of Hazard Evaluation and Emergency Response of the Department of Health and the Department of Defense be consulted to determine whether the site is free from hazardous materials or residues thereof. Four alternatives (including no action) are discussed: (1) pipeline in the State Energy Corridor (preferred); (2) a new contract with Chevron to use the 8-inch black oil pipeline from Campbell Industrial Park to Waiau and then to Honolulu Marine Terminal at Pier 30; and (3) truck delivery. A discussion of the potential impacts of the project alternatives is included. Comments and requests to be a consulted party in the preparation of the draft EIS are due on November 7, 2001. See page 8 for more.

New Plans for Washington Place

The State is planning to restore and renovate Washington Place. This project will convert Washington Place, a former home of Queen Lili uokalani, into a museum and gallery. At the same time, the State will build new living quarters for future governors on an adjacent piece of land.

This plan recognizes that the Governor's mansion is an historic site worthy of restoration and development as a museum for public appreciation. The private upstairs living area of the governor's mansion would be converted into gallery and exhibit space to reflect the rich story of Queen Lili'uokalani and other occupants of the mansion. The 82-year tradition of official occupancy and state entertainments in the first floor state rooms will be maintained.

The State will build a new two-story governor's residence in the mauka-Waikiki portion of the lot at the rear of Washington Place. Two small structures on that portion of the parcel used for ground maintenance storage and general storage will be demolished. For more information, see page 6.

Definitions Your guide to the Environmental Review Process

Draft Environmental Assessment

A project or action that may affect the environment cannot be implemented until an Environmental Assessment (EA) is prepared in accordance with HRS §343. If the lead government agency anticipates that the project will have no significant environmental impact, then a Draft EA is written and public notice is published in this bulletin. The public has 30 days to comment on the Draft EA from the date of the first notice.

Final Environmental Assessment and FONSI (Negative Declaration)

If, after the lead agency reviews the public comments, it feels that the project will have no significant effect on the environment, then it will prepare a Final EA and issue a Finding of No Significant Impact (FONSI) formerly called a *Negative Declaration*. The Final EA must respond to all public comments. An Environmental Impact Statement will not be required and the project may now be implemented. The public has 30 days from the first notice of a FONSI in this Bulletin to sue in court to require the preparation of an EIS.

EIS Prep Notice

If the lead agency decides that a project may have a significant environmental impact, it must prepare an Environmental Impact Statement (EIS) prior to implementing the project. The first step in preparing an EIS is publishing an EIS Preparation Notice (Prep Notice) in this Bulletin. Agencies, groups or individuals have 30 days from the first publication of an EIS Prep Notice to request to become a consulted party and to make written comments regarding the environmental effects of the proposed action. The draft EIS must respond to these comments.

Draft EIS

If a project is likely to have a significant environmental impact, the lead agency or private applicant must prepare a

Draft Environmental Impact Statement (Draft EIS) prior to project implementation. This document must completely disclose the likely impacts of a project. Secondary and cumulative impacts must be discussed along with measures proposed to mitigate them. The public has 45 days from the first publication date in this Bulletin to comment on a Draft EIS.

Final EIS

After considering public comments filed during the Draft EIS stage, the agency or applicant must prepare a Final Environmental Impact Statement (Final EIS). The Final EIS must respond to all comments from the draft stage. If deeper analysis was required, it must be included in this document. If the project is from a private applicant, the lead agency is authorized to accept the FEIS. If the project is public, the Governor or Mayor is the accepting authority. Only after the EIS is accepted, may the project be implemented.

EIS Acceptance Notice

If the accepting authority accepts a Final Environmental Impact Statement, a separate EIS Acceptance Notice will be published in this Bulletin. The public has 60 days from the date of first notice of acceptance to sue in court to challenge the acceptance of an EIS.

NEPA

National Environmental Policy Act (NEPA) is the law that requires federal projects to prepare an EIS. It is similar to Hawaii's law. Some projects require both a state and federal EIS and the public comment procedure should be coordinated. Although not required by law, the OEQC publishes NEPA notices in this Bulletin to help keep the public informed of important actions.

Special Management Area Permits

The Special Management Area (SMA) is along the coastlines of all our islands. Most development in this area requires a Special Management Permit (SMP). The Counties regulate development

of this area. On Oahu, the County law requires an EA be prepared to accompany a permit application. This Bulletin posts notice of these SMP applications to encourage public input.

Shoreline Certifications

State law requires that Hawaii shorelines be surveyed and certified when necessary to clearly establish the regulatory building setback (usually 40 feet inland from the shoreline). The public may participate in the process to help assure accurate regulatory boundaries. Private land owners often petition to have their shoreline certified prior to construction. This Bulletin publishes notice of both shoreline certification applications and of final certifications or rejections.

Environmental Council

The Environmental Council is a fifteen-member citizen board appointed by the Governor to advise the State on environmental concerns. The council makes the rules that govern the Environmental Impact Statement process. The agendas of their regular meetings are published in this Bulletin and the public is invited to attend.

Exemption Lists

Government agencies must keep a list describing the minor activities they regularly perform that are declared exempt from the environmental review process. These lists are reviewed and approved by the Environmental Council. This Bulletin will publish an agency's draft exemption list for public comment prior to Council decision making.

Conservation District Permits

Use of land in the State Conservation District requires a Conservation District Use Application (CDUA). These applications are reviewed and approved by the Board of Land and Natural Resources (BLNR). Members of the public may intervene in the permit process. Notice of these permit applications is published in this Bulletin.



The proposed project involves improvements on a vacant property located in the State Conservation Land Use District. The lot is adjacent to the property owner's main residence. The improvements include: an expanded motor court turnaround area, a new residential addition, an artist's studio/gazebo, a recreational deck, landscaping, and fencing. The proposed improvements will occupy approximately 4,000 square-feet of the subject property.

The project site is located on Wilhelmina Rise on the eastern slopes of Palolo Valley on the Island of Oʻahu. Mr. David Haig, the applicant and landowner of the main residence immediately adjacent (8,140 sq. ft.), owns the project site (71,377 sq. ft.). The 1.6-acre vacant site is relatively steep with 15-40 percent slopes stretching down its 364-foot length. Several relatively level areas on the site exist however, providing potential locations for the proposed site improvements. It is nearly 450 linear feet to the nearest residences of Palolo Valley below the site.



The site improvements are intended to utilize buildable areas on the vacant slope and enhance the amenities of the existing main residence. It is intended that these improvements result in minimal impacts on the environment, surrounding neighbors, and down slope areas.

A Conservation District Use Application (CDUA) is needed to implement site improvements. Construction is anticipated to be completed by mid 2003.

Street Usage

The McCully-Mo'ili'ili Beautification Master Plan completed in June 2001, identifies proposed beautification improvements for the McCully-Mo'ili'ili neighborhood recommended by the community. The plan serves as a guide to allocate funds for the implementation of improvements that will improve the overall aesthetic quality of the McCully-Mo'ili'ili community.

The McCully-Moʻiliʻili Beautification Master Plan draft environmental assessment covers the top priority projects identified by the Manoa/McCully-Moʻiliʻili/Makiki Vision Team. Although more than 68 projects were initially identified, the Vision Team identified 10 projects as their top priority, three of which are scheduled to be implemented in FYs 2001/2002. The EA is limited to the top projects because

these are the projects most likely to be implemented and are the furthest along in the planning and design process. The other 56 projects remain on the community's wish list of improvements but have no scheduled implementation date or funding.

Proposed improvements include street trees, planting strips, irrigation, curbs, gutters, sidewalks, driveway aprons, and storm drainage, at various locations within the McCully-Moʻiliʻili neighborhood. Not all improvements are proposed for all locations. Limited traffic calming measures are also proposed for portions of Citron Street, Kapaʻakea Street, and Hausten Street, and Coyne Street.

The three projects scheduled to be implemented in FYs 2001/2002 are:

- * The Kapi'olani Boulevard Beautification Project, which will provide street trees, planting strips, irrigation, curbs, gutters, sidewalks, driveway aprons, and storm drainage, on the Diamond Head side of Kapi'olani Boulevard from Date Street to Mahi'ai Street.
- * The Washington Middle School Beautification Project, which will provide street beautification and improvements including sidewalks, curbs, gutters, landscaping, and irrigation in the vicinity of Washington Middle School.
- * The Lunalilo Tract Street Tree Planting Project, which will establish a street tree program and a plan for the planting of street trees in the Lunalilo section of McCully-Moʻiliʻili neighborhood.

Short-term impacts from the proposed improvements include impacts to air, noise, and traffic due to construction. Long-term impacts are expected to be positive as street trees will help clean the air, lower temperatures, and increase the overall aesthetic appeal of the area. In addition, curbs, gutters, and drainage basins will reduce flooding, and sidewalks will enhance pedestrian safety.

The proposed improvements are intended to upgrade the container handling facilities along Pier 51-A to better serve the public.

Container handling facilities are an integral part of the shipping industry in Hawai'i. Approximately 80% of all products (energy, food, and goods) must be shipped from the mainland United States or other overseas countries. Improvements to these facilities represent better service to the residents of Hawai'i.

The proposed project involves the construction of a new driveway access and parking lot for the Stevedores at Sand Island, Honolulu Harbor, Oʻahu. The work includes demolition and removal, embankment, grading and compaction, rock riprap, asphalt concrete pavement, concrete curb, metal guard rail, chain link fence and gate, drainage pipe culvert, adjustment of an existing 16-inch waterline, signage and pavement marking and striping.

An application has been submitted to the State of Hawai'i Department of Land and Natural Resources (DLNR) for land use in the State Land Use Conversation District. When awarded, Winners' Camp 501(c)(3) non-profit foundation will renovate the four existing buildings on said property. The land and buildings will be used to house and produce enrichment programs for island teens, their parents and their teachers.

The proposed "Winners' Camp Kamehame Ridge" will be remodeled on 3.5 acres located in the general sub-zone of the conservation district, the former Nike Camp, and missile site above Hawai'i Kai. This camp site is comprised of four existing buildings totaling approximately fifteen thousand square feet under roof. Three of these buildings were the camps' sleeping quarters and one building was the former kitchen and eating area.

The site has been used as a campsite since 1962. It has buildings designed as perfect sleeping quarters and has two completely plumbed kitchens and four communal bathrooms as well as two semi-private bathrooms. The existing placement of the buildings, size of the site, and remote and safe location is a perfect fit for Winners' Camp. Access does not adversely affect the homeowners as all staff, youth participants and parents are transported in passenger vans to the site. The staff stays on site for ten days and the students remain for seven days consecutively during each camping period. The Hawai'i Kai Neighborhood Board approved the use of the site.

Wastewater Discharge

The City and County of Honolulu, Department of Environmental Services, Collection System Maintenance Division is doing high maintenance on the sewer lines along portions of Magazine Street, Prospect Street, Spencer Street, Victoria Street, Thurston Avenue, and Wilder Avenue in the Makiki area. The project has sewer lines that are experiencing backup problems due to roots, grease, and other debris. The City proposes to reconstruct and rehabilitate approximately 4,200 linear feet of 6-inch diameter vitrified clay pipe using a combination of pipe bursting, CIPP, and in-line trenching. Portland cement and epoxy coating is recommended for rehabilitation of the 22 existing sewer manholes. Capacity will also be increased to meet future peak wastewater flows.

This assessment evaluates the redevelopment of the Stadium Bowl-O-Drome property from its current bowling alley use to various alternative forms of commercial development. The property is located at 820 Isenberg Street in Honolulu, Hawai'i, and is under the jurisdiction of the Department of Hawaiian Home Lands. Three commercial development alternatives are being considered and presented as representative commercial projects that could occur on the site: (1) Office Building Complex at 30% Maximum Density Development; (2) Office/Commercial Complex at 30% Maximum Density Development; and (3) Office/Commercial Complex at Maximum Density Development.



The proposed project is expanding existing Kama'ole III Park located in Kihei, Maui, Hawai'i. The 5.35 acre parcel lies between the existing Kama'ole Beach Park III on the north, South Kihei Road on the east, the Kihei Boat Ramp on the south and ocean on the west. The parcel has been designated as Lot 1 of the Kihei Boat Launching Ramp Subdivision. This project consists of constructing a parking lot with approximately 50 stalls including accessible parking stalls, comfort station, outdoor shower, landscaping and irrigation. The County of Maui Department of Water Supply proposes to construct modifications at its existing water treatment facility in Lahaina, Maui. The landowner of the affected property is the State of Hawai'i. This project may be funded by Federal Funds through the State of Hawai'i's Drinking Water State Revolving Fund (DWSRF) program, which would constitute a federal action, and will require the project to meet all Hawai'i DWSRF program requirements.

The proposed modifications include construction of a pre-engineered structure over an existing presedimentation basin and construction of a new sludge lagoon. The purpose of the pre-engineered structure is to curtail algae growth in the presedimentation basin by reducing exposure of the water to sunlight. The new sludge lagoon is proposed to handle overflow and drain line discharges from the existing presedimentation basin.

In the short-term, the proposed modifications may create temporary minor nuisances with respect to vehicle traffic, noise, air quality, and wildlife. Construction vehicles will require access to the site through the Lahainaluna High School campus. Vehicle traffic will be regulated to minimize impacts to the school.

Hawaiian geese (Nene) have been known to nest in the area of the treatment plant. To minimize disturbances to the Nene, construction personnel will be educated on appropriate measures to take if Nene are sighted in the area during construction. The proposed modifications are not anticipated to result in any long-term or cumulative adverse environmental impacts. Construction of the new facilities will not prevent future use of the site by Nene for nesting.

Dewatered sludge generated at the new sludge lagoon should not contain hazardous or toxic chemicals and will be disposed of at a landfill along with other sludge generated at the facility. The new sludge lagoon will prevent further discharges from the existing presedimentation basin to the storm drain which discharges to Kanaha Stream. Elimination of discharges to Kanaha Stream will have a beneficial impact on the water quality of the stream.





The Department of Water (DOW) Kilauea Booster Pump Station (BPS) project will be located within a portion of the parcel designated as TMK: 5-2-21:22, makai of Kuhio Highway. The east side of this parcel is currently being used as a cemetery. However, the BPS site is in a portion of the parcel, on the west side, that is removed from areas that have been used for burials.

The project involves the construction of a duplex pump system to increase the water pressure within the waterline in Kuhio Highway for the benefit of the entire eastern part of the Kilauea Water System, and will operate in conjunction with the recently constructed Pu'u Pane Reservoir.

The project will include the installation of two prefabricated fiberglass building type enclosures on a common concrete slab and associated piping and electrical components. Other components would be an antenna mounted on a 17' 6" high pole for transmission of radio waves to the



DOW's SCADA control center for remote monitoring and operation of the pumps. A hedge of native hibiscus would be planted just outside of the fence.

Two 8" waterlines would also be installed to the BPS from connection points to the existing waterline within Kuhio Highway. No improvements will be made to the existing coral road that will provide access to the BPS from Kuhio Highway except for a short section between the edge of this road and the entrance gate to the BPS site, which will be paved with asphalt concrete pavement.

The Hawai'i Army National Guard (HIARNG) proposes to implement the Integrated Natural Resources Management Plan (INRMP) on four training areas and facilities throughout approximately 630 acres.

The INRMP covers the planning period from fiscal year 2002 (FY02) through FY06, beginning October 1, 2001 and ending September 30, 2006. The INRMP is an overall ecosystem master plan that provides a framework for managing natural resources (in accordance with legal requirements) in order to maximize the capability of military lands to conduct mission-essential training. It provides a single point of reference for environmental issues for HIARNG land managers and military trainers.

The sites included are the 503-acre Keaukaha Military Reservation (KMR) on the island of Hawai'i; the 68-acre Kekaha Firing Range on Kaua'i; the 39-acre Ukumehame Firing Range on Maui; and the Waiawa Gulch Armory (19 acres) on O'ahu.

Implementation of the INRMP would involve the phased completion of numerous individual projects (endangered species management, invasive species control, native ecosystem rehabilitation, Geographic Information Systems and monitoring) over five years, as part of the programs addressed in the plan.

Supplemental Draft EIS for Primary Transportation Corridor

The Federal Transit Administration (FTA) and Federal Highway Administration (FHWA), in cooperation with the City and County of Honolulu Department of Transportation Services (DTS), will prepare a supplemental draft environmental impact statement (SDEIS) in accordance with the National Environmental Policy Act (NEPA) for proposed transportation improvements in the Primary Transportation Corridor of the City and County of Honolulu. The SDEIS will address the following proposed changes to the Bus Rapid Transit (BRT) Alternative selected as the Locally Preferred Alternative (LPA) by the Honolulu City Council on November 29, 2000: addition of an In-Town BRT branch to serve Aloha Tower Marketplace and Kakaako Makai; realignment of a section of the In-Town BRT alignment from Ward Avenue to Pensacola Street; change the location of the H-1 BRT ramp from the Kaonohi Street overpass to a section of the freeway near Aloha Stadium. The DTS is proposing transportation improvements in O'ahu's primary transportation corridor. The primary transportation corridor extends from Kapolei in the 'Ewa District, past Pearl Harbor, Honolulu International Airport, downtown Honolulu, and continues eastward to the University of Hawai'i at Manoa and Waikiki. The proposed action is intended to address existing and future transportation demand and capacity needs, support socioeconomic growth, improve public transit services, facilitate land use development, and support current planning activities and policies.

In August 2000, the Primary Corridor Transportation Project Major Investment Study/Draft Environmental Impact Statement (MIS/DEIS) was distributed for public review and comment. It should be noted that the MIS/DEIS Notice of Intent was published in the April 27, 1999 Federal Register and the notice of the availability of the MIS/DEIS for review and comment was published in the September 8, 2000 Federal Register. On November 29, 2000, the Honolulu City Council selected the BRT Alternative as the Locally Preferred Alternative (LPA).

The SDEIS is not intended to repeat all the analyses contained in the project's MIS/DEIS. Most analyses would be limited to the immediate study area of the Kakaako Makai branch, Pensacola Street alignment change, and Aloha Stadium ramp. System-level impacts (i.e., impacts of the entire BRT Alternative) would be discussed in the SDEIS, if the proposed changes would alter the results of any analysis provided in the MIS/DEIS. Letters describing the proposed action and soliciting comments have been sent to appropriate Federal, State, and local agencies, and to private organizations and citizens who have previously expressed or are known to have interest in this proposal. To ensure that the full range of issues related to this proposed action are addressed and all significant issues identified, comments and suggestions are invited from all interested parties.
