The proposed project includes improvements to the intersection of Bayfront Highway (Route 19) and Waianuenue Avenue (Route 1950) to enhance multimodal connectivity and address ongoing concerns involving poor vehicular maneuverability, restricted access to the downtown Hilo area, pedestrian safety concerns, and overall congestion of roadways in the vicinity. A preferred alternative has been identified which includes reconstruction of roadways to allow for construction of an intersection single-lane roundabout, ADA compliant sidewalks and roadway crossings, drainage improvements, reconfiguration of parking, and other roadway improvements including new highway lighting, electrical infrastructure relocations, signage, pavement markings, pedestrian signals, raised crosswalks, landscape, and traffic management devices, and other utility adjustments as required. To minimize traffic impacts during construction, the project will include both day and night work.

The Hawai'i State Public Library System (HSPLS) proposes a new 13,900 SF public library on a 1.7-acre site in Kea'au, adjacent to the Kea'au Middle School. The site is owned by the State of Hawai'i.

The Kea'au-Mountain View Public Library is one of two new libraries proposed in the Puna District to replace three outdated public and school libraries co-located within school campuses. The main library space will be a flexible open area with modular furnishings that can be reconfigured as needs change. A community meeting room is provided for special functions during or after library hours, and opens to a lanai for indoor-outdoor functions. Staff areas include offices, workspace, storage, and space for Friends of the Library. Two one-way driveways will provide access to the 42-stall parking lot. Accessible walkways will connect the library to the public sidewalk and the middle school.

The U.S. Department of the Interior, U.S. Geological Survey (USGS) proposes a new research facility on 6.8 acres of State-owned land at Komohana Street and Nowelo Road in Hilo. The project provides a replacement facility for the Hawaiian Volcano Observatory (HVO) whose existing facilities in Hawai'i Volcanoes National Park were irreparably damaged by the 2018 Kilauea volcano eruption. The facility will also accommodate the Pacific Islands Ecosystem Research Center (PIERC), currently located in Hawai'i Volcanoes National Park.

The project site is near the University of Hawai'i at Hilo campus and other federal research institutions. This location allows HVO and PIERC to work collaboratively with university faculty and students and strengthen academic and research partnerships. The site is part of a larger parcel granted to the University of Hawai'i by Executive Order 3814 in 2000. The UH Hilo fully supports the project and will execute a Use and Occupancy Agreement with USGS. A related NEPA FONSI is available here.

The County of Maui, Department of Environmental Management (DEM), Wastewater Reclamation Division (WWRD) is proposing to upgrade the North Kīhei Wastewater Collection and Transmission System. The system and certain elements of it are reaching their capacity limits and lack the capacity necessary to convey planned future wastewater flows from new development in its service area. The proposed project will include replacing the gravity sewerline to WWPS No. 3, replacing the gravity sewerlines to WWPS No. 4, a new force main starting at WWPS No. 4 that heads south on South Kīhei Road, turns east on Pi'ikea Avenue, turns south on Liloa Drive, and transitions to a gravity sewerline for 500 feet (ft.) until it reaches the proposed new WWPS near the Kīhei Aquatic Center, and a second new force main that heads south on Liloa Drive and continues on to the Kīhei Wastewater Reclamation Facility (WWRF). The proposed project will also involve upgrading WWPS Nos. 2, 3, 4, and 5.

The State of Hawai'i Department of Hawaiian Home Lands proposes to construct infrastructure improvements in support of the Nā'iwa Agricultural Subdivision project located within the Ho'olehua region on the island of Moloka'i, Hawai'i. EXEMPTION DECLARATION

The University of Hawai'i has declared the following action exempt from the requirement to prepare an EA, pursuant to HAR § 11-200.1-16, and has voluntarily submitted it for publication:

Packaged Air Conditioning Unit Replacement at the Submillimeter Array (SMA) on Maunakea, Hawai'i Island

The action involves three exterior modifications to replace or upgrade components of a nearly-25 year old air conditioning and ventilation system which support SMA's operations: (a) The main packaged AC unit will be replaced; (b) Three auxiliary condensing units will be replaced by two units; and (c) air intake ducts on the building wall will be modified. These components are near the end of their service lifetimes and require increasing maintenance and repair. The replacement units will be functionally and visually similar to the existing units. Most of the work will be confined to the hangar. except for the replacement P ACU which rests on a concrete slab adjacent to the hangar. There will be no change to the developed footprint, expansion of use, or impacts to identified resources.

Air Tour Management Plan for Haleakalā National Park, Maui

The Federal Aviation Administration and National Park Service propose to implement an air tour management plan (ATMP) for Haleakalā National Park (Park) pursuant to the National Parks Air Tour Management Act of 2000 (the Act) which was signed into law on April 5, 2000. The ATMP applies to all commercial air tours over the Park and commercial air tours within ½ mile outside the boundary of the Park. A commercial air tour subject to this ATMP is any flight, conducted for compensation or hire in a powered aircraft where a purpose of the flight is sightseeing over the Park, or within ½ mile of the Park boundary, during which the aircraft flies: (1) below 5,000 feet above the ground level (except solely for the purposes of takeoff or landing, or necessary for safe operation of an aircraft as determined under the rules and regulations of the FAA requiring the pilot-in-command to take action to ensure the safe operation of the aircraft); or (2) less than one mile laterally from any geographic feature within the Park (unless more than ½-mile outside the Park boundary).

The objective of the ATMP is to develop acceptable and effective measures to mitigate or prevent significant adverse impacts, if any, of commercial air tour operations on the Park's natural and cultural landscapes and resources, areas of historic and spiritual significance to Native Hawaiians, Wilderness character, and visitor experience. An ATMP describes conditions for the conduct of air tour operations over a park, including routes, altitudes, time-of-day restrictions, restrictions for particular events, maximum numbers of flights, or other provisions. Removal and Replacement of Park Maintenance Facilities at Pu'uhonua o Honaunau National Historic Park

Proposed Action: National Park Service proposes to remove existing maintenance facilities near the shoreline and construct new facilities and storage within the Puuhonua o Honaunau National Historic Park (Park) upland in areas where flooding and storm surge impacts are not expected to occur. During demolition of the existing maintenance facilities, visitors will be restricted from construction area within the Park but not be limited to shoreline access. Once the facilities are moved to an upland site, recreation in the area may include additional interpretation of cultural and historical resources for visitors of the Park.

The new construction includes a Resource Management building (approximately 5,500 square feet (sf)), Maintenance facility (approximately 4,200 sf), Storage building (approximately 600 sf), covered fleet vehicle parking (approximately 3,600 sf), and Storage/employee parking/vehicle wash area (approximately 9,400 sf). To avoid or minimize impacts to known archaeological features and to the existing landscape, these new buildings are planned for areas previously graded and disturbed. Exterior motion sensor lighting is proposed at all entry points and vulnerable perimeter points to deter vandalism and theft.

ENVIRONMENTAL ADVISORY COUNCIL ANNOUNCEMENT

The State of Hawai'i has partnered with the U.S. Fish and Wildlife Service to increase awareness about the U.S. Fish and Wildlife Service's (USFWS) Information for Planning and Consultation (IPaC) online tool and how it fits into the Section 7 consultation process under the Endangered Species Act of 1973, as amended (ESA).

Through the Office of Planning and Sustainable Development, Environmental Advisory Council's Information & Outreach Committee, the public can <u>participate in an online meeting</u> on Thursday, June 1 from 9:00 to 10:30 AM HST to learn how to incorporate the IPaC online tool into their project planning process. Topics covered will include when and how to create an Official Species List, how to navigate the features in the IPaC online tool, and what to do with the Official Species List once obtained. The IPaC online tool is now required for all consultations under Section 7 the Endangered Species Act of 1973, as amended.

The IPaC online tool also provides Official Species Lists for coordination with the USFWS under the Fish and Wildlife Coordination Act and can assist project proponents by providing a list of birds protected under the Migratory Bird Treaty Act that may occur within a project's action area. The presenters will also share the USFWS's vision for IPaC and future features under development. Carrie Harrington, endangered species biologist with the USFWS, Pacific Islands Fish and Wildlife Office is presenting in collaboration with Chelby Kilheffer, Endangered Species Biologist, and Victoria Foster, National IPaC Program Coordinator, from the USFWS's Headquarters (HQ) IPaC Team in Washington DC. The Navy proposes to construct and operate a modified Type III aircraft hangar at Marine Corps Base Hawaii (MCBH), with an aircraft apron and other supporting infrastructure modifications, to support the Fleet Logistics Squadron 51 (VR-51) C-40A aircraft maintenance and operations. The environmental assessment analyzes two action alternatives and the No Action Alternative. Both action alternative sites (Hangar 104 Site and Green Field Site) are located on MCBH within the airfield area. Under the Hangar 104 Site alternative, existing Hangar 104 would be demolished and a Type III hangar would be constructed within its footprint. Under the Green Field Site Alternative, a Type III hangar would be constructed on a semi-vacant parcel bounded by Mokapu Road and the Marine Corps Air Station (MCAS) Terminal. The Navy is working with SHPO and consulting partners to develop a Memorandum of Agreement (MOA) to resolve adverse effects the Hangar 104 Alternative. Environmental effects of the Proposed Action would have less than significant effects as described in Section 3 of the draft EA. The Navy will implement several Best Management Practices and conservation measures to reduce environmental effects. Development of a MOA with SHPO would resolve adverse effects to historic properties.

This rule is effective on June 12, 2023.

The FAA, in cooperation with the National Park Service (NPS), has initiated development of ATMPs for Haleakalā National Park, Hawai'i Volcanoes National Park, Mount Rushmore National Memorial, and Badlands National Park (collectively referred to as the Parks) pursuant to the National Parks Air Tour Management Act of 2000 and its implementing regulations. This notice announces the public availability of the draft ATMPs and draft EAs for comment and the dates of the public meetings for each of the Parks. The purpose of the public meetings is to review the draft ATMPs with the public. The draft ATMPs provide acceptable and effective measures to mitigate or prevent the significant adverse impacts, if any, of commercial air tour operations upon the Parks' natural and cultural resources and visitor experiences, as well as on tribal lands. In accordance with section 106 of the National Historic Preservation Act, the FAA and the NPS are also seeking public comment on the potential of the draft ATMPs to cause adverse effects to historic properties.

For Haleakalā and Hawai'i Volcanoes National Parks, virtual public meetings will be held on May 25 and June 7, 2023, respectively. GLOSSARY OF TERMS AND DEFINITIONS

Agency Actions

Projects or programs proposed by any department, office, board, or commission of the state or county government which is part of the executive branch of that government per <u>HRS 343-2</u>.

Applicant Actions

Projects or programs proposed by any person who, pursuant to statute, ordinance, or rule, requests approval for a proposed action per <u>HRS 343-2</u>.

Draft Environmental Assessment

When an Agency or Applicant proposes an action that triggers HRS 343, an Environmental Assessment shall be prepared at the earliest practicable time to determine whether the action's environmental impact will be significant, and thus whether an environmental impact statement shall be required per HRS 343-5(b), for Agency actions and HRS 343-5(e), for Applicant actions. For actions for which the proposing or approving agency anticipates a Finding of No Significant Impact (AFNSI), a Draft EA (DEA) shall be made available for public review and comment for 30 days and public notice is published in this periodic bulletin.

Final Environmental Assessment and Finding of No Significant Impact

The action's proponent shall respond in writing to comments on a DEA received during the 30-day review period and prepare a Final EA (FEA) that includes those responses to determine whether an environmental impact statement shall be required. If there are no significant impacts, then the Agency will issue a Finding of No Significant Impact (FONSI). An Environmental Impact Statement (EIS) will not be required and the project has cleared HRS 343 requirements. The public has 30 days from the notice of a FONSI in this bulletin to challenge the FONSI in the Environmental Court and seek a ruling to require the preparation of an EIS.

Final Environmental Assessment and Environmental Impact Statement Preparation Notice

An EIS shall be required if the Agency finds that the proposed action may have a significant effect on the environment. The Agency shall file notice of such determination with OPSD called an EIS Preparation Notice (EISPN) along with the supporting Final EA. After the notice of the FEA-EISPN is published in this bulletin, the public has 30 days to request to become a consulted party and to make written comments. The public (including the Applicant) has 60 days from the notice of the EISPN in this bulletin to ask a court to not require the preparation of an EIS.

Act 172-2012, Direct-to-EIS, Environmental Impact Statement Preparation Notice (with no EA)

Act 172 in 2012 amended HRS 343 by providing for an agency to bypass the preparation of an environmental assessment for various actions that in the experience of the agency would clearly require the preparation of an EIS. The agency must submit its determination that an EIS is required for an action (Act 172-2012, EISPN) with a completed publication form detailing the specifics of the action. This starts a 30-day scoping period in which the agency or applicant must hold a public scoping meeting for the preparation of the Draft EIS. Written comments and responses on the EISPN must be incorporated into the subsequent Draft EIS and oral comments from the public scoping meeting must be recorded and submitted to OPSD with the Draft EIS.

HEPA

While technically there is no "Hawai'i Environmental Policy Act," HRS 343 is often referred to by this term.

Act 312-2012, Secondary Actions in the Highway or Public Right Of Way

Act 312-2012, amended HRS 343, by adding a new section (HRS 343-5.5., entitled "Exception to applicability of chapter"). HEPA allows for a statutory exception for "secondary actions" (those that involve infrastructure in the highway or public right-of-way) provided that the permit or approval of the related "primary action" (those outside of the highway or public-right-of-way and on private property) is not subject to discretionary consent and further provided that the applicant for the primary action submits documentation from the appropriate agency confirming that no further discretional approvals are required. An aid to understanding this is to visualize residential driveway improvements in the public right-of-way.

Draft Environmental Impact Statement

After receiving the comments on the EISPN, the Agency or Applicant must prepare a Draft Environmental Impact Statement (DEIS). The content requirements of the DEIS shall contain an explanation of the environmental consequences of the proposed action including the direct, indirect and cumulative impacts and their mitigation measures. The public has 45 days from the first publication date in this bulletin to comment on a DEIS.

Final Environmental Impact Statement

After considering all public comments filed during the DEIS stage, the Agency or Applicant must prepare a Final EIS (FEIS). The FEIS must respond in a point-by-point manner to all comments from the draft and must be included in the FEIS. For Applicant projects, the Approving Agency is the Accepting Authority and must make a determination within 30 days or the FEIS is deemed accepted as a matter of law. For an Agency project, the Governor or the Mayor (or their designated representative) is the Accepting Authority, and unlike applicant actions, there is no time limit on the accepting authority reviewing the FEIS. Only after the FEIS is accepted may the project be implemented.

Acceptability

The Accepting Authority must be satisified that the FEIS meets three criteria (process, content, response to comments) to accept it. Whether the FEIS is accepted or not accepted, notice of the Acceptance Determination is published in this bulletin. The public has 60 days from publication to legally challenge the acceptance of a FEIS. For both Applicant and Agency actions, the Applicant or the proposing Agency can prepare a Revised DEIS after a non-acceptance determination.

National Environmental Policy Act

The National Environmental Policy Act (NEPA) requires federal projects to prepare a Federal EA or EIS. In many ways it is similar to Hawai'i's law. Some projects require both a State and Federal EIS and the public comment procedure should be coordinated. Upon request by a federal agency, OPSD publishes NEPA notices in this bulletin to help keep the public informed of important federal actions.

Conservation District

Proposed uses of land in the State Conservation District require a Conservation District Use Application (CDUA). These applications are reviewed and approved/denied by the Department or Board of Land and Natural Resources. Members of the public may intervene in the permit process. This bulletin will include EAs & EISs for actions proposed within the Conservation District.

Special Management Area and Shoreline Setback Area

The Special Management Area (SMA) is along the coast-line of all islands; development in this area is generally regulated by HRS 205A, and county ordinance. A portion of the SMA that is addressed by HRS 343 is the Shoreline Area, which includes land between the State-certified shoreline and the county-determined shoreline setback line. This bulletin will include EAs & EISs for actions proposed within the Shoreline Setback Area. Some projects going through the SMA permit process on O'ahu are also required to go through an environmental review process that mirrors HRS 343; these "ROH Chapter 25" EAs/EISs are included in this bulletin.

Shoreline Certifications

State law requires that Hawai'i shorelines be surveyed and certified when necessary to clearly establish the shoreline setback from the certified shoreline. The public may participate in the process to help assure accurate regulatory boundaries. Private land owners often petition to have their shoreline certified by the State surveyor prior to construction. This bulletin publishes notice from the Department of Land and Natural Resources of shoreline certification applicants and final certifications or rejections.

Environmental Advisory Council

The Environmental Advisory Council is a 15-member citizen board appointed by the Governor. They serve as a liaison between the Director of OPSD and the general public concerning ecology and environmental quality. Agendas of their regular meetings are posted on the Internet and the public is invited to attend.

Agency Exemption Lists

Government agencies may keep a list describing the minor activities they regularly perform that are exempt from the environmental review process. These lists and any amendments shall be submitted to the Council for review and concurrence (HAR 11-200.1-16). This bulletin will publish an agency's draft exemption list for public comment prior to Council decision making, as well as notice of the Council's decision on the list.

Endangered Species

This bulletin is required by HRS 343-3(c), to publish notice of public comment periods or public hearings for Habitat Conservation Plans (HCP), Safe Harbor Agreements (SHA), or Incidental Take Licenses (ITL) under the federal Endangered Species Act, as well as availability for public inspection of a proposed HCP or SHA, or a proposed ITL (as a part of an HCP or SHA).
