### MAUI WILDFIRE RESPONSE

DBEDT, its core divisions, and attached agencies have been working with federal, state, county, and community partners to support wildfire relief efforts on Maui.

### Economic Recovery

- DBEDT launched the <u>"Pathways to Recovery"</u> webinar series to provide updates about Maui relief and recovery efforts including housing, consumer protection, and small business recovery.
- READ created a <u>Maui Wildfires Economic Update</u> webpage to provide weekly updates on domestic daily passenger counts, flight and air seat capacity, air booking trends, unemployment data, and more.

#### Housing

- DBEDT Director James Kunane Tokioka and Luke Meyers, Disaster Management Coordinator in the Office of the Governor were tapped to lead the Joint Housing Task Force to relocate more than 5,000 survivors of the Lahaina fire from evacuation shelters into West Maui hotels and timeshare units in partnership with the hospitality industry, the American Red Cross, the Hawai'i Emergency Management Agency (HI-EMA), and the Federal Emergency Management Agency (FEMA).
- The Hawai'i Housing Finance and Development Corporation (HHFDC) launched the Hawai'i Fire Relief Housing Program to connect those in urgent need of housing with homeowners willing to assist by offering unoccupied houses, units, or rooms on a temporary basis. To date, over 500 families have been placed into housing through this program.

#### Tourism

- The Hawai'i Tourism Authority (HTA) activated the
  Department Operations Center at the Hawai'i Convention Center
  on August 8, 2023.
- Airlines and ground transportation companies were coordinated to help get visitors out of West Maui.
- An Assistance Center at the Hawai'i Convention Center was opened in partnership with the American Red Cross to provide housing and aid to displaced Maui residents and visitors.
- The HTA board approved additional visitor education and marketing resources to recover travel demand to Maui, centered around a new Mālama Maui campaign.

Rebuilding Lahaina will be a long-term process. DBEDT will continue working with the people of Lahaina and other government agencies at the federal, state, and county levels, as well as with private organizations, to provide help to Maui residents and businesses during this difficult time.


# Hawai'i-Japan Sister Summit July 27-28, 2023
