### An Ecological Approach to MP #1

#### *Ecosystem Effects of Sea Level Risk Application*

He studied Marine Science at the University of Hawai'i at Hilo and worked in the visitor industry as a tour boat Captain prior to joining the Conservancy's marine team. He coordinates multiple projects, partnerships, and networks focused on empowering communities to maintain and improve the health of coastal and marine life.

#### *Integrated Water Resource Management Planning*



Lauren Roth Venu is the Founding Principal and President of Roth Ecological Design Intl. She is passionate about developing strategic, innovative solutions to build water resiliency and restore ecological services. Her role is to work within an integrated, collaborative process to provide planning, design, and policy development solutions for her clients to achieve these goals. Following her passion for water security development, she recently founded 3Rwater LLC that is developing mobile applications for learners of all ages to find opportunities to reduce, reuse, and recharge water to promote the sustainable use of our water resources. She is also actively engaged in water policy development within Hawaii and has served on a variety of committees over the last decade for the state, city and county of Honolulu, and non-profit groups to support water resiliency measures.

This month we are examining MP 1 through an eco-lense. Coastal development must be considered in the context of current and future environmental conditions in order to be sustainable. A systems-thinking approach to ecosystem management is an integral part of the planning process.

Our September presenters will focus on two examples of ecological considerations for appropriate coastal development by highlighting the issues of ecosystem change and resource allocation.
