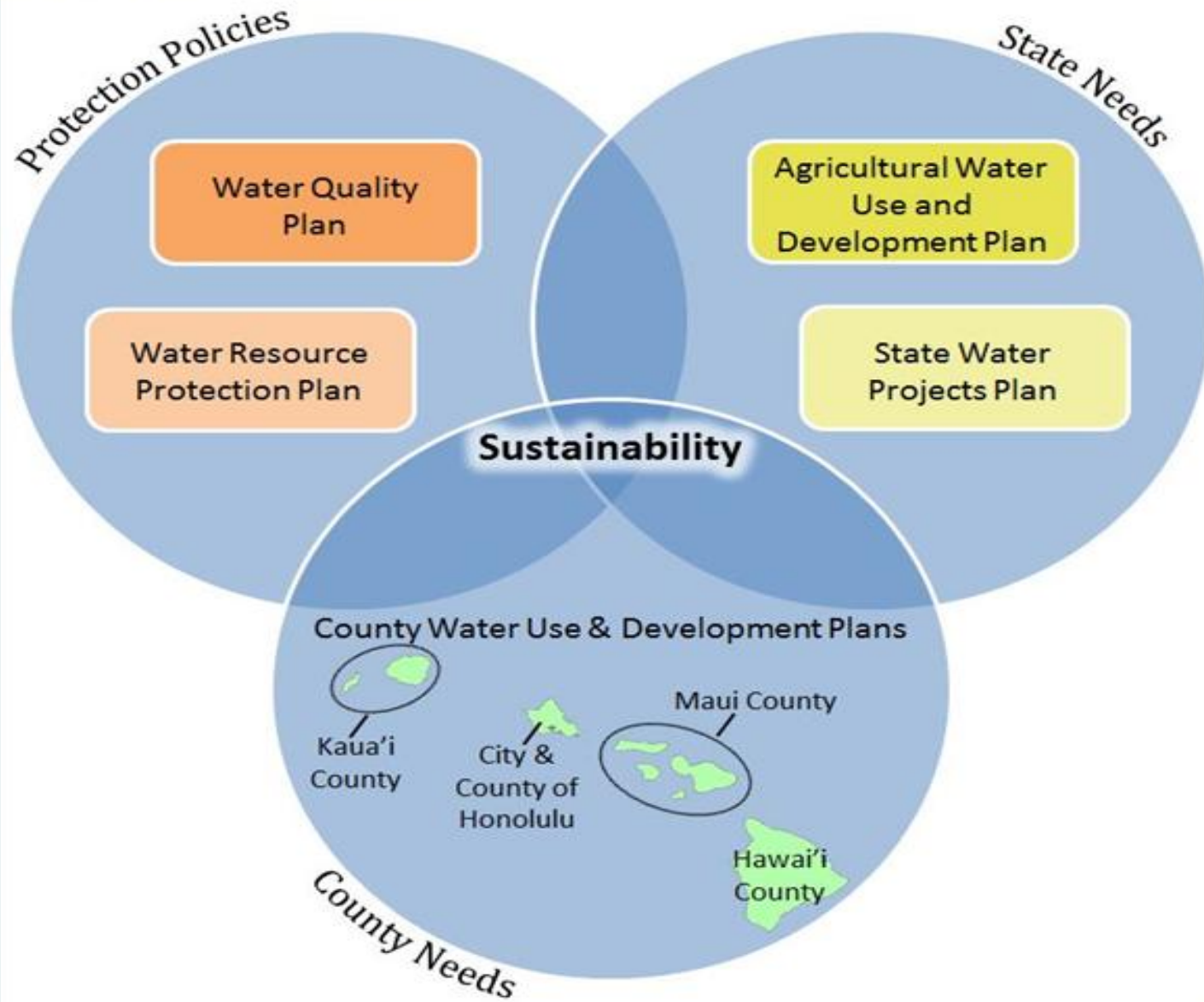

DOH – Water Quality Plan

- **DOH is responsible for the preparation of the Water Quality Plan (WQP). The WQP outlines the regulations, standards, and resource management policies that define the quality to be maintained in ground- and surface-water resources, such as:**
 - 1. Federal/state/county goals, objectives, and policies related to water quality.**
 - 2. Water quality criteria for designation of water management areas.**
 - 3. Water quality standards, monitoring requirements and enforcement provisions.**
 - 4. The identification of any substances which DOH reasonably believes may present a danger to the water quality of the state.**
