Introduction

HAWAII COASTAL ZONE MANAGEMENT PROGRAM

The **Hawaii Coastal Zone Management (CZM) Program** is responsible for managing the State's coastal areas and resources. The Hawaii CZM Act of 1977 created a basis for a network of authorities, statutes, ordinances, rules, and regulations (legal authorities), to achieve and implement the objectives and policies of the Hawaii CZM Program to **preserve, protect, develop, and where possible, to restore or enhance the resources of the Hawaii coastal zone**. The coastal zone management area means all lands of the State and the area extending seaward from the shoreline to the limit of the State's police power and management authority (HRS § 205A-1). Hawaii CZM objectives and their subsequent policies set forth in HRS § 205A-2 are carried out through the various state and county authorities of the CZM management network.

A NETWORK PROGRAM

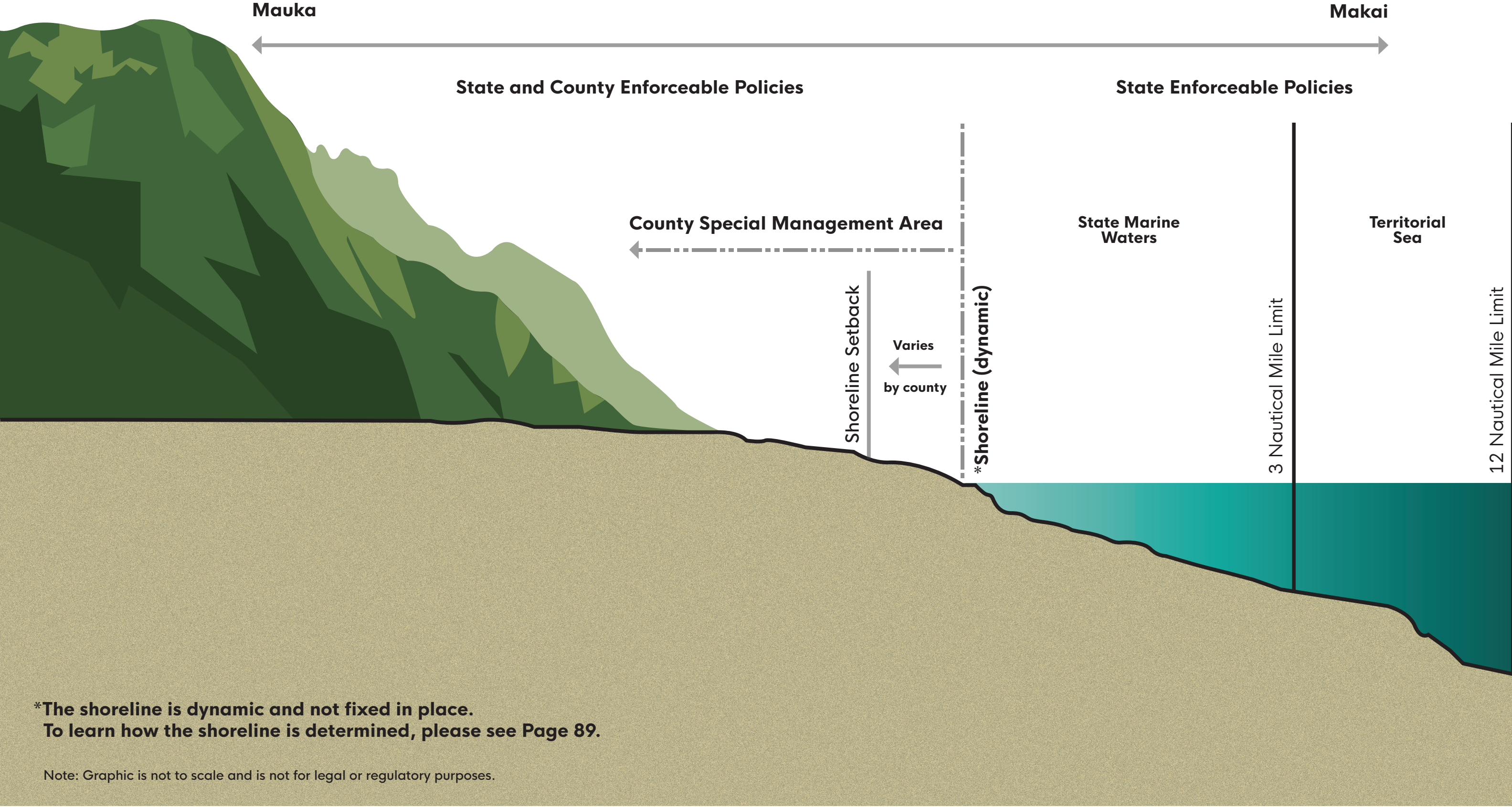
The CZM Program is a **comprehensive and coordinated program**, based on existing laws and authorities among state and local agencies that have responsibilities for the management of the State's coastal resources. The involved agencies represent a wide range of program areas and expertise, thereby providing a holistic approach to the management of land and water resources. While the **Office of Planning and Sustainable Development** is the lead agency for the Hawaii CZM Program, through this networked approach, **all listed partner agencies help to ensure its proper management**.

AUTHORITIES MATRIX

The Authorities Matrix¹ outlines the CZM Objectives and Policies and lists the corresponding enforceable policies with the State/County Lead Agencies that enforce their implementation. The Matrix illustrates how **Hawaii's authorities carry out the objectives and policies of the CZM Program**, thereby meeting CZM Act requirements and federal regulations. This document is provided as a reference that is updated periodically and serves as an overview of **all partners within the CZM network** that uphold the regulatory framework being adhered to for management of the Hawaii's coastal zone.
