## PUBLIC NOTICE PROGRAM CHANGE TO THE HAWAII COASTAL ZONE MANAGEMENT PROGRAM

October 12, 2022

The Hawaii State Legislature designed the State's Coastal Zone Management (CZM) implementation framework to build upon the existing functions of State and county agencies. In 1978, the National Oceanic and Atmospheric Administration (NOAA), U.S. Department of Commerce, approved the Hawaii CZM Program as meeting federal requirements under the Coastal Zone Management Act (CZMA) to receive grants and exercise CZMA review authority over federal actions that may affect the uses and resources of the Hawaii coastal zone.

Periodic changes to an approved CZM Program are necessary to address new challenges, strengthen the management regime, clarify provisions, or otherwise modify management of activities affecting coastal resources. To assure continued federal approval of the CZM Program and its enforceable policies, these statutory and regulatory changes must be submitted for federal review and concurrence before they are officially incorporated into the federally approved Hawaii CZM program. The federal regulations also require a public notice that lists the changes to be posted for the public and affected parties, and an opportunity for public comment.

The Hawaii CZM Program concludes that the following statutory and regulatory changes submitted to NOAA Office for Coastal Management (OCM) for approval will not result in substantive changes to the five program approval areas, including 1) Uses Subject to Management; 2) Special Management Areas; 3) Boundaries; 4) Authorities and Organization; and 5) Coordination, Public Involvement and National Interest. No changes or additions are submitted this time to the Hawaii Federal consistency list of geographic location descriptions.

The following are brief descriptions of the submitted statutory and regulatory changes that are being submitted for NOAA OCM's concurrence. The changes include changes to enforceable policies that, once approved by NOAA, will be applicable to the review of federal actions for consistency with the enforceable policies of the Hawaii CZM Program.
