**AGENDA ITEM 3: Public Comments**

Email from Matthew O'Donnell, contractor with US BGN. Mr. O'Donnell is asking if HBGN wants to proceed with a request to change the name of "Laulaunui Island" to "Laulaunui Islet" in spite of opposition from Navy Facilities Engineering Command Hawaii, which is managing and actively using the island. The name change was proposed by the HBGN sometime in 2012. Mr. Buto inserted a snippet from an internal spreadsheet indicating that the change to "Islet" was made in error. Nevertheless, the proposed name

change to “Laulaunui Islet” appears on the HBGN spreadsheet. Mr. Buto will contact Mr. O’Donnell to inform him that this name change proposal was made in error.

Email request from Danielle Foster, Hawai‘i Volcanoes National Park staff. Ms. Foster asked about the Bobby Camara’s relationship to the HBGN and name proposals within park boundaries. Mr. Buto responded to Ms. Foster that Mr. Camara had on many occasions submitted lists of feature names to the HBGN for its consideration, and that anyone can do the same. Features within park boundaries are referred to NPS staff for approval before being forwarded to the US BGN.

Akua Manamanaloa (Most High Divine Creator) asks me to speak here and tonight. Our great King Ka Mō'i Kamehameha is here with me. For I am Kahu of his personal Temple Ahu'ena Heiau at Kamakahonu restored by my Father. By the Ancestors of 'Ōiwi who uphold the Highest Light of Akua at Kamakahonu, I was guided to instruct that all men of the steady crew who restored Ahu'ena Heiau are to be acknowledged as Ali'i. My Father, the restorer of Ahu'ena Heiau is Ali'i Kahu David Keali'ihelemauna Roy, Jr.

Where did first place names in Hawai'i and the Pacific originate? Not with man. They originated with Akua Manamanaloa, Divine Creator. Further, Pacific people over time continued to keep their connections with Divine World and Akua as priority such that all names through all time stayed in alignment with Akua by our Pacific Ancestors of the Light of Akua.

They were these Pacific Ancestors of the Light whom King Kamehameha II, King Liholiho praised and acknowledged in his famous words that became the proverb "Na wai ho'i ka 'ole o ke akamai he alahēle i ma'a i ka hele 'ia e o'u mau mākua?" Who would not be wise upon a path so well-traveled by my Ancestors?" This was his response to the praise of his wisdom.

These are the Pacific Ancestors of the Light that I here and now praise and acknowledge as they who guide me upholding the Highest Light of Akua at Kamakahonu, abiding Capital of the Kingdom of Hawai'i unified by Kamehameha the Great in 1810.

In the Pacific, it was the 'Divine Life' of 'Ōiwi that brought harmony and peace forward by living life with and by Akua. Perhaps this is why more than one western professional anthropologist or archaeologist over time have described 'Ōiwi and Pacific People as "Happy People."

As I join you here, I am in the company of the "Legends" the po'e (people) of the famed bloodlines of  
*'O Puna paia 'ala i ka hala ~ Puna of the famed bowers of the fragrant hala blossoms.*

I bring you regards of pride and great aloha from ka po'e o Kona. Over the the many months as we've watched newscasts displaying your courage; your upholding of Pelehonuamea, Earth Mother, and your sheer strength and commitment to aloha among you, we've been inspired every day. Even as we were touched by Ka-wahine-o-ka-lua (Pele) directly by ka-uahi-o-Pele-i-ka-lewa (volcanic airborne haze) we took inspiration from YOU, who have been constantly dealing with so much more at any given time. And we join you in upholding Pelehonuamea one of the Divine Seven Facets of the Diamond of Akua Manamanaloa, Ka-'I-lā-lā-'ole (The-Supreme-One-Without-Branches).

It was Kahuna Lā'au Lapa'au and Hawaii's Living Treasure Mornah Simeona who said, the 1970's was a time of great spiritual advancement for 'Ōiwi. Hōkūle'a traveled to Kahiki; Ho'oponopono was implemented at the Geneva Convention and introduced to the world and Ahu'ena Heiau at Kamakahonu was restored by 'Ōiwi.

## 20 names for fissure 8

Deadline for submissions passes; community meeting to be conducted by fall

The deadline to submit possible names for fissure 8 has passed, with a total of 20 proposed monikers submitted.

The state Board of Geographic Names began soliciting proposed names for fissure 8, one of the most prominent landmarks formed from the 2018 Kilauea eruption, from the general public last year. Since then, a group of three appointed by the board — called the Permitted Interaction Group — has discussed with Puna residents what best to

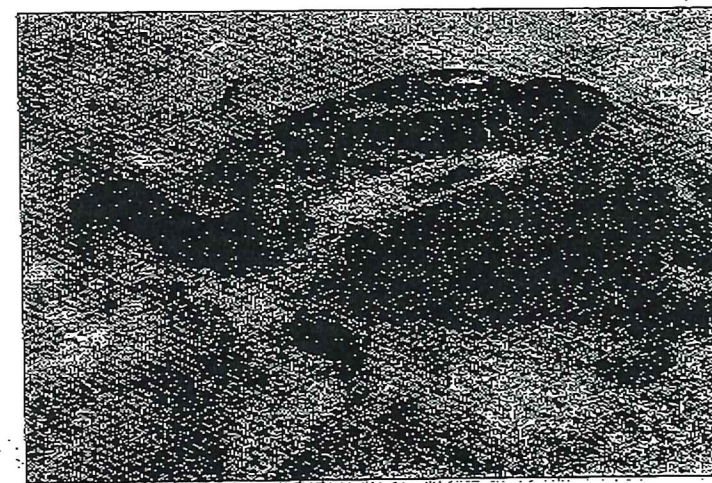
name the new landform.

"We wanted to make sure the community approves of the name and for them to come together to decide on a new name," said Brad Ka'aleleo Wong of the Office of Hawaiian Affairs, one of the members of the interaction group.

With the deadline for public-submitted names now closed, Wong said the next step is for the board to review the submissions before the group meets again with Puna residents to discuss the proposed names. Wong said that meeting likely will be toward the end of summer or beginning of fall.

A previous meeting with Puna residents took place in May, when there was heated discussion about which deity the fissure should be named after. Some argued the vent should be named after the male volcano deity 'Aila'au, a suggestion reflected in two submissions made last year.

Only four submissions have been made since the May meeting. The first name, "Hopena," was submitted by Leilani Estates resident Lori Ann Baker, who wrote in her proposal that the word can

be translated to mean "fate" — pointing out that abbreviating "fissure 8" results in "F8" or "fate" — although she added that, to her, the word means "hope."

The second and third submissions were made by Pahoa resident Robert Roosen, who suggested the fissure be named "Pu'u O'o O'o" or "Pu'u O'o O'o."

Roosen wrote that the names reflect that of Pu'u O'o, the cinder cone formed during the 1983 eruption, and claimed both eruptions were caused by geothermal drilling. Pu'u O'o means "hill of the digging

stick," but that site was originally nicknamed "Pu'u O" thanks to the landmark's location near a letter "O" on a map.

The fourth submission was made by Kalapana resident Lisa Pai, who suggested "Pu'u Wa Kahiko," claiming the name means "eternity from (past) to present."

The remaining submissions include:

- **Puu Leilani** (named for the subdivision, Leilani Estates, where the fissure is located).

- **Pu'u o'aila'au** (Hill of 'Aila'au).

- **Keahiluwahu O Pele** (no meaning provided. Submitter said it came

to them in a dream).

- **Pu'u Kupaianaha** (Pu'u = hill; Kupaianaha = surprising, strange, wonderful, marvelous).

- **Ahu 'aila'au** (Ahu = mound/shrine/altar or cairn; 'Aila'au = a volcano deity).

- **Pu'u 'O Luku** (hill of destruction).

- **Hanaia'na** (creation).

- **Enoho** (regeneration).

- **Hou Ho'omaka** (new beginnings).

- **Keahilapalapa** (spreading or blazing fire).

- **Kekoheho'ohe-nonohehokala'iopunapia'alaiakahala** (cherished crease occupying the calm of Puna of the

forest bower fragrant with pandanus).

- **Ke Ahi 'Bna'ena** (raging fire).

- **Luana-Lani** (named after Luana Street in Leilani Estates).

- **Papalaunahi** (earth of numerous volcanic eruptions; proposed name for all 24 fissures).

- **Pohaha** (a reduplicative of paha, which can mean breaking forth, bursting, cracking and volcanic ejection of any kind).

- **Pohaka'ena** (exploding rage).
