AGENDA ITEM 2: Review of Meeting Minutes for January 11, 2017 and February 8, 2017

Motion: Mr. Akana moved to approve the minutes of the January 11, 2017 meeting, and Ms. McEldowney seconded the motion.

AGENDA ITEM 3: Public Comments.

Mr. Akana stated that Sen. Galuteria would not be able to introduce a bill in the Legislature this session to change the official spelling of the name of the State. Sen. Shimabukuro introduced a bill SB 643 to require all public acts and transactions be in the Hawaiian language, and that upon request by a member of the public for the Hawaiian language version, all reasonable efforts would be made to make it available in Hawaiian. Section 1-13, HRS would be changed from "Hawaiian shall not be required..." to "Hawaiian shall be required..."

Mr. Akana suggested that a Constitutional amendment might be the way to go. Article XV contains the section identifying the official languages. An additional section could be added to define the official spelling.

Ms. Louis followed up on tasks from last year. Two words on maps were undecipherable, one was on Kahoolawae (Kunaka) the other on Lanai.

Mr. Akana received an email from the Kailapa Community Association on the Big Island. They want to change the name of their subdivision and association to Honokoa, which is the historical name of the area. They asked if HBGN needs to do anything? Since Kailapa is not in the GNIS, HBGN doesn't need to do anything. The association should take up the subdivision name change with the county.
