AGENDA ITEM 2: Review of Meeting Minutes for August 26, 2019

MOTION: Mr. Cummins moved to approve the minutes of August 26, 2019; Mr. Wong seconded the motion.

The members present voted unanimously to approve the meeting minutes of August 26, 2019.

AGENDA ITEM 5: Review previous name decision – Kalāhuapueo versus Kalāhuipueo

There was a request from the National Park Service to explain and confirm the name change requested for a place name on Moloka'i.

[360013] Kalāhuapueo. PNH: "Land section. Kamalō qd., Molokai'i. Perhaps this is a garble for Kalāhuipueo (the owl family). Lit., the day [of the] owl's eggs." Mr. Marzan raised the possibility that both names may be correct. It may refer to the story of Kapo'i, in which he took then returned seven owl eggs, and all the owls across the islands came to his aid later. The former Board decision to change the name/spelling only references PNH as the source. National Park Service would prefer to leave the name as it is unless there's a compelling reason to change it. The Registered Map No. 1728, dated 1895 (by MD Monsarrat) is labeled "Kalahuapueo." Mr. Cummins will check the field notes for this.

AGENDA ITEM 6: Selected place names on the island of Hawai'i

<u>Pu'uhonua o Pu'uhuluhulu.</u> A name suggested for the area where Mauna Kea protectors have gathered and encamped. Although the name is in common usage, the consensus of the Board is to wait for the community to request that the name be adopted. According to established USGS Feature Classes, "<u>Locale: Place at which there is or was human activity...</u>" seems to be the most appropriate. <u>The Board decided to wait until Ms. Silva is present to discuss this name further.</u>

At 3:07pm Mr. Bobby Camara joined the meeting by phone.

Mr. Camara was reviewing the minutes from the last meeting and wanted to express his opposition to naming the Pu'uhonua o Pu'uhuluhulu area, because the place already has a name and it's not clear to what the Pu'uhonua would apply.

[366215] Mauna Kea. Mr. Camara would like the Board to address the spelling of Mauna Kea. His understanding is that "Kea" could be a contraction of "Wakea." "Mauna a kea" is contained in a name chant for Kauikeaouli (Kamehameha III).

[359437] Hopukani Springs. Houpu o Kane has not been corrected yet in the GNIS.

[366216] Pu'uwekiu. Should be spelled Pu'uwekiu as the primary spelling rather than as a variant, as it is now. Another misspelled variant for this same feature is based on the misspelling in a memo, dated March 13, 1974, from Shelley Mark, then-Director of the Hawai'i Department of Planning and Economic Development transmitting naming decisions by the Advisory Committee on Geographic Names – "Kukahaula" should be "Kukahaula" See Registered Map No. 1641.

[362813] Omaokoili. "Omaokoili Hills" is labeled on RM 1641 and is listed in the GNIS, but does not have any diacriticals in the spelling. PNH: not listed. ['Ōma'o = green.]

[360015] Kalaieha. Nearby on RM 1641 is "Kalaieha." This could have multiple meanings, depending on where the diacriticals are placed. Mr. Camara will call Dr. Larry Kimura who may have some insight into the place.

[365130] Kipuka Nahuaopala (historical). Not in PNH; concatenate?

[360878] Ke A Pele o Iki. He thinks it should be Keʻāpeleoiki. It's an ʻaʻā lava flow mauka of Naʻalehu. Qd. Puukeokeo. In Kaʻu Forest Reserve; east of top part of Ocean View Estates. "Iki" or "Ike"?

[361318] Kipuka Pele o Iki. Similarly, "Iki" or "Ike"?

[361904] Lua Olai. Mr. Camara referred to Registered Map No. 2176. "Kaluaolai" is labeled on the map next to an area marked as "Volcanic Pit 1868." Mr. Camara suggests that the correct spelling of this feature is "Kaluaōla'i." HPN: Lua Olai: "A deep hole and fissure caused by the disturbance during the flow of '68." (Alexander) Written "Kaluaolai" on RM 2176. Located on mauka side of Mamalahoa Hwy at east edge of 1868 lava flow, at the southeast corner of TMK 9304:2. Elev. 2040 ft."

[362505] Na Manua Haalou. Mr. Camara noted that this is in the Boundary Commission testimony for Kahuku. In Ka'u Forest Reserve above Na'alehu... the "birds of Ha'alou." Ha'alou may refer to a birdcatcher.

HPN: Na Manua Haalou: "A swampy area, elev. between 5440 and 5880 ft. The Kahuku/Kaalaiki boundary jogs mauka around it. Cf. Namanuohaalou." Also HPN: Namanaohaalou: "An area at the mauka edge of the woods; the name was given to the northeast corner of Waiohinu at the Kahuku boundary in BC 91 (elev. about 5700 ft.), called Keanaoumi elsewhere. On USGS 1967, "Na Manua Haalou" is the name of a swampy area below Kahuku in Kaalaiki, near the Waiohinu corner. Coordinates are of the boundary point." [Nā manu o ha'alo'u = The birds of Ha'alo'u.]

From Boundary Commission testimony for the ahupua'a of Kahuku, District of Ka'u, dated March 11, 1873 (transcribed by Mr. Camara from a UH Hilo microfilm copy of the handwritten original):

"Kalakalohe k. Sworn

...Namanu o Haalou is the name of the lae ohia on Kaalaiki where Waiohinu is cut off by Kaalaiki...The boundaries I have told you were pointed out to me by my parents when we went after birds. (In old times all birds above the woods belonged to Kahuku and if we were caught going after them, Kahuku people would take them away from us.

Haupu k. Sworn

...Na manu o Haalou is the name of the ohia grove, which is on Kaalaiki. Kahuku land runs along this boundary on the outside of the woods.

Nahala k. Sworn

...the pahoehoe on the North East side is Makaka. when Haalou from Kahuku came after birds Makaka people prevented him from coming onto the pahoehoe."

[365915] Keanalele. PNH: not listed, according to to Mr. Camara the only Keanalele he knows is in Kiholo; per GNIS this was submitted by William Halliday, President of hte National Speleological Society; no location given. Mr. Camara noted that all of the "Keana" places on the list are caves. All were submitted by Mr. Halliday with no location indicated.

[1930522] Kīpuka 'Āinahou Nēnē Sanctuary. Spelling is correct, just need to concatenate Kīpuka'āinahou.

Summary of decisions:

Seventeen feature names were reviewed: one spelling was corrected, and sixteen require more research and discussion.
