AGENDA ITEM 2: Review of Meeting Minutes for July 2, 2024

AGENDA ITEM 5: Discussion about the possibility of using Hawaiian terminology instead of English descriptors in feature names and suggesting Hawaiian terminology in the GNIS Feature Class descriptions.

Mr. Buto included in the meeting packet Ms. Makaila's list of GNIS Feature Classes that contains suggested Hawaiian terms for some descriptions. Mr. Buto clarified that today's discussion not to replace any feature classes in the names of features but is focused on reviewing the descriptions that appear in the GNIS Feature Class definitions.

Mr. Camara added that there is a website (trussell.com) that has a searchable interface to many Hawaiian dictionaries; search for "lake" and entries from different sources will be listed. He noted that the current discussion is to add Hawaiian terms to the Feature Class descriptions in the GNIS and has nothing to do with the Feature Name itself. In the past the Board removed an English descriptor from a feature name, i.e., "Crater" from "Hi'iaka" and the Hawaiian feature name stands alone. The Hawaiian feature class could be added to the name, e.g., "Lua Hi'iaka," and the English Feature Class doesn't have to be part of the Feature Name.

He also asked about the process to add these Hawaiian terms to the GNIS Feature Class descriptions. Mr. Buto explained that this is an informal staff-level process; Ms. Runyon asked that the Board send her a comprehensive list of the suggested terms to be added to the Feature Class descriptions rather than sending multiple lists piecemeal.

Mr. Camara suggested that for the Feature Class "Bench" the Hawaiian term "kaulu" (*ledge, step, jog as on a cliff*) be added as an example in the description.

AGENDA ITEM 6: Discussion and decision on establishing a Permitted Interaction Group (PIG) to research the name of the Island of Hawai‘i.

Ms. Makaila: previous discussions were tabled waiting for more members present. She supports creating a PIG and volunteered to serve.

Ms. Oliveira also volunteered to serve on the PIG.

Mr. Cummins volunteered to serve on the PIG as a mapping resource but does not have to travel.

Mr. Camara questioned the necessity of a PIG. He believes that the initial concerns about changing the name of the island were because the Board’s intentions were not known, and he feels that the name “**Hawai‘i**” would not be disputed.

Mr. Cummins noted that one purpose of the PIG might be to educate people about the mission of the HBGN. Mr. Marzan’s previous experiences serving on PIGs were very different from this issue and from each other – the Maui community supported changing the name of ‘**Iao Stream** to **Wailuku River**, whereas for **Ahu‘ailā‘au**, the feature did not have a name and many different names were proposed by the community. In the GNIS for the **Island of Hawai‘i**, **Hawai‘i** and **Hawai‘i Island** are both already listed as variant names. Identifying among those names, which one the majority of the community supports could be part of the decision making.

Ms. Oliveira expressed concern that open-ended discussion of the name of the island could distract from the original purpose of the agenda item, which was to look at it in the context of the official names of the other islands, “**Kaua‘i**,” “**O‘ahu**,” “**Maui**,” etc.

Ms. Makaila agreed that the intention is to remove “Island of” from the current official name, and the supportive of that would be to include source information...

Ms. Makaila’s audio and video disconnected.

Mr. Cummins asked if Board members would support changing the name to “**Hawai‘i.**” The context of the name would be clear enough to differentiate between the State or the island, and the proposed change is already one of the variant names listed in the GNIS. A decision could be made expeditiously without expending funds for travel, and prior to reaching out to the media to better clarify what the HBGN is, what was done in this case, and why.

Mr. Camara suggested publishing information in OHA’s *Ka Wai Ola*. He is working with Pua Fernandez-Akamine on an article proposing changing the name of the ‘**Ailā‘au Flow** that happened in the 1400s to the **Kualaloa Flow**.

Ms. Runyon asked that if HBGN reaches out to media it stresses that federal agencies must still use the official name, “**Island of Hawai‘i.**” A proposal to change the official name could be made to the US BGN; there might be pushback. Ms. Runyon asked Mr. Buto to research the State’s records for documentation about when the name “**Island of Hawai‘i**” was approved as a change. She thinks it was circa 2000. The GNIS should reflect the date of that decision.

Mr. Cummins suggested that rather than establishing a PIG now the Board reach out to media and/or social media to explain the reasons for this agenda item and the options that are being considered. If there is significant pushback or concerns, the Board could then move forward with establishing the PIG with the members who have already volunteered.

Other names on the current list include “**Diamond Head**,” “**Aniani Ridge**,” “**Api Spring**,” and “**Awanui Gulch**.”
