HONOLULU – The Department of Commerce and Consumer Affairs today named Jayna Uyehara as the Manager of the Business Action Center.

Uyehara comes to DCCA from the State Department of Taxation where she served as a Rules Officer/Legislative Coordinator since 2001. She has more than ten years of legal, tax, and consulting experience including legislation, tax policy, and tax consulting and planning.

Prior to that, Uyehara also worked as a Senior Tax Associate for PricewaterhouseCoopers, LLP. She received a law degree from the University of Hawaii at Manoa.
