Dear Mr. Kang:

On July 21, 2009, Time Warner Entertainment Company, L.P. doing business as Oceanic Time Warner Cable ("**TWE**"), submitted its written Application for Renewal of its Oahu Franchise ("**Application**") to the Department of Commerce and Consumer Affairs ("**DCCA**"). By letter dated August 4, 2009, DCCA accepted TWE's application for filing. A public hearing on the Application was held on September 15, 2009 at McKinley High School to afford interested persons the opportunity to submit oral or written data, views, or arguments, on the Application.

DCCA extended the deadline for the submission of public testimony to September 30, 2009 in order to review and consider the public input. DCCA and TWE conducted discussions on components of a renewed franchise, and subsequently agreed on October 21, 2009 to extend the time for DCCA to make a decision on the Application to December 30, 2009.

In view of the continuing discussions on provisions of the franchise, DCCA and TWE hereby mutually agree (as acknowledged below), to extend the time for DCCA to make a decision on the Application from December 30, 2009 to January 15, 2010. Please sign and return the original letter back to DCCA.




