Pursuant to 47 U.S.C. § 546(a)(1) and Hawai'i Administrative Rules § 16-133-27(a), this is to respectfully provide notice to the Department of Commerce and Consumer Affairs ("DCCA") that Time Warner Entertainment Company, L.P. dba Oceanic Time Warner Cable ("Oceanic") intends to seek renewal of its Oahu franchise, which currently expires on December 31, 2009 by operation of Decision and Order No. 243.
