Re: Letter Order – Extension of Time for Submission of Technology
Upgrade Plan

On January 14, 2010, in Decision and Order No. 346 ("**D&O 346**"), Section IV.H.2, the Director of the Department of Commerce and Consumer Affairs ("**DCCA**") directed Time Warner Entertainment Company, L.P. ("**TWE**") to submit a technology upgrade plan for its Oahu Cable System to DCCA for every five-year period during the franchise term. The first of these technology upgrade plans is due on August 1, 2010.

On July 26, 2010, DCCA received your July 23, 2010 letter on behalf of TWE requesting an extension of time for submission of the first technology upgrade plan. As stated in your letter, TWE is preparing the technology plan and obtaining necessary information for its completion. Due to the broad scope of the plan, TWE found that significant coordination, planning and consultation with individuals and departments locally and nationally was required. Although TWE has been working diligently on developing the plan, TWE requested additional time to complete the planning and coordination required to produce a technology upgrade plan.

TWE therefore requested a three (3) month extension of time, or until November 1, 2010, to submit its first technology upgrade plan in order for TWE to have sufficient time in which to continue its efforts and finalize the plan.

After due consideration of TWE's representations, DCCA grants a three (3) month extension of time from August 1, 2010 to November 1, 2010, for TWE to submit the first technology upgrade plan.

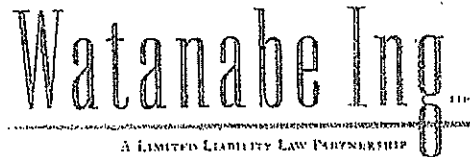

Dear Mr. Sonobe:

Pursuant to Section IV.H.2. of Decision and Order No. 346 (January 14, 2010) ("D&O 346"), Time Warner Entertainment Company, L.P. ("Oceanic") is required to submit a technology upgrade plan for its Oahu Cable System to the DCCA for every five-year period during the franchise term. The first technology upgrade plan is due on August 1, 2010.

As discussed with the Cable Division earlier this week, Oceanic has been in the process of preparing the technology plan and obtaining the necessary information to complete the plan. Given the requested scope of the plan, which includes an anticipated timetable for the incorporation of new developments in the Oahu Cable System, the effect and costs of new technological developments, and impacts to various organizations and services over a five year period, however, the development and finalization of the plan requires significant coordination, planning and consultation with a number of individuals and departments both locally and on a national level. While Oceanic has been diligently engaged in that process, Oceanic believes that additional time is necessary to complete the planning and coordination required to produce the plan as provided in D&O 346.


