On March 5, 2013, Na Leo 'O Hawaii's ("**Na Leo**") submitted an Amended Application to Provide PEG Access Services to the Department of Commerce and Consumer Affairs ("**DCCA**").

This is to inform you that pursuant to Hawaii Revised Statutes section 440G-8.3 and DCCA's September 2, 2011 "Guidelines To Designate PEG Access Organizations Pursuant To Act 19 (SLH 2011)", the DCCA accepts Na Leo's March 5, 2013 Amended Application to Provide PEG Access Services Related to State of Hawaii D&O No. 173 and 185 ("**Amended Application**") for filing. While the Amended Application supersedes Na Leo's October 17, 2012 Application, Na Leo's December 11, 2012 Responses to DCCA's First Request for Information remain relevant to the Amended Application. Unless Na Leo informs the DCCA otherwise by March 14, 2013, the DCCA will apply Na Leo's December 11, 2012 Responses to the Amended Application.

DCCA intends to schedule public hearings on the Amended Application in the near future. At the public hearings, a representative from Na Leo shall provide a brief summary of the Amended Application.


