Dear Ms. Wong:

As we discussed in our telephone conversation today, my firm represents Na Leo `O Hawai`i Community Television ("Na Leo"). Na Leo has submitted an application to provide PEG Access Services related to the State of Hawaii, D&O Nos. 173 and 185.

In that matter, Intervenor Oceanic Time Warner Cable LLC ("Oceanic") submitted a request for information and production of documents (see enclosure). Pursuant to your agency's letter of January 10, 2013, Na Leo's response to Oceanic's request is due on February 4, 2013.

Unfortunately, Na Leo's accounting firm is currently preparing the final financial documents to close Na Leo's 2012 accounts. Information relevant to Oceanic's request will not be available until the accounting firm makes the final accounting and closes Na Leo's books. Na Leo's accountant estimates that all accounts will be closed and full accounting accomplished in February.

Under the circumstances, Na Leo requests an extension of time from February 4 to February 28 for the delivery of information and production of documents responsive to Oceanic's request.
