

**NOTICE OF PUBLIC HEARING ON**  
**NA LEO 'O HAWAII, INC.'S AMENDED APPLICATION FOR DESIGNATION**  
**AS A PEG ACCESS ORGANIZATION ON HAWAII ISLAND**

Pursuant to HRS section 440G-8.3, notice is hereby given that the Director of the Department of Commerce and Consumer Affairs ("DCCA") will hold public hearings on Na Leo 'O Hawaii's ("Na Leo") March 6, 2013 Amended Application to provide public, educational, and governmental ("PEG") access services on Hawaii Island. In its Application, Na Leo is requesting to be designated as a PEG access organization to oversee the development, operation, supervision, and management of PEG access facilities and equipment and for the production, and broadcasting of programs, of PEG access facilities and equipment on Hawaii, in exchange for compensation collected from subscribers.

DCCA will hold two public hearings on Na Leo's written Application on the following dates and locations:

All written comments should be submitted to DCCA by May 8, 2013, 4:30 p.m. (HST).

Individuals who require special needs accommodations for the public hearings may request assistance by writing or contacting CATV at the address above or at (808) 586-2620, at least seven (7) working days prior to the scheduled public hearings.

In addition to submitting comments on the Application, any interested person may request to intervene in the public hearings, if that person has a substantial interest in the outcome of the designation of Na Leo as a PEG access organization; provided that no intervention shall be permitted if the intervention unduly delays the public hearings or has been filed to harass, hinder, or prejudice the rights of Na Leo as determined solely by DCCA. The permitted intervening party shall only be allowed to submit written questions to Na Leo about the Application prior to the public hearings, and reasonably request supporting and clarifying documentation on the Application from Na Leo. The written questions and requests for supporting and clarifying documentation shall be limited in quantity and scope to what is reasonably necessary to allow the interested person to formulate the person's testimony at the public hearings. The deadline to request intervention is April 9, 2013, 4:30 p.m. (HST).
