In general, the proposed amendments specify that the Director of DCCA shall comply with the applicable provisions of the Procurement Code in HRS chapter 103D when designating and selecting PEG access organizations, and specify the factors that the Director considers when designating and selecting PEG access organizations.

All interested persons shall be afforded the opportunity to submit data, views, or arguments, orally or in writing, on the proposed rule amendments at the time of the public hearing. Persons wishing to submit written testimony are requested to submit four (4) copies of their written testimony to the Cable Television Division, Department of Commerce and Consumer
