7. Reason: This / These amendment(s) are necessary because:

DCCA is presently working along with the State Procurement Office to prepare the RFP. Determination was made to issue an RFI (draft RFP) in November 2006 with scheduled December public comment meetings on Oahu and the Neighbor Islands to solicit public comments on the draft and other related issues, which resulted in submittals of numerous written comments. DCCA is also currently working to verify the assets and equipment lists provided by the present PEG providers.

Due to the comments/recommendations received to the initial draft RFI, changes/amendments are being made to the RFP. Therefore, determination has been made to issue another RFI to again solicit public comments. DCCA anticipates that the award and subsequent contract requirements will go beyond the current contract period, which expires June 30, 2007. Therefore, DCCA is requesting an extension to December 31, 2007.

Note: The 2007 PEG franchise fees for all counties total approximately \$6,553,504. 50% of this total was paid at the direction of DCCA to the PEG providers in January 2007. If this amendment is approved, the Department anticipates directing the release of the remaining balance. In 2006, 50% of the 2006 franchise fee amount was paid in January 2006, and the remaining 50% was paid in July 2006.
