## ORDER

JAMES JEA PARK, dba JAMES LIMO TOUR (Applicant), filed an application on December 13, 2001, seeking commission approval to extend his authority under certificate of public convenience and necessity number 1248-C (Certificate No. 1248-C) by (1) adding the 1-to-7 passenger classification, and (2) removing the "limited to limousines" restriction in the 8-to-25 passenger classification. By Decision and Order No. 19309, filed on April 19, 2002 in this docket, the commission granted Applicant's request to extend his authority under Certificate No. 1248-C subject to certain requirements.

By letter filed on April 19, 2002, Applicant sought commission approval to voluntarily surrender his authority under Certificate No. 1248-C. By Order No. 19362, filed on May 22, 2002, in Docket No. 02-0090, the commission terminated Applicant's authority to transport passengers under Certificate No. 1248-C. In light of the termination of Applicant's operating authority, the commission finds good cause to void Decision and Order No. 19309, and to close this docket. THE COMMISSION ORDERS:

1. Decision and Order No. 19309 is voided.

2. This docket is closed.
