<u>ORDER</u>

By transmittal filed on June 28, 2002, E NOA CORPORATION (E Noa) seeks commission approval on short notice of certain changes to its tariff. E Noa makes its request in accordance with Hawaii Revised Statutes § 271-21 and Hawaii Administrative Rules § 6-63-18. The proposed effective date of the transmittal is July 5, 2002.

For the island of Oahu, E Noa possesses regular route authority in the over-25 passenger classification. E Noa requests the following additions and/or changes to its services:

- 1. West bound: Eliminate the stop at the Sports Authority (after the Ala Moana Shopping Center);
- 2. East bound: Add a stop at the Sports Authority (after Aloha Tower Marketplace);
- 3. East bound: Add a stop at the King Kalakaua Plaza (after the Hilton Hawaiian Village); and
- 4. Move the stop at the Hilton Hawaiian Village from Kalia Road to the ABC Store.

E Noa states that it desires to "provide continuous and uninterrupted service to these stops." Specifically, it explains that it is under a contractual obligation to begin service to the King Kalakaua Plaza on July 5, 2002. In addition: (1) the schedule changes for the Sports Authority have been agreed to by the Victoria Ward Center; and (2) the relocation of stops at the Hilton Hawaiian Village is necessary to eliminate the traffic citations E Noa has received for picking up and dropping off passengers near the stop for the public bus system.

Upon review, the commission finds good cause to grant the request for approval on short notice.

II.

THE COMMISSION ORDERS that E Noa's transmittal, filed on June 28, 2002, is approved on short notice, to be effective on July 5, 2002.
