# <u>ORDER</u>

I.

By an application filed on April 8, 2002, VERIZON HAWAII INC. (Applicant), requests commission approval to include \$520,600 in Applicant's rate base for a DMS-100 trunk addition in the Hilo Central Office. Applicant makes its request in accordance with Section 2.3.d.2 of General Order No. 8, Standards for Telephone Service in the State of Hawaii (Section 2.3.d.2) and Hawaii Administrative Rules, § 6-80-90. Copies of the application were served on the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy (Consumer Advocate).

By letter, dated and filed on July 5, 2002, Applicant requests an extension of time, until August 8, 2002, of Section 2.3.d.2 requirement that the commission render a decision within 90 days after the filing of a telecommunications utility's application.
