ORDER

I.

By transmittal number 004-CFT, filed on July 26, 2002, FRANK LAWRENCE, dba C & F TRUCKING (C & F Trucking), seeks commission approval on short notice of certain changes to its tariff. C & F Trucking makes its request in accordance with Hawaii Revised Statutes § 271-21 and Hawaii Administrative Rules § 6-63-18. The proposed effective date of the transmittal is August 7, 2002.

C & F Trucking is duly authorized to transport property in the general commodities and dump truck classifications on the island of Hawaii. It seeks approval on short notice as follows:

1. To establish a new rate to transport diesel fuel from Tesoro Hawaii's facility in Hilo to Hamakua Energy Partners, an independent power producer located in Honokaa.

The contracted rate is \$.0163 per gallon.

2. To increase the present rate to transport naphtha fuel from Tesoro Hawaii's facility in Hilo to Hamakua Energy Partners' facility in Honokaa.

The present rate is \$.01108 per gallon, and the proposed new rate is \$.0157 per gallon, reflecting an increase of \$.00462 per gallon.

C & F Trucking states that the new rates for diesel and naphtha fuels were negotiated with and agreed to by Tesoro Hawaii, with an effective date of August 7, 2002.

Upon review, the commission finds good cause to grant the request for approval on short notice.

II.

THE COMMISSION ORDERS that C & F Trucking's transmittal number 004-CFT, filed on July 26, 2002, is approved on short notice, to be effective from August 7, 2002.
